Mr. Newhall called to inform us that a Maj. Gen. John Murray, USA(ret), sent a letter on OSTP stationery to Cabinet-level officials on his opinions of a current study on Agent Orange. The letter was sent to the head of the VA, Admiral Crowe, and Secretary Weinberger, among others. Murray was a member of a subpanel on Agent Orange that Dr. Young chaired. A copy of the letter sent to Weinberger is attached.

Murray evidently represented himself to some people that Newhall has talked to as a "volunteer consultant" to OSTP. Murray is not now, nor has he ever been a consultant for OSTP. The HHS is coordinating any press queries. Any calls on this matter can be referred to Stephanie Lee-Miller, HHS, at 245-1850.
