PHILIP H. VISION DEERFIELD VETERANS' AFFAIRS SUBCOMMITTEE ACTION LABELED
INSULT TO ILLINOIS GENERAL ASSEMBLY AND

CITIZENS OF ILLINOIS

Senator Karl Berning, R-Deerfield, Chairman of the Illinois Agent Orange Study Commission, labeled the actions of the Oversight Committee of the Veterans' Affairs Committee of the U.S. House as "an insult to the Illinois General Assembly and the citizens of Illinois."

Berning was referring to the manner in which the testimony of the Illinois delegation was heard by the subcommittee September 15th in Washington, D.C.

The Illinois delegation consisting of Berning,
State Representative John T. O'Connell, D-Western
Springs, Co-Chairman of the Commission and a Vietnam
veteran; and Commissioner Joan Maiman, a civilian
Vietnam veteran was ask to testify after a recess
had been called for voting. The acting chairman
of the subcommittee, Congressman Bob Stump, D-Arizona
gaveled the meeting to order with no other member or
staff present.

Although the Illinois delegation offered to remain until more members were present Stump did not believe

it was necessary to wait despite the fact that the Illinois delegation was the only out of town group present.

"We made the trip especially to present the concerns of the citizens of Illinois regarding Agent Orange at the invitation of the Chairman of the Committee, G.V. "Sonny" Montgomery of Mississippi," Berning added. The Illinois delegation summed up its visit with the following comment:

"We hope the conduct of Congressman Stump on behalf of the committee does not represent the policy of the federal government towards the states in the Agent Orange matter. We had a story to tell and unfortunately there was no one there to listen when we were asked to tell it."
