DEFENSE LOGISTICS AGENCY

Tennessee Wholesale Drug Co.*, Nashville, Tennessee, is being awarded a \$5,521,917 firm fixed price indefinite quantity contract for pharmaceuticals. Seventy four proposals were solicited and four were received. Work is expected to be completed by December 26, 1997. Funds will not expire at the end of the fiscal year. The Defense Personnel Support Center, Philadelphia, Pennsylvania, is the contracting activity (SP0200- 96-D-7019).

ARMY

Lockheed Martin Defense Systems, Pittsfield, Massachusetts, is being awarded a \$16,680,308 firm fixed price contract for 540 - 3 modification kits (transmission) for the Bradley Fighting Vehicle System. Work will be performed in Pittsfield, Massachusetts, and is expected to be completed by December 31, 1997. Contract funds will not expire at the end of the current fiscal year. This is a sole source contract initiated on June 20, 1996. The contracting activity is the U.S. Army Tank- Automotive & Armaments Command, Warren, Michigan (DAAE07-96-C- T557).

Stone & Webster Engineering Corporation, Englewood, Colorado, is being awarded an \$8,426,366 cost reimbursable contract to perform interim remedial action at landfills number 6 and 7. Work will be performed at Fort Sheridan, Illinois, and is expected to be completed by October 31, 2002. Contract funds will not expire at the end of the current fiscal year. This is a sole source contract initiated on August 26, 1996. The contracting activity is the U.S. Army Corps of Engineers, Louisville, Kentucky (DACA45-96-D-0007).

USA Asbestos Removal Company, Incorporated*, Clifton, New Jersey, is being awarded \$98,000 of a \$14,700,000 (includes 2 option years) indefinite delivery type/firm fixed price contract for the demolition of buildings. Work will be performed in and around Fort Hood, Killeen, Texas, and is expected to be completed by September 26, 1999. Contract funds will not

expire at the end of the current fiscal year. There were 164 bids solicited on August 9, 1996, and seven bids received. The contracting activity is the U.S. Army Corps of Engineers, Ft. Worth, Texas (DACA63-96-D-0050).

Templeton Construction Company*, San Angelo, Texas, is being awarded a \$6,006,373 increment as part of a \$6,153,273 (base plus 17 options) firm fixed price contract for renovation of ADAL dormitory buildings 6125 and 6136. The project involves the complete interior renovation of 2 three-story, 25,000 square foot dormitories to comply with the new Air Force 1+1 standard. These structures will house approximately 144 personnel in 72 suites. Each suite will include 2 bedrooms, kitchen, and bathroom. The existing buildings have

concrete foundations and structural masonry walls, with exterior brick finish. Site amenities include basketball and volleyball courts. Hazardous materials abatement of asbestos, lead-based paint, mercury, PCB and CFC is required. New balconies will be required for both buildings. Work will be performed at Dyess Air Force Base, Texas, and is expected to be completed by June 30, 1997. Contract funds will not expire at the end of the current fiscal year. There were 15 bids solicited on July 2, 1996, and four bids received. The contracting activity is the U.S. Army Corps of Engineers, Ft. Worth, Texas (DACA63-96-C-0064).

Trimble Navigation Limited, Austin, Texas, is being awarded \$12,881,764 of an estimated cumulative total \$13,361,764 firm fixed price and time and materials contract for 785 Global Positioning Systems (GPS). The Cargo Utility GPS Receiver (CUGR) is a self contained, lightweight standalone GPS receiver for the Army UH-1 helicopter fleet. This acquisition meets the Congressional mandate to equip all aircraft (UH-1) with GPS capability by the year 2000. Work will be performed in Austin, Texas, and is expected to be completed by April 30, 1998. Contract funds will not expire at the end of the current fiscal year. There was an announcement on the electronic bulletin board March 6, 1996, and one bid was received. The contracting activity is the U.S. Army Communications & Electronics Command, Fort Monmouth, New Jersey (DAAB07-96-C-A780).

Science Applications International Corporation, TSC, Pacific Technology Services, San Diego, California, is being awarded a \$5,051,991 increment as part of a \$12,072,817 cost plus fixed fee contract for technology support services. Work will be performed in Frederick, Maryland (98%), McLean, Virginia (1%), and San Diego, California (1%), and is expected to be completed by September 26, 2001. Contract funds will not expire at the end of the current fiscal year. There were 85 bids solicited on June 24, 1996, and three bids were received. The contracting activity is the U.S. Army Medical Research Acquisition Activity, Fort Detrick, Maryland (DAMD17-96-C-6131).

Fenn Manufacturing Company, Newington, Connecticut, is being awarded a \$10,556,480 firm fixed price contract for 1,760 housing assemblies, part of the main rotor head on the Apache helicopter. Work will be performed in Newington, Connecticut, and is expected to be completed by May 31, 1998. Contract funds will not expire at the end of the current fiscal year. This is a

sole source contract initiated on May 13, 1996. The contracting activity is the U.S. Army Aviation & Troop Command, St. Louis, Missouri (DAAJ09-96-C-0392).

ECI Construction, Incorported*, Shawnee Mission, Kansas, is being awarded a \$5,221,432 firm fixed price contract for construction of a three-story, 145,300 square foot - 48 person barracks and adjacent 13,800 square foot single-story and basement, Soldier Community Building. Foundations will be pier and grade beam with structurally supported slabs. Roofs will be composition shingle with an option for standing seam metal. Heating and air conditioning will utilize a central chiller and boiler with a 4-pipe system. Variable air volume will be used in the community building and individual fan coil units will be used in the barracks. The barracks include living/sleeping rooms, private bath, walk-in closets, built-in desks and shelving, and service areas. An intrusion detection system is required. Supporting facilities include electric service, fire protection and alarm systems, paving, walks, curbs and gutters, parking and access roads, storm drainage, and landscaping. LOGIS-TECH, Incorporated*, Alexandria, Virginia, is being awarded a first task-order amount of \$8,016, 143, which is part of a \$200,000,000 (if all options exercised) firm fixed price contract to furnish all plant labor, equipment, materials and incidental construction necessary to provide turn-key Controlled Humidity Preservation and Operational Preservation Programs to include a total package fielding hand-off at various locations throughout the United States and its territories. Work will be performed in Tennessee, Maryland, Kentucky, Wisconsin, Oregon, Iowa, Michigan, Mississippi, New York, and Guam, and is expected to be completed by September 30, 1998. Contract funds will not expire at the end of the current fiscal year. This is a sole source contract initiated on July 30, 1996. The contracting activity is the National Guard Bureau, Falls

Church, Virginia (DAHA90-96-D-0012).

J & J Maintenance, Incorporated, Austin, Texas, is being awarded an estimated \$2,522,441 increment as part of an estimated \$7,542,699 cost plus award fee contract to furnish all management, administration, personnel, data, equipment and materials to perform base operations support services; and construction jobs (not to exceed \$25,000 range on each job). Work will be performed at Fort Sherman, Republic of Panama, and is expected to be completed by December 31, 1999. Contract funds will not expire at the end of the current fiscal year. There were 53 bids solicited on May 2, 1996, and three bids were received. The contracting activity is the U.S. Army South, Republic of Panama (DAHC92-96-C-0098).

Lockheed Martin Logistics Management, Incorporated, Arlington, Texas, is being awarded \$3,216,288 as part of an \$11,315,440 cost plus award fee contract for support services to the Directorate of Logistics. Work will be performed in Fort Clayton, Republic of Panama,

and is expected to be completed by December 31, 1999. Contract funds will not expire at the end of the current fiscal year. There were 48 bids solicited on May 17, 1996, and four bids were received. The contracting activity is the U.S. Army South, Republic of Panama (DAHC92-96-C-0099).

O'Gara-Hess & Eisenhardt Armoring Company*, Fairfield, Ohio, is being awarded a \$5,985,000 modification to a firm fixed price letter contract for 133 Up Armor High Mobility Multi- purposeWheeled Vehicles (HMMWV), XM1114. Work will be performed in Fairfield, Ohio, and is expected to be completed by February 28, 1997. Contract funds will not expire at the end of the current fiscal year. This is a sole source contract initiated on September 19, 1996. The contracting activity is the U.S. Army Tank-Automotive & Armaments Command, Warren, Michigan (DAAE07-94- C-0406).

Steward & Stevenson Services, Incorporated, Sealy, Texas, is being awarded a \$21,279,663 modification to a firm fixed price contract to exercise option of 208 Family of Medium Tactical Vehicles (FMTV). Work will be performed in Sealy, Texas, and is expected to be completed by September 30, 1997. Contract funds will not expire at the end of the current fiscal year. There were three bids solicited on September 20, 1990, and three bids received. The contracting activity is the U.S. Army Tank- Automotive & Armaments Command, Warren, Michigan (DAAE07-92-C- R001).

Operational Technologies, Incorporated*, San Antonio, Texas, is being awarded \$76,634 (estimated first delivery order) of a not-to-exceed \$10,000,000 increment, as part of a not-to-exceed \$50,000,000 (if 4 options exercised) firm fixed price contract to provide environmental services to support the National Guard throughout the United States and its territories. Lockheed Martin Ordnance Systems, Incorporated, Burlington, Vermont, is being awarded a \$7,778,313 modification to a firm fixed price supply contract to implement mandatory technical improvements to ensure reliability and safety of M933 and M934 120mm mortar cartridges. A price reduction incorporated due to waiver of First Article Test. Work will be performed at the Milan Army Ammunition Plant, Milan, Tennessee, and is expected to be completed by December 29, 1997. Contract funds will not expire at the end of the current fiscal year. This is a sole source contract initiated on August 19, 1993. The contracting activity is the U.S. Army Armament, Munitions and Chemical Command, Rock Island, Illinois (DAAA09-93-C-0569).

Lockheed Martin Vought Systems Corporation, Grand Prairie, Texas, is being awarded a \$31,741,252 modification to a firm fixed price contract to add additional funding to previous exercise of FY96 low rate initial production (LRIP) as an unpriced contractual action, quantity of 70 Army Tactical Missile System Block 1A guided missiles and launching assemblies and warranty; and 72 Block 1 Missile Variants in support of foreign military sales requirement. Work will be performed in Dallas, Texas (98.2%), and Horizon City, Texas (1.8%),

and is expected to be completed by July 31, 1999. Contract funds will not expire at the end of the current fiscal year. This is a sole source contract initiated on October 28, 1994. The contracting activity is the U.S. Army Missile Command, Redstone Arsenal, Alabama (DAAH01-92-C-0038).

W. M. Jordan Company, Incorporated, Newport News, Virginia, is being awarded a \$10,849,000 firm fixed price contract for construction of enlisted barracks without dining facility. The project consists of one three-story barracks building clustered on two sides of a three-story Soldier Community Building. Work will be performed at Fort Eustis, Virginia, and is expected to be completed by April 30, 1998. Contract funds will not expire at the end of the current fiscal year. There were 91 bids solicited on July 17, 1996, and three bids received. The contracting activity is the U.S. Army Corps of Engineers, Norfolk, Virginia (DACA65-96-C-0094).

Compaction America, Incorporated, Kewanee, Illinois, is being awarded an estimated \$45,990,000 requirements contract giving the government the opportunity over the next five years to purchase a maximum of 160 self-propelled vibratory rollers Type I, and 487 self-propelled vibratory rollers Type II. Work will be performed in Kewanee, Illinois, and is expected to be completed by December 30, 2001. Contract funds will not expire at the end of the current fiscal year. There were 12 bids solicited on September 7, 1995, and four bids received. The contracting activity is the U.S. Army Tank-Automotive & Armaments Command, Warren, Michigan (DAAE07-96-D-X004).

Fletcher Pacific Construction Company, Ltd., Honolulu, Hawaii, is being awarded a \$13,898,000 firm fixed price contract for construction of one enlisted personnel barracks for 200 personnel. The project will include living/sleeping rooms with bath, walk-in closets, elevator, and a multi-purpose court; construction of two two-story medium company operations facilities, and construction of a temporary gravel parking lot and maintenance. Work will be performed at

Schofield Barracks, Hawaii, and is expected to be completed by September 30, 1998. Contract funds will not expire at the end of the current fiscal year. There were 245 bids solicited on August 12, 1996, and 12 bids received. The contracting activity is the U.S. Army Corps of Engineers, Fort Shafter, Hawaii (DACA83-96-C-0061).

Landmark Construction Corporation, Milwaukee, Wisconsin, is being awarded a \$5,967,000 firm fixed price contract to convert two existing permanent party dormitories into upgraded transient dormitories; 34 visitor modules for building 1172, and 31, and visitors modules for building 1166. Work will be performed at Hickam Air Force Base, Hawaii, and is expected to be completed by May 13, 1998. Contract funds will not expire at the end of the current fiscal year. There were 211 bids solicited on August 9, 1996, and ten bids received. The contracting activity is the U.S. Army Corps of Engineers, Fort Shafter, Hawaii (DACA83-96-C- 0042).

Stimpel-Wolbelhaus Associates, Redding, California, is being awarded a \$7,241,865 fixed price contract for excavation of a detention basin, earth fill a dam, and earth fill a dike with outlet works in Las Vegas, Nevada, with an expected completion date of October 30, 1997. Contract funds will not expire at the end of the current fiscal year. There were 100 bids solicited on August 5, 1996, and ten bids were received. The contracting activity is the U.S. Army Corps of Engineers, Los Angeles, California (DACW09-96-C-0046).

Western Data Systems, Calabasas, California, is being awarded a \$5,935,559 firm-fixed-price, indefinite-quantity time and materials type contract for manufacturing Resource Planning Commercial Off-the-Shelf Software, training, implementation support, program management, and software maintenance to support the Department of Defense depot community. Work will be performed in Calabasas, California (5%), Jacksonville, Florida (19%), Albany, Georgia (19%), Barstow, California (19%), Havelock, North Carolina (19%), and San Diego, California (19%), and is expected to be completed by September 1997. This contract was competitively procured with 48 proposals solicited and three offers received. The Contracts Directorate, Marine Corps Logistics Base, Albany, Georgia, is the contracting activity (M67004-96-D-0024).

Digital Wizards Incorporated, San Diego, California, is being awarded a \$12,694,833 indefinite-delivery, cost-plus-fixed- fee contract for engineering support services for the Systems Integration Facility/Combined Test Bed (SIF/CTB) Gateway System. The SIF/CTB is a land-based test site for testing and evaluating performance of the initial Joint Tactical Information Distribution System (JTIDS). This contract includes options which, if exercised, would bring the cumulative value of this contract \$25,821,308. Work will be performed in San Diego, California, and is expected to be completed by September 2000. Contract funds will not expire at the end of the current fiscal year. This contract was competitively procured with 119 proposals solicited and two offers received. The Naval Command Control and Ocean Surveillance Center Research Development Testing & Evaluation (RDT&E) Division, San Diego, California, is the contracting activity (N66001-96-D-0005).

Industrias Metalurgicas Pescarmona S.A.I.C.y F., c/o Impsa International, Incorporated, Pittsburgh, Pennsylvania, is being awarded an \$8,643,717 firm-fixed-price contract for 40-ton Container Cranes. The work to be performed provides for the design, fabrication, erection, shipment, and delivery of one 40- ton container crane for Naval Ordnance Center, Port Hadlock Washington, and two 40-ton container cranes for Naval Weapons Station, Concord, California. The erection of the cranes will be performed in the vicinity of Port Hadlock, Washington (75%), and Concord, California (25%), and is expected by be completed by May 1999. Kalama Services, Orange, California, is being awarded a \$27,355,884 modification to previously awarded contract N62742-94- D-0519 to provide for all labor, supervision, administration, and management necessary to carry on the base operating support services under the cognizance of the Field Command Defense Special Weapons Agency at Johnston Atoll near Hawaii. Work will be performed in Chesapeake, Virginia, and is expected to be completed by September 2001. Contract funds will not expire at the end of the current fiscal year. This contract was not competitively procured. The Naval Surface Warfare Center, Carderock Division, is the contracting activity (N00167-96-D-0044).

C-Cubed Corporation, Incorporated, Springfield, Virginia, is being awarded a \$6,602,874 cost-plus-fixed-fee term contract for technical and engineering support services in support of shipboard electronic communications systems, including design, development, integration, test and evaluation, installation, maintenance and logistics support.
