# Secretary's Message

---

Greetings, I hope your summer so far has been enjoyable and that you have spent quality time with your family and friends. September is a month of change in that the weather begins to cool off, children go back to school, and we at CalVet are deep in planning for the CalVet Women's Leadership Conference and Veterans Day.

But during this month we especially remember Prisoners of War and those still Missing in Action throughout Asia. Our hearts go out to all the families of POW/MIAs. Please remember them in your prayers this "POW/MIA Recognition Day," Friday, September 21.

I now want to discuss CalVet's Farm and Home Loan program and why it is still the best deal for veterans trying to purchase a home. This great benefit for veterans has been around since 1921. It is now one of the most fiscally sound programs in our Golden State.

Thanks to restructuring of its debt, making sound financial decisions, and taking proactive steps to better position the program in today's chaotic real estate market, the CalVet Farm and Home Loan program has secured AA ratings from Standard and Poor's, Fitch's, and Moody's rating agencies for our Revenue and General Obligation Bonds.

Also, the CalVet Farm and Home Loan program has one of the lowest foreclosure rates in California. We work diligently with veterans to help keep them in their home, because we understand that many of them have taken an economic hit due to our nation's down economy.

If working carefully with our veteran mortgage holders to find ways to help them stay in their homes was not enough, we offer the best program for veterans getting into the housing market as well. For starters, although our rates may not be as low as those in the open market, we more than make up for it in benefits the veteran will enjoy during the life of the loan.

Among the added benefits that make our CalVet Home Loans more attractive is that once approved, most veterans

have to provide little to no money for the down payment. In addition, our life and disability, fire and hazard, and disaster indemnity insurance provides a low cost/low deductible policy and the highest benefits available. This level of insurance cannot be purchased anywhere on the open market at any price, so we are very happy to offer this benefit to California veterans.

Currently, our rates range between 4.25% and 5.95%, while these may seem a little higher than in the open market, when compared with FHA and Conventional interest rates and expenditures, CalVet's Farm and Home Loans really do offer an advantage. For example, with a 4.25 percent interest rate, an FHA \$160,000 loan will require around an \$8,800 down payment. For a Conventional loan with a 5.00 percent interest rate for the same amount, the down payment would roughly run around \$11,600. ## *CALVET MOBILE APP NATIONAL AWARDS FINALIST*

The California Department of Veterans Affairs (CalVet) is among 30 finalists across all categories being considered by the National Association of State Chief Information Officers (NASCIO) for the 2012 Outstanding Achievement in the Field of Information Technology award. The CalVet app is one of only three awards finalists in the Digital Government-to-Citizen category.

The CalVet mobile app, available for both Apple and Android devices, gives users 24/7 access to information about employment, education, housing, health and other benefits and services available to California veterans. The app provides details of specific veteran benefits, including

eligibility, providers, hours of operation, and contact information. Using GPS technology, the app also provides maps and driving directions to nearby County Veterans Service Offices, U.S. Department of Veterans Affairs health facilities and clinics, and organizations that offer services to veterans. The Android app can be downloaded for free from Google Play and the Apple app can be downloaded for free from the Apple Store.

NASCIO's prestigious Recognition Awards are given annually to states that have implemented exceptional programs which have made an important contribution to the operation of state government.

This year, NASCIO received more than 120 nominations. According to NASCIO, the 2012 State Recognition Award nominations demonstrate that states strive to support the public policy goals of state leaders, provide cost-effective service to citizens, and make available solutions that are transferable to other agencies or units of government.

"To put this in sports terminology, being selected as a finalist by NASCIO is like going to the Super Bowl – it's really the highest recognition we can receive at a national level," said Mark Lennon, CalVet Deputy Secretary for Administration.

During NASCIO's Annual Conference in San Diego, the organization will highlight outstanding state initiatives, including the CalVet mobile app, during a Best Practices Breakfast on Tuesday, October 23, 2012.

In addition to the NASCIO award, the CalVet mobile app was given an Honorable Mention in the Driving Digital Government State Government Category of the 2012 Digital Government Achievement Awards presented by the Center for Digital Government. The Center for Digital Government is a national research and advisory institute on information technology policies and best practices in state and local government.

## AREA VETERANS ENJOY FREE SPORTING EVENTS

Veterans in Sacramento and surrounding counties have been the happy recipients of complimentary tickets to a variety of exciting sporting events. These tickets are the result of relationships developed by CalVet with sports franchises including the Sacramento River Cats, Sacramento Kings, Raceway in Sonoma, and the Sacramento Mountain Lions.

The Sacramento River Cats, have been incredibly generous with ticket donations this summer. In August alone, the Triple-A baseball club donated more than 1,800 tickets to CalVet to pass along to veterans through area veterans service organizations.

"We're so grateful to the River Cats and to other sports franchises for helping us care for veterans and their families," said CalVet Secretary, Peter J. Gravett. "Being able to connect veterans with the benefits and services they've earned through military service and offer them opportunities to enjoy a day of fun with their family or friends is wonderful."

Indy Grand Prix—a race that involved cars and stars of the Indianapolis 500®. Drivers like Will Power, Dario Franchitti, Helio Castroneves and Tony Kanaan reached speeds in excess of 170 mph on what has been called the most challenging road course on the race circuit. Eight hundred tickets, compliments of the Raceway in Sonoma and Pacific Gas and Electric Company's Tickets for Troops program, were given to CalVet, and were distributed to grateful veterans through nearly 30 veteran service organizations.

"The Wounded Soldiers and the Soldiers that take care of them deeply appreciate the tickets that CalVet is able to provide," said Wendy Van Houten, Army Wounded Warrior Advocate. "Those events allow the Wounded Soldiers to escape from their many doctor appointments to enjoy time with family and friends. The Soldier cadre is so involved

## TRAGEDY ASSISTANCE PROGRAM FOR SURVIVORS

If you have suffered the loss of a loved one in military service to America, the Tragedy Assistance Program for Survivors (TAPS) may be able to help you. In early October, TAPS will present the National Military Suicide Survivor Seminar and Good Grief Camp for Young Survivors in San Diego.

The seminar will offer carefully chosen workshops, sharing groups, and peer mentor training for adults, and a special program for children who have lost a parent, sibling or loved one in military service. The Good Grief Camp allows children to be surrounded by others of their own age who have experienced a similar loss. Both the Adult Seminar and the Children's Good Grief Camp run concurrently. Childcare is also offered for those under 4 years old.

TAPS is a nonprofit organization that provides immediate and long-term peer-based emotional support, grief and trauma resources, seminars, case work assistance, and 24/7 crisis intervention care for anyone grieving the death of a loved one who served in the military.

Through their Survivor Seminars and Good Grief Camps, TAPS has provided support to more than 30,000 surviving family members of fallen military members since 1994. ## COLLEGE TUITION FEE WAIVER FOR DISABLED VETERANS' DEPENDENTS

Disabled veterans can get help sending their children to college thanks to the help of the College Tuition Fee Waiver program.

This program waives mandatory system-wide tuition and fees at any State of California institution of higher learning. These institutions include any college in the University of California, California State University and community college system.

There are several plans under the College Tuition Fee Waiver program, but the most commonly used plan entitles the children—natural, adopted and step children—of disabled veterans (at any percentage) for a waiver of most of the fees (also referred to as tuition) at the aforementioned institutions. The

entire fee package is not waived, but the program usually waives about 90 percent of the fees. This program does not cover the expense of books, housing or parking.

The plan includes the dependent children of a veteran who has a service-connected disability or had a service-connected disability at the time of death, or died of service-connected causes. There is no requirement of war time service for the veteran and no age limit for the child of the veteran.

There are income restrictions. The child's annual income, which includes the child's adjusted gross income and the value of support provided by the parent, may not exceed the "annual income limit." This limit is announced every year as the national poverty level. This year it is \$11,702.

and have a connection to the military by being one of the following:

- Active-duty service member
- Veteran
- Spouse of military member or veteran
- Surviving spouse of a fallen soldier
- Child of a military member or veteran

Eligibility also requires potential applicants be either currently enrolled in a post-secondary school or planning to attend a post-secondary school the following year. This includes high school seniors. Eligible applicants must submit transcripts reflecting a minimum 2.5 grade point average on 4.0 scale.

Applicants must also submit an essay no longer than 750 words based on one of three prompts made available in the spring and fall by Veterans United Scholarship Program. Fall submissions will be accepted October 1-31, 2012 with recipients announced by November 15, 2012. Spring essays will be accepted April 1-30, 2013 and recipients will be announced by May 15, 2013.

## << WAIVER

The basic requirement for this benefit is that the veteran must provide proof of the service-connected disability. This is usually done with the U.S. Department of Veterans Administration award letter. The applicant must fill out the DVS-40 form, which can be obtained online by at [www.cacvso.org/uploads/dvs40.pdf](http://www.cacvso.org/uploads/dvs40.pdf).

The dependent child must provide proof of their relationship to the disabled veteran with either a birth certificate or adoption papers. In the case of a step child, the applicant must show proof of relationship to the veteran through marriage to the student's parent. This must be done with a birth certificate and marriage certificate.

The final document needed is the student's tax form for the last tax year showing that they made less than the income limit for this year. If the student did not work, they must produce a letter from the IRS or the Franchise Tax Board stating that they did not file taxes in the last tax year.

All of this information must be taken to the County Veterans Service Office (CVSO) where it is reviewed for accuracy and processed. The CVSO sends a letter to the college applied for and a copy to the student. The fees are then waived by the college.

There is no age limit or limit on the number of times a student may use this benefit. The only limitation is the amount of income reported by the student. The income and the parental support cannot exceed the

income threshold. If the threshold is exceeded the student is denied the benefit. There is no wiggle room, and the benefit will be denied even if the student is one dollar over the income limit.

This benefit also applies to graduate schools in most cases. Certain classes that are not funded by the educational general fund can be excluded from this waiver. Extension and some summer sessions can sometimes be funded by other than general fund sources and the school may not accept the fee waiver for these classes.

There are three other plans that benefit veterans under the College Fee Waiver Program. In Plan A, the children and spouse, unmarried widow or registered domestic partner of a 100-percent disabled veteran may receive the tuition fee waiver under certain circumstances.

Plan C covers dependents and the spouse of any California National Guard member who was killed on active duty.

Plan D gives these benefits to the children of Medal of Honor recipients. It is for undergraduate studies only and the student must meet both the income and age restrictions.

## NEW PROGRAM INTRODUCES RETURNING VETS TO ENTREPRENEURSHIP

Transitioning veterans can learn the fundamentals of small business ownership and the U.S. Small Business Administration (SBA) tools and resources available to them through the SBA's Boots-to-Business program. The SBA aims to ultimately provide entrepreneurship awareness and opt-in training nationwide.

The Transition Assistance Program (TAP) was created as a nationwide entrepreneurship training program to unleash the potential of the 250,000 service members that transition each year. To meet that goal, SBA is partnering with U.S. Departments of Defense and Veterans Affairs to include an entrepreneurship training component as a part of the overall changes to the existing TAP.

The goal is to strengthen service members' transition from military to civilian life and to prepare them for success in the next phase of their life. There are now three optional tracks a transitioning service member can choose to explore more deeply as a part of the new TAP:

## << ENTREPRENEURS

1) Education; 2) Technical Training; and 3) Entrepreneurship. SBA and its Resource Partner network will deliver the Entrepreneurship track to transitioning service members who opt-in to receive such training.

To test the Boots to Business initiative prior to national rollout, SBA is working with the United States Marine Corps (USMC) to deliver a streamlined version of the Boots to Business phased entrepreneurship training to approximately 20,000 transitioning Marines in four pilot locations—two of which are in

California: Camp Pendleton and Twenty-Nine Palms .

## MORTGAGE-FREE HOMES FOR VETERANS AVAILABLE IN CALIFORNIA

OEF and OIF combat-wounded veterans and unmarried Operation Enduring Freedom (OEF) / Operation Iraqi Freedom (OIF) Gold Star spouses may qualify for 100% mortgage-free homes.

The homes are donated by the Military Warriors Support Foundation, a nonprofit organization dedicated to assisting our heroes as they transition to civilian life. Besides the homes donation program, the Foundation's programs include employment assistance and outdoor recreational activities.

"We are so glad that the Military Warriors Support Foundation is

making mortgage-free homes available in California to our deserving veterans," said Peter J. Gravett, Secretary, California Department of Veterans Affairs. "I encourage qualifying OEF/OIF veterans and Gold Star spouses to take advantage of this opportunity. Imagine getting the title to your home after only three years of ownership!"

The homes donation program, Homes4WoundedHeroes, has awarded more than 140 mortgage-free homes across the continental U.S. since its inception in late 2010. The homes come with a free 3-year financial and family mentorship that

helps the families understand the fundamentals of home ownership.

To be eligible, applicants:

1. Must be an OEF/OIF combat-wounded veteran (Purple Heart recipient preferred) or OEF/OIF unmarried Gold Star spouse;
2. Must be honorably retired or separated from the military. (Those with compelling situations, who are less than 90 days from retirement or separation may be considered); and
3. Must not currently have a mortgage;

## HELP FOR CAMP LEJEUNE MARINES EXPOSED TO TAINTED WATER

President Obama recently signed into law the Honoring America's Veterans and Caring for Camp Lejeune Families Act, which includes recognition of a water contamination problem that occurred at Camp Lejeune, North Carolina, between 1957 and 1987.

During that time, Marines and their families living at the base apparently bathed in and ingested tap water contaminated with harmful chemicals. An undetermined number of former base residents later developed cancer or other ailments, which many blame on the contaminated drinking water.

In 2009, the federal government initiated investigations into the

allegations of contaminated water. The contamination appears to have affected the water from two of the eight water treatment plants on the base. More than 70 chemicals have been identified as contaminants at Camp Lejeune including dry cleaning solvents and a degreaser. The Marine Corps has since cleaned up the water supply and safe water is being supplied to Camp Lejeune and its residents.

In 1999, the Marine Corps began notifying former base residents that they might have consumed contaminated water. The notifications were directed by a federal health study examining possible birth defects among children born at the base during the contamination years. At this time, there is insufficient scientific and clinical evidence to establish a presumptive association between service at Camp Lejeune during the period of water contamination and the development of certain diseases.

The U.S. Department of Veterans Affairs (USDVA) is closely monitoring new research. USDVA representatives regularly attend the quarterly

Community Action Panel meetings hosted by the Agency for Toxic Substances and Disease Registry.

While all the facts are not in on this issue, all veterans who served at this Marine base between 1957 and 1987 and suffer from illnesses that could be tied to this exposure should file a claim for service-connected disability by going to their County Veteran Service Office (CVSO). To find the CVSO nearest you, go to [www.cacvso.org](http://www.cacvso.org). Click on "Contact Us," and then click on your county of residence. The USDVA will decide these claims on a case-by-case basis.

The families of veterans who lived on this base during that time should register at <https://clnr.hqi.usmc.mil/clwater/index.aspx> to receive notifications from the Marine Corps regarding Camp Lejeune Historic Drinking Water.

## VETERANS BENEFITS AND CHILD SUPPORT CALCULATIONS

When a veteran divorces and there are minor children involved, there can be confusion about whether veterans benefits are subject to court-ordered child support calculations. Veterans ordered to pay child support are subject to the same laws and regulations as enlisted members of the military and non-veterans. They are all required to pay their child support on time and in full every month.

The dollar amount of child support owed each month is determined using the Statewide Uniform Child Support Guideline established in California state law. It is based primarily on earnings, regardless of the source, and the amount of time the child or children spend with each parent. Guidelines that allow parents to estimate the amount of child support they may owe are available at [www.childsup.ca.gov/Resources/CalculateChildSupport.aspx](http://www.childsup.ca.gov/Resources/CalculateChildSupport.aspx).

The California Department of Child Support Services (DCSS) and the Local Child Support Agencies (LCSA) work with parents and guardians to

## CALVET VETERAN BRINGS HOME SILVER MEDAL IN NATIONAL WHEELCHAIR GAMES

Every year, veterans across the country come together to compete in the National Veterans Wheelchair Games—the largest wheelchair sports competition in the world. Presented by the U.S. Department of Veterans Affairs (USDVA) and the Paralyzed Veterans of America (PVA), this multi-event sports rehabilitation program is open to U.S. Military veterans who use wheelchairs for sports competitions due to spinal cord injuries, amputations or certain neurological problems, and who receive care at USDVA medical facilities or military treatment centers.

More than 500 veterans with disabilities competed in the Games, which featured exciting competition in motorized wheelchair relay, softball, table tennis, track and field, trapshooting, power soccer, quad rugby, archery, swimming, basketball, bowling, weightlifting, nine-ball,

wheelchair slalom and hand-cycling. For the third year, stand-up events were held in archery and table tennis for athletes who have amputations and chose to compete using prosthetic devices, instead of their wheelchairs.

Among the competitors was 70-year-old John Smith, a resident of the Veterans Home of California – West Los Angeles. When asked about the event, Smith stated, “I never had the feeling of being alone or dependent. Those things were dispelled the moment I was at the competition. The games are held just like the Olympics. I can’t begin to tell you how much fun it was!” Smith is also a member of the USDVA Greater Los Angeles Shakers, the largest team represented at the competition this year.

Smith’s hard work paid off as he took home two Silver Medals! Despite the 104-degree temperature, he placed

ensure children and families receive court-ordered financial and medical support.

Most court-ordered child support payments are made through employer income withholding. An Income Withholding Order can be placed on military pension, compensation, emergency officer's retirement pay, and certain disability benefits.

Federal statutes generally prohibit the garnishment of veterans benefits provided by the U.S. Department of Veterans Affairs (USDVA) to satisfy debts owed to private individuals. The exception is USDVA disability compensation for a service-connected disability received in lieu of waived military retired pay.

If a parent is late or doesn't pay, interest accumulates on unpaid arrears at 10 percent a year. Collections may be obtained through liens on real property and interceptions of unemployment and state disability payments, tax refunds and lottery winnings. Passports can be denied, driver licenses and professional licenses can be suspended, and bank accounts can be levied, under certain circumstances.

Help is available. If a parent loses a job, becomes disabled, goes to jail or has other circumstances that make that person unable to make the court-ordered child support payments, it is essential that they contact their LCSA as soon as

Options are available to parents who qualify that lower current child support owed each month and/or help pay off past due child support (arrearages). LCSAs can also help qualified veteran parents enroll in the Military Compromise of Arrears Program. This program is available to noncustodial parents who have been or are currently reservists or members of the National Guard who experienced a decrease in income as a result of being activated to U.S. military service and neglected to seek a modification to the child support order.

Child support services are available to individuals needing or already receiving support, as well as to parents paying child support. DCSS and the 51 LCSAs throughout California are ready to help participants provide financial and medical support for their children. ## THE NEW TRANSITIONAL TREATMENT PROGRAM AT YOUNTVILLE

The CalVet Home in Yountville is testing a solution to a serious problem. So far, the results are promising.

The United States Department of Veterans Affairs (USDVA) has an initiative to end homelessness for



veterans. This past year, in response to the USDVA initiative, the CalVet Homes started to increase the admission of homeless veterans and to expedite the admissions process. This was good, but it created a problem.

Homeless veterans present unique challenges. Their situations are more complex and severe than those of veterans who are primarily aged or disabled. Challenges can include brain injury, serious mental health issues, drug and alcohol abuse, years of neglected physical health, and other behaviors that are inconsistent with a peaceful and therapeutic communal living environment.

## SPECIALLY ADAPTED HOUSING GRANT PROGRAM

Disabled veterans who are not ready to leave their home but are facing challenges continuing to live there can get help remodeling their home to make it more accessible.

Veterans or service members who have specific service-connected disabilities may be entitled to a grant from the U.S. Department of Veterans Affairs (USDVA) for the purpose of constructing an adapted home or modifying an existing home to meet their adaptive needs. The goal of the Specially Adapted Housing (SAH) Grant Program is to provide a barrier-free living environment that affords the veterans or service members a level of independent living he or she may not normally enjoy.

Since 1948, USDVA has provided adaptive housing assistance grants to eligible individuals who

have certain service-connected disabilities to construct an adapted home or modify an existing home to accommodate their disabilities. Today, USDVA provides adaptive housing assistance primarily through three programs—Specially Adapted Housing (SAH), Special Housing Adaptation (SHA) and TRA benefit which allows veterans to apply for a grant to adapt the home of a family member with whom they are temporarily residing.

There are three types of grants which are available to help severely

Yountville's Behavioral Wellness team accepted the challenge of the USDVA initiative, redirected their resources, and developed a pilot Transitional Treatment Program to meet the needs of this population of veterans. Members of the interdisciplinary team include psychologists, social workers, recreation, occupational, and music therapists, residential care unit leaders, alcohol and drug treatment counselors, physicians, and security personnel. The program considers new admissions to the Home as well as current residents who may not be adapting successfully due to the problems noted above.

Currently, there is room for six veterans in this intensive, multi-month program. Many of these are veterans who would not previously

be admitted to a veterans home; too often they would remain homeless.

The program is highly structured, including group activities, one-on-one counseling, exercise, work and recreation five days per week. The interdisciplinary team reviews each veteran's progress weekly, and an individualized care plan is developed. The plan is adjusted to meet unique needs, e.g., brain injury, drug and alcohol addiction, aggression and anger, withdrawal and isolation, destructive behaviors, extreme fearfulness or anxiety, etc. Each veteran has input into their plan of care, and goals are spelled out in a written behavioral contract.

The program has had its first graduate; others are showing steady improvement. Within this program, residents bond with each other and develop peer support. They

get immediate feedback when they misbehave or act out. They learn time management skills, adaptive social skills, and positive ways to express their emotions. They learn to accept and embrace the benefits of sobriety. They are offered opportunities to exercise employment skills within the Home's stipended volunteer program. As skills are acquired and exercised, Transitional Treatment Program veterans are integrated into Home's activities and social events.

The Transitional Treatment Program is an opportunity to help underserved veterans in a new way. It is restoring lives. The program moves CalVet Homes closer to the goal of "no veteran left behind." We look forward to refining and expanding this much-needed program.

disabled veterans in adapting housing to their special needs.

### **Specially Adapted Housing Grant**

The maximum amount of this grant is \$63,780. It is available to veterans with service-connected permanent and total disability due to one of the three following conditions:

- the loss or loss of use of both lower extremities or,
- blindness in both eyes, having only light perception, plus loss or loss of use of one lower extremity or,
- loss or loss of use of one lower extremity together with other disabilities which precludes locomotion without the aid of braces, crutches, canes or a wheelchair

### **Special Home Adaptations Grant**

The maximum amount of this grant is \$12,756. It is available to veterans with service-connected permanent and total disability due to one of the two following conditions:

- blindness in both eyes with 5/200 visual acuity or less or,
- the loss or loss of use of both hands.

### **Temporary Residence Grant**

The TRA grant program enables veterans and service members eligible under the SAH and SHA programs to use up to \$14,000 and \$2,000, respectively, to modify a family member's home. Each TRA grant counts as one of the three grants allowed under either SAH or SHA. TRA grants also count toward the maximum allowable amount, \$60,000 under SAH and \$12,000

under SHA. The TRA grant program is available through December 31, 2012.
