Wait Lists and Homeless Veterans are still "in the news" but as usual we're really not seeing much if any improvement at all!

It wasn't long ago that Secretary McDonalds "solution" was to increase appointment times from 14 days to 30 days which in my personal opinion doesn't help and/or solve.

The problem still remains lack of licensed medical professionals nationwide, an estimated 4,100 job positions remain open and unfilled. And at this time I've still not seen much in the way of job announcements or postings any where to show any signs of an attempt to fill those job positions, thus adding to the delays and wait times.

And it wasn't long ago that the backlog list was composed of 600,000 Veterans actually living and waiting and more than 307,000 had more than likely passed away while waiting. That's one in every three Veterans who has passed away WAITING!

Then we find out the reason for that was the department was staffed by family members of the IT Director and none were educated in computer science or engineering, they were all in school courtesy of the IT Director, the VA and of course the TAXPAYER who funds the VA and DoD both!

Additionally go to your Congressman's and Senators websites and send the same message using their individual systems. The more we hound them, and flood their E-Mails and phones, the more attention we will get and the sooner we can see real positive action FOR and not AGAINST Veterans.

If you've not visit the <u>Veterans-For-Change</u> website lately, or never been there, give it a shot! In the past 30 days we've added another 1,300+ documents, and re-installed some that were missing in the transition to the new version of the software.

Betty Hidalgo who is our Operation Mail Call director has been making sure care packages have been going out weekly, and most of the requests have been coming from those in the Army. This past week she got a little bombarded with requests from the Air Force, and of course she is more than happy to try and meet their need too.

Update on the Blue Water Navy Vietnam Veterans Act

This week we have had 5 more Representatives signed onto the Bill making the total 269. We need to get that number up to over 289 so that certain rules will be suspended.

We also had 1 more Senator signed up making the total for the Senate to be 24.

John Wells is making another trip to Washington DC this coming week. On Blue Water Navy Awareness we have posted a list of some of the Members of Congress Offices he will be visiting along with the Contact Information for that office. We are trying to get as many people as we can to write these Congress Members and asked them to support the Blue Water Navy Vietnam Veterans Act. Please visit us for the list and please join us in writing these Members of Congress.

Also we do have Contact Information for all Members of Congress. This is so we all can all keep contacting Member of Congress to let them know we are not going away. We are here to stay. We will be post a list of e-mail list for each member of Congress (it will be one of the staff members). Due to an agreement I have it will only be available on Blue Water Navy Awareness on Facebook (for the time being).

There was a Webinar this week put on by two of the best that are fighting for us to get the Blue Water Navy Vietnam Veterans Act passed. Besides giving out the back ground information they suggested ways for us to help. Keep Contacting Congress was one of the ways along with getting the word out to the News Media. We need to let everyone know what Blue Water Navy Vietnam Veterans are going through. How the VA is putting us off and ignoring us. One other idea was to keep contacting the VA, if you know the e-mail address of Robert MacDonald and Sloan Gibson please send them my way. I have tried Robert.McDonald@va.gov and Sloan.Gibson@va.gov and I did not get a Bounce back so they may be valid. Yes I know they won't actually get the e-mails BUT if they keep getting them I am sure that the person who is reading them will let them know we are out here. Not only do we need to make the request for the Blue Water Navy Vietnam Veterans Act, we need to ask them to support the Extension of Agent Orange Act (HR 3423). This will extent by two years the original sunset deadline of the Agent Orange Act of 1991 to ensure that Vietnam veterans exposed to Agent Orange receive just compensation and care.

The Act expires on September 30, 2015 and the legislation would extend the sunset to September 30, 2017. FRA warned the House and Senate Veterans Affairs Committees regarding the sunset of the Act during its March 18, 2015 testimony.

The Agent Orange Act of 1991 (AOA) established a presumption of service connection for diseases associated with Agent Orange exposure, relieving Vietnam veterans from the burden of providing evidence that their illness was a result of military service. This law directs the the National Academy of Sciences (NAS) to periodically research and review diseases that might be associated with Agent Orange exposure. The VA is required to add diseases the NAS finds to have a positive association to Agent Orange exposure to the VA's list of presumptive service connected diseases. Since the enactment of the AOA, the NAS has issued reports that have led to the presumption of service connection for diseases such as Parkinson's, B-cell leukemia and early onset peripheral neuropathy. Without these studies, thousands of Vietnam era veterans would have gone without the benefits they greatly deserve.

If the AOA expires the VA would no longer be obligated to review the NAS report or add any new diseases to the presumption of service list, in the process denying thousands of veterans their right to compensation.

Members are urged to use the Action Center to ask their Representative to support this important legislation.

DoD Celebrates National Hispanic Heritage Month

From Sept. 15 – Oct.15, the Department of Defense joins the nation in celebration of National Hispanic Heritage Month. During this time, the department and the nation honor the histories, cultures and contributions of American citizens whose ancestors came from Spain, Mexico, the Caribbean and Central and South America. The start of National Hispanic Heritage Month also marks the anniversary of independence for Costa Rica, El Salvador, Guatemala, Honduras and Nicaragua. The independence of Mexico and Chile are observed shortly thereafter, on Sept.16 and Sept. 18, respectively.

The theme of this year's observance, "Hispanic Americans: Energizing our Nation's Diversity," harkens to the vibrant and thriving contributions of Hispanics to our nation across the centuries. The celebration seeks to draw attention to the diversity and countless contributions Hispanics continue to make to enrich the United States and strengthen the defense of our nation.

The department will honor National Hispanic Heritage Month with programs and activities at installations around the world. The Pentagon will host a ceremony to present a temporary display, designed and owned by the Hispanic Medal of Honor Society, which features Hispanic Medal of Honor recipients. The society promotes the awareness of the patriotism, gratitude, and loyalty of Hispanics in the United States. The ceremony will be held in the Pentagon on the second floor in corridor 2A.2.5 on Friday, Sept.18 at 2 p.m.

Other Hispanic Medal of Honor displays around the National Capital Region include one titled, "Return with Honor," which illustrates the story of Commander Everett Alvarez Jr., the first American pilot shot down over North Vietnam. "Return with Honor" will be featured at the Navy Yard. A third display entitled "Justice for my People" showcases the story of Dr. Hector P. Garcia, the first civil rights activist and founder of the American G.I. Forum will be displayed at Fort Belvoir in Building 1458.

The department is committed to honoring and recognizing the Hispanic Americans that strengthen the fabric of our country and serve in defense of the values we hold dear. All department personnel are encouraged to recognize the immeasurable contributions made by Hispanic Americans and to celebrate the diversity of our workforce. Affected Vietnam Veterans should consider Filing Reconsideration of Claim

As reported in the May 1, 2015 issue of NewsBytes, the Court of Appeals for Veterans Claims has ruled that veterans who served aboard ships in the harbors of Vietnam more than 40 years ago should not be arbitrarily excluded from Agent Orange claims—a significant step forward for these veterans. Former Navy seaman Robert Gray has been denied multiple disability claims by the Department of Veterans Affairs (VA) based on the fact that he was aboard a ship—not on land—during the Vietnam War, when the herbicide Agent Orange was liberally sprayed by American forces to remove foliage and eliminate enemy cover. The chemical was later found to cause numerous health problems for service members who were exposed, but the VA has denied disability claims to U.S. Navy sailors under the argument that the seamen were offshore and were not directly exposed. Veterans who served on ships off the coast of Vietnam who later developed specific health problems tied to exposure to Agent Orange should consider filing a claim for VA benefits or filing for re-consideration of previously denied claims.

In related news, FRA is supporting the "Agent Orange Extension Act," (H.R. 3423) which would extend by two years the original sunset deadline of the Agent Orange Act of 1991 and ensure that Vietnam veterans exposed to Agent Orange receive just compensation and care. The Act expires on September 30, 2015, and the legislation would extend it to September 30, 2017.

In addition, FRA supports the "Blue Water Navy Vietnam Veterans Act," (H.R. 969/S. 681) which would clarify a presumption for filing disability claims with the VA for ailments associated with exposure to Agent Orange herbicide during the Vietnam War. Congress should recognize that so-called "Blue Water" veterans who served off the coast of Vietnam were exposed to Agent Orange herbicide. The bill authorizes presumptive status for VA disability claims associated with this exposure for this group of veterans. Members can weigh in on these proposals through the FRA Action Center (action.fra.org/action-center).

The governor of California has issued a state of emergency in Amador and Calveras counties for the Butte Wildfire and in Lake and Napa counties for the Valley Wildfire. Emergency prescription refill procedures are in place from 9/11/2015 through 10/112015 and 9/13/2015 through 10/13/2015 respectively.

VA Announces Price Freeze

The Department of Veterans Affairs announced that veterans who fill their prescriptions at a Veterans Affairs Department pharmacy will see no increase in co-payments until at least January 2017.

Under the new policy published in the Federal Register, VA will extend a freeze on co-payment increases until at least Dec. 31, 2016.

Veterans are required to pay a portion of the cost for prescription drugs they receive for non-service-related conditions if their incomes exceed established threshold limits.

They pay either \$8 or \$9 per 30-day prescription, depending on their eligibility status within the VA health system.

According to VA, veterans tend to reduce use of their pharmacy benefits when co-payments rise, which leads to not taking their medications as prescribed.

Patients also are at greater risk for adverse drug interactions if they fill some of their prescriptions at VA and others at civilian pharmacies, VA officials say.

The freeze is designed to continue providing the benefit to veterans at moderate cost.

A Possible NDAA Compromise Emerging?

There appears to be movement on the stalled National Defense Authorization conference report. According to multiple sources, the chairmen of the House and Senate Armed Services Committees are close to resolving a dispute over military health care fees that has ground to a halt negotiations to craft a final version of this year's National Defense Authorization Act.

One proposal being considered is to allow a "one-time reset" of TRICARE fees - an approach that could kick to next year the contentious issue of whether to green-light the Obama administration's request for a series of fee increases phased in over a decade. This would be similar to what happened last year, when negotiators agreed to a pharmacy fee hike for the current fiscal year but rejected long-term fee hikes, saying they might reconsider the 10-year proposal in the future.

"I think we're making progress," said Rep. Joe Heck (R-NV), chairman of the House Armed Services Military Personnel Subcommittee. "I think that there is an opportunity to look potentially for a smaller, one-time reset of the co-pays that could pass muster."

He cautioned that "negotiations are ongoing." Senate Armed Services Chairman John McCain also said Thursday there has been "progress" in the House-Senate conference negotiations, which have been stalled since July over TRICARE fees and other issues.

Starting October 1, 2015, a new law requires all TRICARE beneficiaries, except active duty servicemembers, to get select brand name maintenance drugs through either TRICARE Pharmacy Home Delivery (www.tricare.mil/homedelivery/) or from a military pharmacy. Beneficiaries who keep using a retail pharmacy for these drugs will have to pay the full cost. Maintenance drugs are those you take regularly for a long time. The law does not apply to drugs you take for a short time, like antibiotics. Beneficiaries living overseas, or with other prescription drug coverage, are not affected. You can check with your local military pharmacy to see if they carry your prescription. Veterans Sue Army Over Chemical Testing

Veterans who were used in chemical and biological testing from 1922 to 1975 have filed a class action lawsuit against the U. S. Army. If they are successful, the Army will have to explain to anyone who was used in testing exactly what substances they were given and any known risks. The Army would also have to provide those veterans with health care for any illnesses that result, in whole or in part, from the testing. The law firm representing the veterans estimates at least 70,000 troops were used in the testing, including World War II veterans exposed to mustard gas. In June, an appeals court ruled in favor of the veterans. The Army has filed for a rehearing. National Veterans Crisis Line

September is suicide prevention month, and the Department of Veterans Affairs (VA) is raising awareness about its Veterans Crisis Line. When veterans call the Veterans Crisis Line, use the chat service, or send a text, they are connected to resources local to them. There are suicide prevention coordinators (over 300) located at every VA in the country. The Veterans Crisis Line is able to connect veterans with their local suicide prevention coordinator who can then ensure they are getting the treatment and resources they need, like getting enrolled in VA care. Service Dogs for Wounded Warriors

The Walter Reed Wounded Warrior Service Dog Training Program (WWSDTP) internship provides therapy while allowing military servicemembers to train dogs that will later be given to other disabled warriors. The program can help people who have trauma, depression, anxiety, stress and other conditions. Military servicemembers are recommended for the program by people on their care team. Once they are accepted into the program, the servicemember goes to work with service dog trainers during train-the-trainer sessions. Service dogs learn as many as 90 tasks during the training. Service dogs trained in the program are mainly mobility dogs — those trained to help people who have some form of physical disability such as an amputation. Once the dogs complete the program they are placed with a wounded, ill or injured veteran. Veterans Still Waiting

A new report from the Department of Veterans Affairs (VA) inspector general has found that nearly 900,000 military veterans have pending applications to access health care from the Department of Veterans Affairs. The report recommended a total overhaul of their record-keeping system that could take years. The report says one-third of those veterans are thought to be dead, but problems with the data make it tough to know how many former troops are still struggling to get care. Veterans and Financial Readiness

The millennial generation of veterans and their families — those between 18 and 35 years old — have proven to be outstanding warriors. But, they are struggling in basic financial readiness. They are missing basic financial readiness skills — skills like spend less than you earn, put money away each month for retirement, and for a rainy-day fund, protect yourself and your family and your belongings, and prepare basic estate-planning documents. To address this issue, USAA Bank and The American Legion have worked together to develop a dedicated webpage (www.legion.org/usaa) to provide personal finance assistance and access points to USAA's online tools.

WASHINGTON – Secretary of Veterans Affairs Robert A. McDonald today announced the awarding of up to \$8 million in grants to eligible recipients with experience managing largescale adaptive sports programs for disabled Veterans and disabled Servicemembers of the Armed Forces. The grant recipients may use these funds for planning, developing, managing and implementing adaptive sports programs.

The VA is awarding the Grants to national governing bodies, which prepare high-level athletes for Paralympic competition; Veterans service organizations; city and regional municipalities; and other community groups to provide a wide range of adaptive sports opportunities for eligible Veterans and Servicemembers. The Grants will support sports ranging from rowing, cycling and skiing to golf, fly fishing and equestrian sports.

"Adaptive sports help Veterans heal both physically and emotionally," said Secretary McDonald. "We are proud to partner with organizations nationwide to provide these rehabilitative opportunities for America's Veterans."

VA will distribute the <u>grants</u> to <u>89</u> national, regional and community programs serving all 50 states, the District of Columbia, Puerto Rico, the Virgin Islands and Guam. Approximately 10,000 Veterans and Servicemembers are expected to benefit.

VA Awards Local Grants to Prevent and End Homelessness

Flexible Grants Are Helping Achieve Lower Rates of Veteran Homelessness, Community By Community

WASHINGTON – Thousands of very low-income Veteran families around the nation, who are permanently housed or transitioning to permanent housing, will continue to have access to crucial services with the renewal of approximately \$300 million in grants under the Supportive Services for Veteran Families (SSVF) program.

SSVF renewal funding, which supports outreach, case management and other flexible assistance to prevent Veteran homelessness or rapidly re-house Veterans who become homeless, went to <u>286</u> non-profit organizations and consumer cooperatives in all 50 states, the District of Columbia, Guam, Puerto Rico and the Virgin Islands. A list of grantees is located at www.va.gov/homeless/ssvf.asp.

"SSVF grants empower our local partners to provide short-term-focused interventions that promote housing stability among the most economically vulnerable Veterans and their families," said Department of Veterans Affairs' Secretary Robert A. McDonald. "Whether they need rental or child care assistance, transportation vouchers or another type of support, SSVF grantees offer Veterans the mix of services they need to gain housing and stay housed."

SSFV grantees typically serve Veterans with incomes below 30 percent of the area median income. Grantees must follow the housing first approach, which centers on permanently housing homeless Veterans quickly without preconditions and providing supportive services as needed. Additional SSVF requirements are that grantees engage in outreach to find and serve Veterans in need, provide Veterans with case management and assist them in obtaining VA and other public benefits.

SSVF served 127,829 participants in fiscal year (FY) 2014 and is on track to serve 135,000 Veterans and their family members by the end of FY 2015. As a result of these and other efforts, Veteran homelessness is down significantly since the launch of the Federal Strategic Plan to Prevent and End Homelessness in 2010. Since 2010, nearly 230,000 Veterans and their family members have been permanently housed, rapidly rehoused or prevented from falling into homelessness by VA's homelessness programs and targeted housing vouchers provided by HUD.

The funding announced today will support SSVF services in FY 2016, which starts October 1, 2015, and ends September 30, 2016.

The SSVF program is authorized by 38 U.S.C. 2044. VA implements the program by regulations in 38 CFR part 62. Visit www.va.gov/homeless/ssvf.asp to learn more about the SSVF program.
