And the sad thing is that most people do not get it. So how do those with Posttraumatic Stress and their <a href="loved ones">loved ones</a> best survive this time of year? And how can others convey long-overdue appreciation?

I got a real shock the day I was looking for Veterans Day cards at our huge local super store. Three complete aisles and four end displays of greeting cards, including rows and rows of Halloween cards (that in itself would be another blog another time). Could not find the Veterans Day cards.

So I asked an employee (who had worked there for 15 years). She had not even heard of Veterans Day! What? Excuse me???

Finally I found them. Just a few cards. Down at the bottom. It made me mad. And sad. So I bought a whole bunch (if you ever need one, call me.)

For the first time, I realized that *I too* am more susceptible to being triggered this week. Do not be surprised if our vets and **those of us who love them** seem more irritable than usual this time of year. **Symptoms of PTSD** may be much more hot-wired (sleep disturbances, anxiety, substance abuse, withdrawing, outbursts or emotions, hyper-vigilance, flashbacks, suicidal thoughts, etc.).

I am coming to believe that a lot more veterans have PTSD than realize it. They often carry themselves well in parades and other patriotic events. And rightly so. They DO deserve all the honor and gratitude they receive! But inside many of those brave uniformed bodies are hidden the terrors of war. No one but the veteran really knows the horror they lived through. And relive over and over again.

# So whether you are a veteran or a loved, one, please be sure to surround yourself with good <u>support</u> during this time, stay aware of your own triggers, and take care of YOU.

#### No Veterans COLA for 2016

While Congress is considering bills to authorize a cost-of-living adjustment (COLA) in 2016 governing veterans' disability compensation, pension and other payments, the Social Security Administration has already announced that no COLA will be made available in 2016. Therefore, if Congress passes veterans' bills authorizing COLA increases next year, there will not be any increase in the rates paid for disability compensation and other benefits. This lapse is unfair to America's disabled veterans.

In recent years, it has become apparent that even the several prior COLA increases failed to meet rising costs faced by disabled veterans, their dependents and survivors. These individuals are not "normal" consumers of goods and services on the U.S. economy; they are significantly older and suffer disabilities at higher rates than average citizens across the age range of residents of this country. In general, they are heavy consumers of health care, both within the systems of the Departments of Veterans Affairs and Defense, from Medicare and Medicaid, and from private providers. The sickest and most infirm among them are unemployable. They are substantial consumers of expensive prescription medications and other health aids. In many cases, they live on fixed incomes and some must subsist on a single source of funds: their monthly government disability or pension payments. Flattening next year's VA benefit payments is an unjust policy and will negatively impact the financial security of this deserving group, and should be remedied.

Please contact your elected officials to urge them to introduce legislation that would guarantee a reasonable COLA for wounded, injured, and ill veterans and their dependents and survivors. A letter for this purpose is provided for your use. You may also write a personal message if you prefer.

As always, thank you for your grassroots support and advocacy to enable us to move helpful legislation through Congress that is beneficial to disabled veterans.

311VET is Veterans Benefits Administration's (VBA's) new benefits app, and it answers a wide range of questions about veterans' benefits, including what benefits you may be entitled to, how to apply for benefits, how different benefits are defined, and where to go to get more information about VA services. 311VET can provide information about most VA benefits, including pension, education, health, disability, loan, burial and career benefits. 311VET cannot answer questions about the status of specific claims (use IRIS for that) or other questions that require personally identifying information (PII) or protected health information (PHI). 311VET is available for both iOS devices and Android devices. If you do not have a smart phone, simply text your question to 311838.

When TRICARE Prime beneficiaries need specialty care services, they must receive a referral from their primary care manager (PCM). Getting a referral makes sure your regional or overseas contractor authorizes the care before you make an appointment. TRICARE rules require that if the care you need is available at a military hospital or clinic near you, and there is space available, you will be referred there first. Before making an appointment with the specialty care provider, <u>call</u> your regional contractor 3-5 days after the PCM enters the referral to check the status. If you are overseas and are referred to a host nation provider, be sure to <u>coordinate your care through your overseas contractor</u>.

# Free Legal Aid Clinic in Idaho

Several University of Idaho law students have organized a free monthly legal aid clinic in Lewiston, Idaho to assist veterans with various civil issues. Veterans are asked to fill out an intake form when they arrive at the clinic to determine what their legal need is and collect some personal information, as well as a memorandum of understanding explaining that there may be some limitations to the services that can be provided at the clinic. They then meet with a licensed attorney who provides them with directions on how to resolve their issue. Each clinic is 6 to 8 p.m. on the first Wednesday of the month in the Brammer Building, 1225 Idaho St., in Lewiston, Idaho. The next clinic is Nov. 4.

#### AF Releases Sexual Assault Prevention Strategy

The Air Force recently released a new, five-year Sexual Assault Prevention and Response Strategy. The two-part document outlines both response and prevention strategies. Although Airmen will likely be familiar with the programs included in the response portion of the strategy, the prevention strategy presents a new phase in Air Force SAPR efforts. The strategy document explains factors that put an individual at risk for perpetration such as previous unhealthy experiences, beliefs or relationships, and outlines a plan to tailor training to address risk factors in every setting. Airmen will begin seeing portions of the prevention strategy in action this year. The new 2015 SAPR Strategy is available online.

## Keeping Up With VA Regional Offices

The Department of Veterans' Affairs (VA) has fifty-six regional benefits offices (ROs) located throughout the country. All states have at least one, and a few states have more to handle larger populations. Many ROs periodically host claims clinics and similar events. To locate an event in your area you can do one of the following: (1) follow VBA on <a href="Facebook">Facebook</a> and <a href="Twitter">Twitter</a>; VA post details about the events in advance of the event; (2) all ROs have a designated webpage; this <a href="mailto:map">map</a> will link you to the one in your state; or (3) contact your local RO and inquire about upcoming events. But, you do not need to wait for an event to ask questions. All ROs also have public contact personnel who can assist you with your questions during normal operating hours.

# DoD Replaces Risky Commissary Plan

The Pentagon's last two budget plans to "reform" the commissary benefit for military families and retirees were driven by a goal to save money, without due regard for preserving the benefit, said a senior Defense official who claims to be leading commissary reforms on a less perilous path. In a strikingly frank address Tuesday to commissary brokers, suppliers and product representatives at the annual convention of American Logistics Association, Peter Levine, deputy chief management officer for the Department of Defense, confirmed what critics in Congress and industry, and advocates for commissary patrons, had charged for the past two years.

# VA Launches Hepatitis C-Advanced Liver Disease Disparities Dashboard Dashboard Bolsters VA Efforts to Identify and Treat Veterans With Hep C and Liver Disease

WASHINGTON – The Department of Veterans Affairs (VA) is stepping up its efforts to accelerate treatment for Veterans with hepatitis C and advanced liver disease (ALD) through the creation of a Hepatitis C–ALD dashboard. The dashboard works by using a set of criteria, including age, gender, geography, service era along with and race and ethnicity, to distinguish Veteran groups at highest risk for ALD as a result of hepatitis C.

"The dashboard is a powerful data tool to help VA identify Veteran groups disproportionately affected by Advanced Liver Disease and to ensure they receive the appropriate health care," said Dr. David Shulkin, VA's Under Secretary for Health. "VA will provide data directly to facilities for any of the vulnerable groups identified by the dashboard and support outreach efforts to Veteran populations disparately impacted and not currently served by VA health care. This is an important step in assuring all Veterans with ALD receive timely, appropriate care."

VA's Veterans Health Administration's Office of Health Equity developed the dashboard as part of its efforts to target and accelerate care of Veterans with this serious disease. The new resource promotes equitable diagnosis and treatment of underserved Veterans with hepatitis C and ALD nationally and compliments existing clinical hepatitis and liver disease dashboards available in some Veterans Integrated Service Networks or VISNs.

Chronic hepatitis C virus (HCV) infection is the most common blood-borne infection in the world. Complications that result from untreated HCV infection include progressive liver damage leading to cirrhosis, primary cancer of the liver, liver failure and death. Although many of these complications are treatable or even preventable, three-quarters of the individuals with HCV infection in the U.S. are unaware they are infected. VA leads the country in <a href="hepatitis">hepatitis</a> screening, testing, treatment, research and prevention.

The Hepatitis C-ALD dashboard further advances the vision for quality care and improved access to care identified in VA's <u>Blueprint for Excellence</u>. # Support Extension Of Agent Orange Act (HR 3423)

Time is Running Out for Agent Orange Act. Congressman Tim Walz (MN) recently introduced the FRA-supported "Agent Orange Extension Act," (H.R. 3423) which would extend by two years the original sunset deadline of the Agent Orange Act of 1991 to ensure that Vietnam veterans exposed to Agent Orange receive just compensation and care. The Act expires on September 30, 2015 and the legislation would extend the sunset to September 30, 2017. FRA warned the House and Senate Veterans Affairs Committees regarding the sunset of the Act during its March 18, 2015 testimony.

The Agent Orange Act of 1991 (AOA) established a presumption of service connection for diseases associated with Agent Orange exposure, relieving Vietnam veterans from the burden of providing evidence that their illness was a result of military service. This law directs the the National Academy of Sciences (NAS) to periodically research and review diseases that might be associated with Agent Orange exposure. The VA is required to add diseases the NAS finds to have a positive association to Agent Orange exposure to the VA's list of presumptive service connected diseases. Since the enactment of the AOA, the NAS has issued reports that have led to the presumption of service connection for diseases such as Parkinson's, B-cell leukemia and early onset peripheral neuropathy. Without these studies, thousands of Vietnam era veterans would have gone without the benefits they greatly deserve.

If the AOA expires before the final report is issued, the VA would no longer be obligated to review the NAS report or add any new diseases to the presumption of service list, in the process denying thousands of veterans their right to compensation.

Members are urged to use the Action Center to ask their Representative to support this important legislation.
