# This-N-That

The Veterans Affairs administration spent \$20 million on expensive artwork and sculptures amidst the healthcare scandal, where thousands of Veterans died waiting to see doctors.

Then the VA goes and spends another \$670K on two art sculptures for center for BLIND Vets.

Honestly, I believe art work does make for a better healing environment, but why not go to up and coming fresh artists where their work is far cheaper? And why is artwork more important than Veterans Healthcare?

The one thing I have found over the years from countless Veterans is they love art work make by school kids! It makes them smile, even laugh and laughter in most cases is the best medicine around. So why didn't the VA go to the schools?

They could have offered an art contest with three levels of prizes, first, second and third places with a cash prize of \$500 for first, \$250 for Second and \$100 for Third and saved millions of dollars and still had art work on display.

Reaching out to the schools from elementary to high school they could have had both paper art as well as sculptures.

But instead they have placed the value on a Veterans life. While they were out buying up millions of dollars in art work, over 1,000 Veterans died waiting. With just those two numbers that comes to \$20.6 million dollars and a value of \$20,670.00 per Veteran life lost while waiting for medical care.

Then former Marine Brandon Ketchum, 33, killed himself only a few hours after being turned down at the Iowa City VA Medical Center on July 7th. He made an emergency appointment with the facility and spoke to doctors about his struggle.

When someone reaches out knowing they need help, what on earth is going through the heads of Medical care providers when they turn one of our finest away?

What ever happened to their oath "first do no harm?" Is turning away a Veteran in need doing no harm? HELL NO! To me it's saying the usual "suck it up" and "move on!" Or in other words, go on and kill yourself, problem solved!

Totally sickening to me! As with the art work and non verbally placing a value on a Veterans life, this too is placing a ZERO value on this Veterans life.

When each of you enlisted into the military, you each wrote a blank check for an amount up to and including your life! And the VA and our Government are all taking advantage of that and cashing in on those checks by NOT providing medical care and benefits in a timely manner.

Isn't this mass genocide of all our Veterans at the hands of the VA and our Government?

How many more lives is it going to cost before they stand tall and answer for their criminal activities?

And now there is a strong push on privatizing the VA and this is NOT the answer. The VA has the strongest buying power in the country which seriously helps keep costs down, privatizing will only drive costs sky high and making the VA have tougher guidelines on when they will authorize medical care due to high costs and budgetary constraints. Do you honestly want wait times and approvals to put you further into limbo, make you wait even longer?

## VA 'Choice' Update

The Department of Veterans Affairs' (VA) <u>Veterans Choice Program</u> (VCP) has reached a key milestone by scheduling two million appointments through the program. The network now has over 350,000 providers and facilities. VA has partnered with Congress to improve the community care experience by: (1) removing the enrollment date requirement for Choice; (2) implementing criteria of 40-mile driving distance from medical facility with primary care physician; (3) implementing the unusual or excessive burden criteria; and (4) expanding the episode of care authorization from 60 days to up to one year. Appeals Court will not give Blue Water Navy day in court

Today the United States Court of Appeals for the District of Colombia Circuit denied our appeal brought on behalf of the Blue Water Navy Vietnam Veterans Association to seek judicial review of the irrational "boots on the ground" policy. The appeal dealt solely with jurisdictional issues and did not reach the merits of the case. The three Judge panel ruled that our sole remedy was via the Veteran's Judicial Reform Act. A separate case has been brought under that law and is pending in the United States Court of Appeals for the Federal Circuit.

Although this decision is obviously a setback, Military-Veterans Advocacy and the Blue Water Navy Vietnam Veterans Association are continuing to address the issue judicially and in Congress. Finding a jurisdictional loophole in the Veterans Judicial Reform Act was always considered a long shot, but one worth taking. Although we are disappointed we are not discouraged and intend to push forward.

I have taken on a number of Blue Water cases and I am becoming concerned as I read the submissions by certain VSOs. I would recommend engaging an attorney for the appeal. Although I am not accepting new cases right now, I do suggest you contact Hill and Ponton. I work closely with them. Their number is 844-415-2025. #### Female Veteran Suicide Prevention Act

The Female Veteran Suicide Prevention Act was recently signed into law by President Obama. It requires the Department of Veterans Affairs (VA) to identify which VA mental health care and suicide prevention programs are most effective for women Veterans and those having the highest satisfaction rates among women Veterans. ### Employment Preference for Gold Star Families

The Office of Personnel Management has issued a new guidance detailing how the parents of deceased or disabled veterans can now claim veterans' preference. A new law amends the veteran preference statute to include both parents of deceased or permanently disabled veterans instead of the previous version of the law, which extended preference only to the mother of a veteran. Veterans' preference promotes eligible veterans for civil service jobs over other applicants based on their military service. The new guidance allows the parent of a deceased or permanently disabled veteran to claim their preference if: (1) the spouse of that parent is permanently disabled or (2) the parent is unmarried or legally separated when the preference is claimed. The agency is currently updating relevant print materials and website pages to accommodate the new changes.

#### FREE AFFIDAVIT PRODUCES NUMEROUS STATE COURT VICTORIES

Since 1987, the individual state and commonwealth family law systems have been presumptuously using disabled veterans' disability compensation benefit awards in establishment calculations for child support. The U.S. Supreme Court held in *Rose v. Rose 481 U.S. 619 (1987)*: "A state court has jurisdiction to hold a disabled veteran in contempt for failing to pay child support, even if the veteran's only means of satisfying this obligation is to utilize veterans' benefits received as compensation for a service-connected disability."

However, that wasn't all that the *Rose* decision had to say regarding this domestic relations nightmare that a large percentage of disabled vets unfortunately experience sooner or later. The good news is that after the noted 1987 deficiencies cited in that high court ruling, U.S. Congress, under the leadership of President Reagan, went to work and actively legislated to preclude disabled veterans from having to endure the consequences of the *Rose* verdict by establishing the new presidential cabinet level Department of Veterans Affairs and passing the **Veterans Judicial Review Act of 1988** (VJRA). A few years later, they repealed 38 U.S.C. § 211, engrossed § 511 in its place, and finally, oversaw the 1998 implementation of *Information Memorandum IM-98-03* entitled *Financial Support for Children from Benefits Paid by* **Veterans Affairs** promulgated by the Commissioner of the Federal Office of Child Support Enforcement (OCSE) and as directed by the Secretary of Health & Human Services. And with that, *Rose v. Rose* was abrogated but only if the disabled veteran had knowledge of the active legislation.

However, because of congressional financial incentive laws, i.e. 42 U.S.C. §§ 658a & 655, the various states and commonwealths have stubbornly refused to read past the first page of the 1987 *Rose* holding. In doing so, they have also deviously, through their conspiring and abdicating state family law attorney associations, denied veterans due process in their family court hearings and proceedings. In 2014 after enduring years of contentious child support battles with the state of Texas and sensing that my federal civil rights had been ignored even though I had paid handsomely for legal representation, I began to seek answers with a small group of fellow disabled veterans also forced to abide by similar

adversarial edicts. After several years of intense reading and research, I devised the *Parsons Due Process Affidavit (PDPA*) which assures that all the veteran's civil rights are asserted before the family court.

The PDPA is offered freely to all my "Disabled Vet Child Support Info" Facebook group members, established June 2015 with current membership totaling over 850, in a Microsoft WORD Template file. Recent court victories utilizing notarized PDPAs have been realized in Pennsylvania, North Carolina, Florida & Illinois. #### A Lot to Learn on New Transgender Policy

The U.S. World War I Centennial Commission and the Pritzker Military Museum and Library have announced a new program to help people across the country restore and preserve local World War I memorials. 100 Cities/100 Memorials is a fund-matching program in which groups or individuals can: (1) identify local World War I memorials; (2) put together a conservation treatment proposal for a memorial in distress; (3) submit their plan for consideration for matching grant funds; and (4) have the memorial treated by an accredited conservator, with communication help and possible matching funds. ## Prosthetic lab walk-through at Boston VA facility

The MyVA Advisory Committee (MVAC) took a tour of the prosthetics lab at the Jamaica Plain VA facility in Boston. Certified prosthetist Eric Lydon showed the group different types of prosthetics he has been working on, and the process they go through when using enhanced technology to meet a Veteran's needs.

After the demonstrations for the MVAC group, Lydon was nice enough to give our digital media team a walkthrough of the laboratory. He gives us a brief step-by-step of how the staff in the lab would create a prosthetic for a Veteran. The process starts with a negative cast and ends with a diagnostic mold.

## Commission on Care Chairwoman Discusses Veteran Health Equity and the VHA Health Equity Action Plan

The <u>Commission on Care</u> Chairwoman in a recent interview discusses Veteran health equity and the <u>VHA Health</u> <u>Equity Action Plan</u>. The Commission released its final report on June 30, 2016. Included in the 18 recommendations is a call for the elimination of health disparities. The Commission makes the following recommendation:

Recommendation #5 – Eliminate health care disparities among veterans treated in the VHA Care System by committing adequate personnel and monetary resources to address the causes of the problem and ensuring the VHA Health Equity Action Plan is fully implemented.

- VHA work to eliminate health disparities by establishing health care equity as a strategic priority.
- VHA provide the <u>Office of Health Equity</u> adequate resources and level of authority to successfully build cultural and military competence among all VHA Care System providers and employees.

- VHA ensure that the <u>Health Equity Action Plan</u> is fully implemented with adequate staffing, resources, and support.
- VHA increase the availability, quality, and use of race, ethnicity, and language data to improve the health of minority veterans and other vulnerable veteran populations with strong surveillance systems that monitor trends in health status, patient satisfaction, and quality measures.

#### Navy Improves Medical Records System

The U.S. Navy Bureau of Medicine and Surgery (BUMED) recently created its new Navy Medicine Records Activity (NMRA) detachment. The NMRA ensures timely transfer of service treatment records (STRs) to the VA within 45 calendar days in support of Navy veterans filing a VA claim. Following separation or retirement, these records become a component of the veteran's health care documentation. A complete STR includes all serviceprovided medical and dental documentation, civilian-provided medical and dental documentation, a printed copy of the servicemember's electronic health record file, and a Service Treatment Record Certification (DD Form 2963).
