### ***This-N-That***

In 2014, the Phoenix branch of the Department of Veterans Affairs became ground zero for the national health care rationing wait list scandal that rocked the federal agency. In response, both President Obama and the department's bureaucrats pledged to implement reforms that would fix the problems that led to thousands of the nation's Veterans being denied timely medical treatment, where hundreds died waiting for appointments without ever receiving any care.

This summer, Steve Cooper, a 45 year old Veteran seeking care for Stage 4 prostate cancer, secretly recorded his encounter with VA medical staff at a recently opened regional branch of the VA in the greater Phoenix metropolitan area.

I'm staying on top of them and cramming this information down their throats the best I can so they can't sit back and claim "oh, I'm sorry, I had no idea!"

Then we have the 388-acre West Los Angeles campus and dealing with the Homeless Veterans in Los Angeles.

I and many others have written about this issue over the past few years, McDonald made a "special appearance" along with huge promises the problem would be resolved. And here we are some two plus years later and nothing.

They have historical buildings which need updating and some TLC and others still being leased out to private elitist entities of Brentwood which are supposedly coming to a resolution to get them out. But still Donna Beiter has not shown where all that revenue went.

She personally made it extremely difficult for homeless to even enter the property especially when seeking help in housing, food, medical care and more.

In my humble opinion, the director of this facility is far more evil and vile than Hillary Clinton when it comes to our nations Veterans, their care, and compassion for their needs.

And I've said for many years now, she, as well as all other old guard administrative staffs nationwide need to go. Bring in people who are truly compassionate, caring, and willing to do what ever it takes to take care of those who took care of us.

So please, help us to help you, and those who are or may contemplate suicide, help us to force that twenty-two suicides down to ZERO by making the calls, getting on their websites and sending the same message, and if you have a fax machine, fax their DC office and send a letter to their local office demanding this be brought to an immediate halt. Help us to help save lives!

If we keep putting pressure on them, WE can all help force change!

### ***Almost a Million Expected for 'Blended' Retirement***

More than 740,000 currently serving active duty members and 176,000 drilling Reserve and National Guard personnel are expected to opt in to the new BRS, or Blended Retirement System, when the choice becomes available in 2018 to military members with fewer than 12 years' service. The opt-in estimates are the product of a "dynamic retention" computer model developed by RAND Corporation and used to predict how personnel will react to a new retirement choice. The BRS was designed by the Military Compensation and Retirement Modernization Commission and approved by Congress last year after lawmakers tweaked a few features. ## ***NDAAs Negotiations Yield Modest Results***

Following their first meeting since returning from the summer recess, the leaders of the House and Senate Armed Services committees see progress toward a compromise defense policy bill, but no timeline for a final resolution.

The 'Big Four,' the chairmen and ranking committee members who met Thursday, have said they hope to finish the National Defense Authorization Act before the start of the new 2017 fiscal year on Oct. 1, but a slew of policy and funding issues still remain unresolved in reconciling the House and Senate bills."

"Negotiators are still wading through a morass of issues on the must-pass bill, including major overhauls of the Pentagon's acquisition system, command structure and military health system - all different in the House and Senate bills. Lawmakers also haven't solved the most contentious issue - whether to tap the Pentagon's war account to fund base defense priorities."


### ***Battle Tested Veterans Offers Podcasts***

### ***Reimbursement Policy Changes***

The Defense Activity for Non-Traditional Education Support (DANTES) Exams Reimbursement Program will no longer physically process any paper-based reimbursement mail received after Oct. 1. The policy change includes reimbursement of test fees for the following exams: (1) GED (beginning October), (2) GMAT, (3) GRE General and GRE Subject, (4) Praxis Core and Praxis Subject Assessment, and (5) ACT and SAT. Service members will now use the online Electronic Reimbursement Request on the DANTES [website](#) to receive reimbursement. Members should select "Examinations and Reimbursement Eligibility" to get started. A valid common access card (CAC) is required.

### ***Defense Bill Considered Again***

For the third time Senate Democrats again blocked the Pentagon spending bill from advancing to the floor.

You may recall that Senate Democrats back in July voted twice to block floor consideration of the annual Pentagon spending bill. The Senate returned from recess Tuesday, and Democrats once again blocked a procedural motion to advance the measure ([HR 5293](#)).

There is plenty of blame on both sides of the aisle as the majority continues to offer the bill with non-germane additions which they know Democrats will not support such as cutting more funding from Planned Parenthood.

According to Democrats, the vote, 55-43, is not a reflection of opposition to the bill's contents so much as a tactical gambit. Holding defense spending hostage gives leverage, they say, in negotiations to secure as much domestic spending as possible in a fiscal 2017 appropriations package. Tuesday's blockade of the defense measure is the latest sign that new fiscal 2017 spending initiatives are not likely to move forward before the November elections.

### ***Hearing Held on Commission on Care Recommendations***

The House Veterans' Affairs Committee held hearing on Wednesday to examine The Commission on Care and the Future of the VA Healthcare System.

Nancy Schlichting, chair and Dr. Delos (Toby) M. Cosgrove, vice chair for the VA Commission on Care testified that their report calls for creation of a "fully integrated care system," which would leverage private sector care providers who fully understand the needs and experiences of veterans would be able to provide care in a system that integrates that care with that provided by VHA providers.

They also recommended the VA transform its internal processes, including information technology, supply chains, and personnel management. In addition, the commission recommended eliminating the geographic and wait time constraints on veterans obtaining care in the private sector.

### ***Veterans Day Parade Expands***

The nation's largest Veterans Day parade in New York City — America's Parade — is making its way to the West Coast. On Nov. 11, Los Angeles will host its first America's Parade while New York City will celebrate its 97th. The Veterans Day parade on both coasts will commemorate the 15th anniversary of 9/11 with special recognition to post-9/11 veterans and first responders, and it will honor the 25th anniversary of Desert Storm. ### ***Obama Sets Troop Pay Raise at 1.6 Percent in 2017***

President Barack Obama on Wednesday [set the military pay raise at 1.6 percent for next year](#). The figure is higher than the 1 percent increase he approved for civilian employees in the federal government but lower than the 2.1 percent bump service members are supposed to receive under the formula in current law. The change to monthly basic pay will take effect Jan. 1 and marks the fourth straight year troops will see their pay raise fall short of private sector-wage growth.

## ***TRICARE Policy on Appointments***

A no-show occurs when a patient misses a TRICARE appointment without making any attempt to cancel or reschedule 24 hours in advance. Your provider may charge you because you did not show up for your appointment. The fee can range from \$20- \$40 and is not covered by TRICARE. It is best to keep your appointments or reschedule them at least 24 hours in advance. If you are being seen at a military hospital or clinic, you can do this through [TRICAREOnline](#), which is available 24 hours a day, 7 days a week. You can use this portal to set appointment notifications and set up email and text message reminders.

## ***VA Proposes Presumptive Diseases Connected to Camp Lejeune Water***

The Federal Register issued a "public inspection document" on Thursday (which it does the day before any rule is published), which indicates VA is proposing a presumptive rule of service connection for eight conditions for those who served at Camp Lejeune for no less than 30 days from August 1, 1953 through Dec. 31, 1987.

"In addition, VA proposes to establish a presumption that these individuals were disabled during the relevant period of service, thus establishing active military service for benefit purposes. Under this proposed presumption, affected former reservists and National Guard members would have veteran status for purposes of entitlement to some VA benefits." The conditions covered include (1) kidney cancer; (2) liver cancer; (3) Non-Hodgkin's lymphoma; (4) adult leukemia; (5) multiple myeloma; (6) Parkinson's disease; (7) aplastic anemia and other myelodysplastic syndromes; and (8) bladder cancer. ## ***VA Launches Vet Employment Program***

The Department of Veterans Affairs (VA) has launched the [Veterans Employment Pay for Success \(VEPFS\) Program](#). The grants program is designed to help Veterans with a service-connected disability such as post traumatic stress disorder (PTSD) secure meaningful and sustained employment. Pay for Success programs are different because the payout occurs only after a rigorous evaluation determines that the pre-agreed-upon outcomes have been achieved. The VA is thus paying for what works. Pay for Success program is the first of its kind to be attempted at VA. ## ***Keeping Your TRICARE Coverage at Age 65***

By taking a few simple steps, retirees can make sure they have their TRICARE benefits after they turn 65. Four months before your 65th birthday, you will receive a postcard from the Defense Manpower Data Center (DMDC) with information about keeping TRICARE coverage after age 65. Be sure to sign up for Part B no later than two months before your 65th birthday. If you do not receive a postcard from DMDC, call them at 1- 800- 538-9552. You must have Medicare Part A and Medicare Part B to be eligible for TRICARE For Life. TRICARE For
