### ***NAUS Letter to Senate Majority Leader and Armed Services Chairman***

This week NAUS sent a letter to Senate Majority Leader Sen. Mitch McConnell (R-KY) and Armed Services Chairman John McCain urging passage of a provision in the Veterans First Act (S. 2921) to assure eligibility of the Fry Scholarship education benefits for survivors who lost their loved one in the early days of the Iraq and Afghanistan wars.

Currently, public law (passed in 2015) cuts off Fry Scholarship eligibility 15 years from the date of a service member's death for surviving spouses. Unless action is taken, survivors who lost their spouses in the early days of the wars will not have complete access under the Fry Scholarship program. For example, if a service

member died in service in April 2002 his surviving spouse would have until 1 April 2017 to use the Fry Scholarship.

### ***Congress to be Busy Next Week***

Congress returns for the second-half of its lame-duck session next week. Expectations are for a short session, but lawmakers will have to get some key bills done before the new Congress convenes in January.

The biggest in the defense world is the National Defense Authorization Act, which could move as early as next week. The final touches are still being put on the conference report, which will need to be signed by the House and Senate conferees.

Congress also needs to pass a spending bill to keep the government running past the December 9 deadline. The plan is to approve a continuing spending resolution through the end of March, so the Trump administration can have a say in the fiscal 2017 appropriations process.

### ***Grass Roots Veterans Movement Wants a Veteran as VA Secretary***

Led in part by veterans pushing for legislation to provide Agent Orange benefits to those who served in the bays, harbors and territorial seas of Vietnam, many veterans are expressing their disapproval of likely VA Secretary Congressman Jeff Miller, R-FL. Miller, who is not a veteran, has served as the Chairman of the House Veterans Affairs Committee since 2011.

Concurrently with Miller's tenure, the veterans caused legislation to be introduced to extend the presumption of exposure to the territorial seas of the Republic of Vietnam. Miller has repeatedly failed to hold hearings on the bill despite increased support in Congress. The current version of the bill, HR 969, has 335 co-sponsors.

"We need a veteran in charge of the VA," said Susie Belanger the wife of a Navy veteran who volunteers for the Blue Water Navy Vietnam Veterans Association and Military-Veterans Advocacy ". With all due respect to Congressman Miller, a candidate with a military background or the inner workings of the VA would make a strong advocate for this position. We currently have tens of thousands of veterans dying from Agent Orange, but he has refused to even hold a hearing."

Support for the top spot within the VA has coalesced around retired Navy Commander John B. Wells, a retired surface warfare officer who is also an attorney practicing military and veterans law. For the past six years, Wells has been the lead advocate for the Blue Water Navy and, along with Belanger, has led the charge for these veterans. He currently serves as the unpaid Executive Director of Military-Veterans Advocacy. In this capacity he travels frequently to Washington to advocate on veterans issues. He has also filed suits against the VA to force the VA to grant benefits to veterans.

Wells has criticized attempts to legislate accountability in the VA. "This is a management problem, not a Congressional problem," Wells said, "You cannot set up a separate civil service system for the VA. Instead you have to provide a consistent disciplinary policy and hire competent attorneys to prosecute cases before the Merit Systems Protection Board."

Wells also criticized proposed appellate reform legislation. "It does not solve the problems. Instead it strips due process from the veterans making it easier for the VA to deny meritorious claims." Wells provided extensive written testimony against the proposal last June including a blueprint for true appellate reform.

Wells has been endorsed by several veterans organizations and periodicals. A facebook page "Make John Wells Secretary of the Department of Veterans Affairs" attracted 1400 members in less than a week. Over 200 people, most of them veterans, have sent letters of support to the Presidential Transition team. Wells stated his priorities are:

1. Restructure the culture at the Department of Veterans Affairs to make it "veteran friendly" with an emphasis on service rather than bureaucracy.
2. Emphasize outreach to veterans to ensure they are aware of their rights and benefits.
3. Working in concert with the National Academy of Sciences become proactive in the identification of diseases and disabilities unique to or connected with military service.

4. Work with Congress to ensure that funding is available to compensate and treat veterans who suffer disease or disability due to military service.

Wells intends if appointed to concentrate on the following specific items:

1. Exempt service connected mandatory benefits from the offset provisions of the Pay As You Go Act of 2010.
2. In concert with the Veterans Service Organizations conduct a baseline review of Title 38 of the Code of Federal Regulations to streamline the benefits program.
3. Establish a Merit Systems Protection Board unit consisting of attorneys with MSPB litigation experience at the General Counsel's Office to manage employment termination decisions.
4. Promulgate a disciplinary policy with consistent and specific guidelines for punishment.
5. Establish a center of excellence to research effects of toxic exposure on vets and descendants. Investigate all issues concerning toxic exposure and contract as necessary for expert assistance. Retain on a permanent basis the Committee to Review the Health Effects in Vietnam Veterans of Exposure to Herbicides and expand its mandate to include all toxic exposures including but not limited to Gulf War disease and Burn Pit exposure.
6. De-emphasize the use of standard forms within the VA and emphasize personal contact between the VA staff and the veterans they serve.
7. Assign Ombudsmen, who are veterans, to each Regional Office and medical facility.
8. Revise job descriptions for VA raters to require military medical experience.
9. Require that the VA maintain a centralized database at an existing facility to identify health trends among veterans and their descendants and refer them as appropriate to the National Academy of Sciences for further study.
10. Immediately extend the presumption of Agent Orange exposure to veterans of the Blue Water Navy, Guam, Johnston Island, Thailand, Laos, Cambodia, Panama and Korea during the time Agent Orange was present.
11. Appoint a Chairperson of the Board of Veterans Appeals acceptable to the Veterans Service Organizations, the VA and the Congress. The BVA has been without a Chairperson for 5 years.
12. Decertify Veterans Law Judges with an excessive controllable remand rate.
13. Require all Veterans Law Judges to be Administrative Law Judges.
14. Incorporate pre-hearing conferences and scheduling orders in consonance with the practice in the federal administrative adjudication system.
15. On an interim basis, contract with retired Military Judges, after training in VA law, to hold regional hearings on veterans appeals until the 450,000 person backlog is eliminated.
16. Reconstitute and expand the VA Inspector General program.
17. Adopt the Industry Standard "Epic" medical records program for both VA and DOD.
18. Digitalize all records and phase out the centralized mailing system in favor of a digitalized intake system which can be accessed by VSOs and veterans law practitioners.

Emergency refill procedures are in place through December 11, 2016. To get an emergency refill, take your prescription bottle to any TRICARE retail network pharmacy. To find a network pharmacy, call Express Scripts at 1-877-363-1303 or search the [network pharmacy locator](#). If possible, visit the pharmacy where the prescription was filled. If you use a retail chain, you can fill your prescription at another store in that chain. If your provider is available, he or she may call in a new prescription to any network pharmacy. You can request assistance at another pharmacy, but it is at that pharmacy's discretion to help you.

### ***VA Online Scheduling System to go Live in January***

Veterans will initially be able to schedule primary care appointments by using a new app. And in the future VA officials plan to add optometry, audiology and mental-health.

The U.S. Department of Veterans Affairs plans in January to begin online scheduling of medical appointments nationwide.

With the program, the VA will schedule primary-care appointments for more than 6 million patients through an app on their phones, tablets or computers.

VA officials also plan to add appointments for optometry, audiology and mental-health.

Neil Evans, MD, chief of the office of connected care for the Veterans Health Administration said the move will be “a huge step forward” for the VA. “I think this is really, really, really important for us to be able to offer.”

Kathleen Frisbee, executive director for connected health at the VA’s office of connected care, added that the new software will open in the agency’s health system for more public inspection as patients view open appointments and choose which times are best for them with the click of a computer mouse. “I mean, we are exposing our availability to the world,” Frisbee said.

Initially VA developers planned to offer online requests for appointments rather than actual scheduling.

But vets who use the VA’s online portal, called MyHealtheVet, advocated for actual do-it-yourself online scheduling, Evans said. In fact, online scheduling was the most requested item of vets using the VA’s online portal.

The portal software cost \$3.2 million, and runs on technology infrastructure from Agilex Technologies, now Accenture Federal Services, and the VA’s internal development.

### ***Law Gives Federal Employees Who Are Disabled Vets Extra Leave***

Under the Wounded Warriors Federal Leave Act of 2015, disabled veteran leave will be available to any federal employee hired on or after Nov. 5, 2016, who is a veteran with a service-connected disability rating of 30 percent or more. Disabled veteran leave is available as a one-time benefit during a 12-month period beginning on an eligible employee's first day of employment and may not exceed 104 hours for a regular full-time employee. Disabled veteran leave can only be used for undergoing medical treatment of a qualifying service-connected disability which was incurred or aggravated in the line of active duty. While current federal employees who were hired before Nov. 5, 2016, are not eligible for disabled veteran leave, the federal government offers a wide range of leave options and workplace flexibilities. ### ***Open Enrollment for Healthcare Begins***

It is the time of year when people can enroll in or change their health insurance plan at [HealthCare.gov](http://HealthCare.gov). The open enrollment period is November 1, 2016 to January 31, 2017 for 2017 coverage. Most TRICARE beneficiaries do not need to worry about open enrollment. However, for beneficiaries who are not eligible for TRICARE coverage, have lost or are losing coverage, or may qualify to purchase a TRICARE premium-based health plan ([TYA](#), [TRR](#), [TRS](#) or [CHCBP](#)), they can use this open enrollment period to see if there are other health coverage options that work best for them and their family.
