### Do you – or should you? – CARE about President Elect Trump's Selection of Secretary of Veterans' Affairs?

If there's a single thing Donald Trump just proved to the world, it's that the voice of the American People CAN be heard, and he's the man to hear it. Consider the way Trump punctuates every single rally with pauses to listen to the audience. Consider how he responds to this or that person, smiling warmly, welcoming the love, but absolutely welcoming the input. Consider how, doing a town hall or a TV talk show like Hannity, when asked a question, Trump so often turns it around and asks the audience what they think – AND THEN LISTENS! Consider how many detractors and attackers upon exiting Trump Tower after meeting him for the first time all comment on the copious questions he asks, and how intently he listens.

We might multiply the examples. But the one example that matters most is that

by showing America he listens, he won the election.

All that is my way of saying, by all means and ABSOLUTELY YES, you SHOULD care about his selection of Secretary of Veterans' Affairs. Clearly, it's the single most important posting, and that's why it's taking so much longer than all the rest. Clearly, it's the most demanding challenge. Nearly impossible. Clearly, it's the most important stain upon America's character. Clearly, it's the one problem that, if we fail to solve it, we'll keep ourselves weak in the face of a world that will NOT tolerate weakness.

Although I have thoughts about who should be selected, I'm honestly NOT qualified myself, personally, to recommend someone, but I know someone who is. His name is Jim Davis, and you'll read his recommendation below. My purpose is NOT to recommend anyone, but rather to urge that you care, and that if you do feel you know who to recommend, you MUST find your voice to speak, to speak boldly and strongly and to be as certain as you can that your voice is heard. I have a thought for you about that.

There are many ways to speak. Social Media is mighty. Letters to editors of News Papers are powerful. Letters and calls to your Congressman and Senator are really, really important. The thing is, time is short now, and if your voice is to be heard, it must be heard NOW. For that, there is – to my observation – one and only one MOST powerful medium: Talk Show Radio...and let's be clear, LOCAL TALK SHOW RADIO. No, NOT the national shows with the famous star hosts, those are often impossible to access. Rather, it is your small, local station, the one where the host often has the line open, hoping someone will call with a topic, that's where the power is.

There are many reasons, but allow me to share just this one. All local talk show hosts are active participants in our society. They all have contacts. They all report up the food chain as to what's going on. Also, especially during the morning commute, talk show radio has greater reach than any other medium in America. It has more listeners than there are readers, and that includes web sites and TV. It is, and likely will remain the most powerful medium of political and social influence in America

Last point. Let's imagine that some of you agree with Jim Davis' recommendation below. Let's imagine you persuade a few others and find your local station, call in, and there's a ground swell around one candidate. My prediction is that just two days of such coordinated and focused effort would make it's presence, it's unstoppably powerful presence known to the Trump Transition Team's decision makers. Your voice will be heard. And with that, I turn it over to my friend Jim. You can know he knows; his counsel is worth your deepest consideration!
