I'd like for you all to be fully mindful of the conditions of any exam room or hospital room, and if able, take pictures with your cell phone as evidence.

If we can keep this in the media then we're making everyone both Veterans and Civilians alike aware of the type of conditions you are subjected to and maybe it will help encourage many others to be vocal about it, and encourage them to be in contact with their Reps in DC and demanding change.

And if willing, please write to me and send me

the pictures as well and I will make darn sure it's included in the weekly fax blast to all 535 members of Congress.

A couple of days ago we sent out a special release where an Army Vietnam Veteran, James Rabuse is asking for help from any and all sources as his wife Betty Hidalgo-Rabuse has been quite ill and in the hospital for some time now and was diagnosed with stage 4 cancer.

Unfortunately the account link sent with that release was plagued with problems and it took some time for the Go-Fund me to effect repairs, proper links to accounts etc.

Down further in this newsletter is another posting for those who would like to help, and the link has been tested and found to be correct now.

Some of you may remember that Betty was the Director of our Operation Mail Call Program for nearly six and a half years working tirelessly every week, getting socks, t-shirts, personal

care items, DVD's, Joke/gag gifts all donated and would spend hours baking cookies and fudge to put into the packages.

And she did all this out of love for our Troops and using her own money, all we did was ask people to send in cards and letters to be included in the packages which went out weekly.

You may not know Betty personally, but she is our hero and helped to put smiles on hundreds and hundred of our active duty service men and women.

The original plan was to get enough people to help so that James could buy a small used RV so he could fulfill the one wish Betty had, which was to travel.

They have a rented home in Atwater, but Betty has been transferred to a really good Cancer Treatment Hospital in San Francisco, so the more urgent need is to help cover travel and meals for James since he has to travel back

and forth from Atwater to San Francisco, and also needs help covering medical bills which the amount not covered by insurance is running \$1,600.00 per month.

Betty has lost quite a bit of weight due to the cancer, and was just put on a liquid diet on Thursday and is doing relatively well so far, the doctors goal is to get her to gain back some of the weight she has lost before continuing on with other medical treatments. So she will be hospitalized for a while, and this is why James needs your help.

## Veterans: You May Be Missing Disability Rating Upgrade Opportunity

Many medically-discharged veterans who had their disability rating "low-balled" by their service branch may be missing out on an opportunity to have their disability upgraded. In 2009 Congress mandated that a Physical Disability Board of Review (PDBR) be formed to reevaluate the disability ratings of up to 71,000 veterans. ## **H.R. 5467, the Purple Heart and Disabled Veterans Equal Access Act of 2018**

On April 11, 2018, Congressman Daniel Lipinski (IL), introduced H.R. 5467, the Purple Heart and Disabled Veterans Equal Access Act of 2018.


Access to the Department of Defense (DoD) commissary stores and Morale, Welfare & Recreational (MWR) retail facilities is currently limited to active duty service members and dependents, Guard and reservists, military retirees, certain surviving spouses of deceased service members and veterans rated at 100 percent permanently disabled. In November 2017, the Secretary of DoD granted online access to MWR retail facilities to all honorably discharged veterans.

This legislation, H.R. 5467, will expand eligibility to physical commissary stores and MWR retail facilities to veterans awarded the Purple Heart, Medal of Honor recipients, former prisoners of war, veterans with a service-connected disability and caregivers of certain veterans.

DAV supports this legislation as it is in agreement with DAV Resolution No. 222, to expand commissary privileges to all service-connected veterans. Please use the prepared electronic letter or draft your own to urge your Member of Congress to support and cosponsor H.R. 5467.

Standing up for veterans is vital and we appreciate your advocacy. Your actions help make DAV a highly influential and effective organization in Washington. Thank you for all you do for America's ill and injured veterans and their families.

## **Vietnam Veteran whose wife Diagnosed with Stage 4 Cancer Needs help!**



Hello my name is James Rabuse. I am a Vietnam Era Veteran. I am retired on SSI and Disability. I come to you with some bad news and just ask for prayers and help as my wife Betty is going through a lot of pain

Betty and I were married on May 27, 2017. About a month ago Betty took seriously ill, and was transferred from Atwater, CA to a Hospital in San Francisco, CA where they diagnosed her with stage 4 cancer. As you know travel, gas to and from the hospital, room and, board, and parking fees gets costly. In order for my wife to get the best possible care while she is still here, this treatment needs to get done.

Betty has been a very active Veteran volunteer being director of Operation Mail Call for Veterans-For-Change after losing her son's father in the Vietnam War, then she also lost her oldest grandson to the Afghanistan War.



## **Report: At Least 126 Bases Report Water Contaminants Linked to Cancer, Birth Defects from the Military Times**

The water at or around 126 military installations contains potentially harmful levels of [perfluorinated compounds](#), which have been linked to cancers and developmental delays for fetuses and infants, the Pentagon has found.

In a March report provided to the House Armed Services Committee, the Pentagon for the first time [publicly listed the full scope](#) of the known contamination. The Defense Department identified 401 active and Base Closure and Realignment installations in the United States

with at least one area where there was a known or suspected release of perfluorinated compounds.

These included 36 sites with drinking water contamination on-base, and more than 90 sites that reported either on-base or off-base drinking water or groundwater contamination, in which the water source tested above the [Environmental Protection Agency's acceptable levels](#) of perfluorooctane sulfonate or perfluorooctanoic acid, also known as PFOS and PFOAs.


The man-made chemicals, which can be used to make items heat or water resistant, are found in everyday household, food and clothing items, even take-out food wrappers.







## **MilCon/VA Spending Bill approved by Subcommittee**


The House Appropriations, Military Construction, Veterans Affairs (VA), and Related Agencies Subcommittee approved its portion of the FY2019 spending plan. This is the first subcommittee to approve its portion of the budget. The still unnumbered bill strengthens oversight and accountability at the Departments of Defense and VA. Several provisions include: requiring rigorous reporting on the status of VA claims processing, and the development of the VA electronic health record, and oversight of large construction projects that are managed outside of VA.

The bill provides a total of \$10.3 billion for military construction projects—an increase of \$241 million, or 2.4 percent above the enacted FY2018 level. Specifically, the bill provides \$1.6 billion to fund construction, operation and maintenance of military family housing for FY2019. This is \$173 million above the FY2018 level matching the Administration's budget request. The funding will ensure quality

housing is sustained for all 1,400,000 military families currently served by the program.

The bill also includes \$361 million for construction and alterations for new or existing military medical facilities. This funding will allow for continued support and care for 9.8 million eligible beneficiaries. The bill will now go to the House Appropriation Committee for further consideration. FRA will continue to monitor the appropriations process to ensure adequate funding of FRA supported programs.

## **New Pain-Blocking Technology Available at 40 VAMCs, Coming to Dozens More**

TREA: The Enlisted Association got a presentation this week from BioWave Corp., a Health Technology company that delivers "Smarter Pain Blocking Technology™." Its patented, FDA-approved medical device technology is now in use at 40 U.S.

Department of Veterans Affairs Medical Centers (VAMCs) nationwide. This includes five of the 19 VA Centers of Innovation (COINs), which lead the charge in specific areas of patient care.

The technology, which works on roughly 85 percent of people who try it, is a non-opioid, non-addictive technology that can cut opioid use by as much as 50 percent, while resulting in a greater range of motion and dexterity than while on a drug regimen.

It delivers therapeutic signals through the skin into deep tissue, blocking pain signals at the source using electrodes that look like a TENS device.


With opioid addiction being such a huge societal problem, anything that would reduce Americas, and veteran, use of the addictive alternative has to be considered a good thing.

The Air Force is continuing its rollout of the Alpha Warrior program with the launch of the 2018 Alpha Warrior Meet and Greet Tour in April. Alpha Warrior challenges Airmen as they tackle the various obstacles or stations around a unique apparatus. This year's tour introduces the fitness initiative to Airmen at 27 Air Force. Tour stops are typically two days. Installations are receiving either a battle rig (a 27-foot competition rig) or battle station (a 12-foot by 12-foot training rig) based on the desires of local leadership. Training on how to use the Alpha Warrior equipment is expected to launch in May and take place at 35 installations. ## Support H.R. 5452, Reduce Unemployment for Veterans of All Ages Act of 2018

On April 10, 2018, Congresswoman Julia Brown (CA), introduced H.R. 5452, the Reduce Unemployment for Veterans of All Ages Act of 2018.

Currently, veterans with service-connected disabilities or other employment challenges are

able to receive career development services through the VA's Vocational Rehabilitation and Employment program up to 12 years after they separate from military service. H.R. 5452 would eliminate the 12-year-period of eligibility.

In accordance with DAV Resolution No. 250, we support this legislation to eliminate the 12-year-period of eligibility. By removing the limited eligibility, H.R. 5452 will provide veterans the flexibility to receive the support they have earned and deserve throughout their lifetime and thus help reduce unemployment for service-connected veterans.

## **TREA: The Enlisted Association to Amtrak - Reinstate the Veterans' Advantage Discount**

Amtrak announced back in March that they were discontinuing the Veterans' Advantage discount, which gives active duty military, retired military, veterans and their families a 15% discount on the price of an Amtrak ticket.

In the past, Amtrak had a long history of supporting the military; its previous President had a goal of making 25% of all new hires veterans back in 2015, and they unveiled a veteran-themed locomotive for its Northeast routes.

Amtrak has offered these discounts for 17 years, making the decision to discontinue them all the more puzzling as the US has become involved in counter-terror operations across the globe over the last decade and a half.

It is not just veterans, however, that have seen their discount programs go away. Students and AAA have also seen cuts from Amtrak's new

President, while disabled customers have seen their discounts reduced from 15% to 10% and the age requirement for seniors has been raised to 65.

Amtrak also recently announced a 25% cancellation fee on Acela business class and reserved coach tickets that are canceled 24 hours or more after booking and prior to departure.



## Six Reasons to Continue Serving

Here are financial incentives to continue serving in the Guard or Reserve: (1) reserve retirement can provide a powerful boost to your financial security; (2) continuing to serve can open your eligibility for TRICARE Reserve Select (TRS); (3) it might offer you an opportunity to save big money by opting out of your civilian employer's health coverage; (4) once you sign up for Medicare, you will switch to TRICARE for Life and will not need Medicare Supplement Insurance; (5) you will continue to be eligible for \$400,000 of Servicemembers' Group Life Insurance coverage; (6) continuing to serve also affords you the opportunity to earn monthly drill pay along with active-duty pay for annual training; and (7) you will still have an ID card that will allow you to use a nearby installation's PX/BX, commissary, MWR and other money-saving services. ## **PDBR Review of Disability Claims Continues**

The Physical Disability Board of Review (PDBR) was created by the FY2008 Defense Authorization Act (NDAA) to reassess the accuracy and fairness of combined disability ratings of 20 percent or less for service members who were separated from service, rather than medically retired because of medical conditions. In order to be eligible for a PDBR review, service members must have been medically separated between September 11, 2001, and December 31, 2009, with a combined disability rating of 20 percent or less, and found ineligible for retirement. According to Military.com, only 19,000 of the more than 71,000 eligible have requested a review of their claim. The PDBR claims that more than half of reviewed claims have been upgraded to a disability rating of 30 percent or more.

This review panel is authorized to recommend an increase in a disability rating, uphold the

previous finding, or issue a disability rating when the previous board did not assign one. The board, however, is NOT able to recommend a lower rating. Eligible veterans can request a board review by submitting Department of Defense Form 294, Application for Review of Physical Disability Separation from the Armed Forces of the United States. 

## MIA Update

The Defense POW/MIA Accounting Agency has announced identification and burial updates for nine American service members who had been missing in action from WWII and Korea. Returning home for burial with full military honors are:

**Marine Corps Reserve 1st Sgt. David H. Quinn**, 24, of Temple, N.H., whose

identification was previously announced, will be buried May 5 in his hometown. Quinn was assigned to Company C, 2nd Amphibian Tractor Battalion (C-2d Amp Tr Bn), 2nd Marine Division. On Nov. 20, 1943, Quinn's unit landed on the small island of Betio in the Tarawa Atoll against stiff Japanese resistance. Quinn was killed on the second day of the battle, one of approximately 1,000 Marines and sailors killed in the intense fighting. [Read about Quinn.](#)

**Marine Corps Reserve Cpl Raymond A.**

**Barker**, 22, of Evanston, Ill., whose identification was previously announced, will be buried May 5 in Delavan, Wis. Barker was assigned to Company C, 2nd Tank Battalion, 2nd Marine Division. On Nov. 20, 1943, Barker's unit landed on the small island of Betio in the Tarawa Atoll against stiff Japanese resistance. Barker was killed on the first day of the battle, one of approximately 1,000 Marines and sailors killed in the intense fighting. [Read about Barker.](#)

**Marine Corps Pfc. Harold V. Thomas**, 21, of Columbus, Ohio, whose identification was previously announced, will be buried May 7 in Arlington National Cemetery, near Washington, D.C. Thomas was a member of Company F, 2nd Battalion, 2nd Marine Regiment, 2nd Marine Division. Thomas's unit was one of those tasked with securing the small island of Betio in the Tarawa Atoll. Encountering fierce resistance by the Japanese, almost 1,000 Marines and sailors were killed and another 1,000 were wounded in the battle. Thomas was killed on the first day of the battle, Nov. 20, 1943. [Read about Thomas.](#)

**Army Pfc. Billy R. Ball**, 20, of Matthews, Mo., whose identification was previously announced, will be buried May 4 in St. Louis. Ball was a member of Headquarters Detachment Philippines Department, when Japanese forces invaded the Philippine Islands on Dec. 8, 1941. After months of intense fighting, Corregidor fell and American forces surrendered on May 6, 1942. Ball was one of the thousands of U.S. and Filipino service

members taken prisoner and eventually moved to Cabanatuan POW camp. More than 2,500 POWs perished in this camp during the remaining years of the war. According to prisoner records, Ball died on Sept. 28, 1942, and was buried along with fellow prisoners in the local Cabanatuan camp cemetery. [Read about Ball.](#)

**Army Cpl. Terrell J. Fuller** was a member of Company D, 1st Battalion, 38th Infantry Regiment, 2nd Infantry Division, supporting Republic of Korea Army attacks against units of the Chinese People's Volunteer Forces in an area known as the Central Corridor in South Korea. After enduring sustained enemy attacks, the American units withdrew to Wonju, South Korea. It was during this withdrawal that Fuller was reported missing as of Feb. 12, 1951. Interment services are pending. [Read about Fuller.](#)

**Army Sgt. 1st Class Rufus L. Ketchum** was a member of Medical Detachment, 57th Field Artillery Battalion, 31st Regimental Combat

Team, 7th Infantry Division. In late November 1950, his unit was assembled with South Korean soldiers in the 31st Regimental Combat Team (RCT) on the east side of the Chosin River, North Korea, when his unit was attacked by Chinese forces. Ketchum was among more than 1,000 members of the RCT killed or captured in enemy territory and was declared missing on Dec. 6, 1950. Interment services are pending. [Read about Ketchum.](#)

**Army Pfc. Oscar E. Sappington** was a member of 3rd Platoon, Company C, 1st Battalion, 309th Infantry Regiment, 78th Infantry Division. On Jan. 10, 1945, the 309th Infantry launched a number of attacks in the Hürtgen Forest of Germany. At some point during the two days of action, Sappington stepped on a landmine. Though he was mortally wounded, no soldiers from his unit could reach him during the vicious fighting to render aid or confirm his death. He was reported missing in action as of Jan. 11, 1945. Interment services are pending. [Read about Sappington.](#)

**Army Pvt. Kenneth D. Farris** was assigned to Company B, 22nd Infantry Regiment, 4th Infantry Division. On Nov. 28, 1944, Farris was wounded by artillery and left the front line for the battalion aid station. His regiment remained in combat for several more days, reaching the outskirts of Gey, Germany, before being pulled off the front line. When officers took an accounting of the surviving Company B soldiers, Farris could not be found. Interment services are pending. [Read about Farris.](#)

**Marine Corps Pfc. William F. Cavin** was assigned to Company F, 2nd Battalion, 8th Marine Regiment, 2nd Marine Division, Fleet Marine Force. On Nov. 19, 1943, Cavin's unit landed on the small island of Betio in the Tarawa Atoll against stiff Japanese resistance. Cavin was killed on the first day of the battle, one of approximately 1,000 Marines and sailors killed in the intense fighting. Interment services are pending. [Read about Cavin.](#)





## **S. 2356, Stronger Medical Workforce Act**

Senator Jon Tester, Ranking Member of the Senate Veterans' Affairs Committee introduced S. 2356, the Stronger Medical Workforce Act—a bill that calls for better access to Department of Veterans Affairs (VA) health care services for rural and underserved communities. VA reports there are currently 33,000 staff vacancies in the health care system. Tester, concerned about Montana's chronic difficulty in recruiting qualified medical personnel, introduced legislation to specifically help fill vacancies in rural areas and other areas classified as underserved.

This bill directs the VA Secretary to create new criteria that define "underserved" specific to VA and to establish a plan to address each facility that meets such criteria. Each plan would


address how a facility will address increasing personnel or use temporary personnel including mobile deployment teams, use of special hiring incentives and direct hiring authorities. In addition the bill would authorize a pilot program to support tuition reimbursement and loan repayment for health care clinicians who agree to work in underserved VA facilities for a specified length of time. The bill would also draw from the Public Health Service Corps, enlisting 500 officers to work within VA facilities. Finally, it would allow Vet Center employees to qualify for VA's education debt reduction program.

DAV supports this bill in accordance with Resolution 230, which calls for sufficient resources for VA to improve health care in rural areas and Resolution 112, to ensure timely access to quality VA care. Help advocate for real improvements at VA's underserved facilities by using the prepared letter to ask your Senators to cosponsor and support S. 2356, the Stronger Medical Workforce Act.



# Long Medical Delays for Pacific Island Vets

According to the Government Accounting Office (GAO), it takes between 37 and 75 days for veterans in the Pacific islands to receive medical attention and mental health care from defense facilities. These services are provided by the Department of Veterans Affairs Pacific Islands Health Care System (VAPIHCS) to approximately 50,000 veterans who live Hawaii, American Samoa, Guam and the Northern Mariana Islands. GAO found that some of the veterans experienced delays related to the processing of their enrollment applications, contacting them to schedule appointments and completing comprehensive mental health evaluations. The bureaucratic delays were compounded by an acute shortage of medical professionals. For more information, read the [GAO report](#).

## **State Veterans Home Construction Grants**

The Department of Veterans Affairs (VA) recently announced that it will use \$685 million in funding from Congress to fund several State Veterans Home construction projects through the VA State Veterans Home Construction Grant Program. The new funding can be used where needed for repairs, renovation or new construction. The program provides up to 65 percent of the cost to build and renovate facilities. Plans for the new funding include at least 52 projects including bed replacement projects. This is the largest appropriation in the more-than 50-year history of this program.


