I hope everyone had a really great Thanksgiving day with family and friends!

I've heard from so many who live near military bases who made it a point to invite a few from the bases who either have not family or were not able to go home for Thanksgiving and for that I thank you!

This has been a long standing tradition in our family since 1970 while dad was still active duty, and since his passing we've continued his tradition and some, like our family also made a place setting for all those who didn't make it home and all those whom we've lost.

The VA has taken some pretty serious steps toward improving their website, making it easier to get to information needed all based on a survey of which 5,000 Veterans took part in.

The VA website is actually a series of websites all linked together and it always was an intense challenge to find what you were looking for, now it's supposedly streamlined and easier, so if you have had the opportunity to use the site in the last 30 days, I'd like to hear your opinions!

Our volunteers are constantly accessing it on a daily basis, still having issues with finding appeals that were approved finally, but maybe down the road they will improve and realign that site too.

The VA is now claiming a 5% reduction in homeless Veterans over last year. Well they're close by our numbers collected from agencies and groups all across the country it's more like 2.85% reduction but their number of 40,000 is still extremely way off and we're still not even sure how they manage to come up with such a low number when we're still seeing numbers of 1.45 million.

Many cities are claiming they've resolved the homeless Veteran problem, when fact is they've successfully managed to chase them off into another city making it their problem.

And those who are actually trying to solve the problem are constantly running into the problem of "not in my

neighborhood!" Most not even thinking of how more secure their neighborhoods would be with Veteran living there!

Decades after the Vietnam War ended, the children of soldiers who served say they continue to struggle grapple with the impact of Agent Orange exposure.

The new report, released Thursday by The National Academies of Sciences, Engineering, and Medicine, specifically looked into generational health effects of dioxin after a special request from the VA.

Hopefully, the VA will pay attention, and follow through on something we've all known for decades then actually begin to take care of the children of Veterans who served in Vietnam!

We've been pushing for many weeks now for HR 299 which as you recall passed the House 382 to Zero and got bogged down in the Senate because the VA Administration is fighting tooth and nail to provide the earned, much needed medical care and benefits and from what we've seen is all based on outdated and bad science all to save a buck, but to save a buck at the cost of human lives.

So again, we're asking everyone, including our civilian readers to please call the following people and ask that they bring HR 299 to the floor and vote to pass it in the Senate.

#### **Korean War Remains Uncovered Inside DMZ**

This past week, South Korea's defense ministry announced that five sets of remains from the Korean War had been unearthed during demining operations around the Cheorwon area, in the vicinity of Arrowhead Hill. This recent discovery brings the total number of remains unearthed in this area since Oct. 1 to nine. This effort is the result of a joint agreement signed between North Korea and South Korea to remove weapons and munitions along the 155-mile long Demilitarized Zone that separates the two Koreas, and to identify and return any remains that are recovered in the process. Currently, there are 7,675 Americans who remain unaccounted for from the Korean War and more than 133,000 South Koreans.

changes, you do not have to do anything. If you have the
TRICARE Retiree Dental Program(TRDP), provided by
Delta Dental, and want dental coverage in 2019, you will

If you miss open season, you'll only be able to make enrollment changes within 90 days of a Qualifying Life Event or during the next TRICARE Open Season in fall 2019. 
**Military Recruiting Drops 7 Percent** 

Recruiting statistics released by the Department of Defense last week reflect a 7 percent overall decrease in accessions for fiscal year 2018. In the Active Component, the Navy, Marine Corps, and Air Force met or exceeded their goals of 39,000; 31,556; and 29,450, respectively, while the Army was more than 6,500 soldiers short of their goal of 76,500. It was the first time since 2005 that the Army did not meet its goal. In the Reserve Component, only the Marine Corps Reserve and Air Force Reserve met or exceeded their goals of 8,990 and 5,282, respectively. The Navy Reserve came in 421 sailors short of their goal of 7,097. The Air National Guard was 870 airmen short of their 9,659 goal. The Army Reserve was 4,273 soldiers short of their goal of 15,600, and the Army National Guard was more than 9,700 short of their goal of 34,629 soldiers. Quoted in a Stars and Stripes article, Maj. Gen. Joe Calloway, the Army's military personnel management director, blamed the Army's shortfall largely on a strengthening U.S. economy in which fewer potential recruits are looking for jobs. Only about 30 percent of 17 to 24-year-olds can meet the mandatory requirements for consideration for military service — a combination of physical, mental, and background attributes. According to the Pentagon, only about 13 percent of that target population is even interested in military service. Read more.

The Department of Veterans Affairs (VA) has revamped its website, which is accessed by 10 million customers per month. The new website contains homepage content that focuses on the top 20 tasks that 80 percent of VA's customer's need, the ability to login to receive a personalized experience and easy to understand plain language content. Logged in customers will find a dashboard summarizing the current status of services they receive from VA, whether they be prescription refills or claims. 

**Exchange Extends Return Policy** 

The Army & Air Force Exchange Service is extending its return policy for items purchased between Nov. 1 and Dec. 24. The Exchange's standard policy allows returns from 15 to 90 days after purchase with a sales receipt or online order confirmation depending on the item. The holiday return policy extends these terms through Jan. 31. Veterans who have registered to shop online at ShopMyExchange.com can use the extended holiday return policy. They can return ShopMyExchange.com merchandise purchased between Nov. 1 and Dec. 24 by mail or by calling 1-800-527-2345 for assistance through Jan. 31.

#### **TRICARE Prime and Select Open Season**

TRICARE has kicked off its first open season where Prime and Select beneficiaries can enroll in or change their health care coverage plan for 2019. The open season period will last from now until Dec. 10 and any changes made during this period will become effective on Jan. 1, 2019. If you are satisfied with your current plan, then your coverage will continue automatically for 2019, as long as you remain eligible for coverage. **New Diabetes Guidelines for Veterans** 

For the millions of veterans with diabetes, the Department of Veterans Affairs (VA) and the Department of Defense (DoD) are implementing new guidelines calling for the patient, their family, and their health care team to share information and decisions. A Shared Decision Making (SDM) encounter occurs when the patient, his loved ones and the health care team discuss together what treatment options best address the patient's goals. In 2017, Department of Veterans Affairs and the Department of Defense recognized the important role SDM plays in managing diabetes when they updated their Clinical Practice Guideline for the Management of Type 2 Diabetes Mellitus in Primary Care. #### **New Navy Cash Cards Available**

The NAVSUP FLC Norfolk Navy Cash Fleet Support Group completed a year-long effort to re-card the ships of the Atlantic Fleet to new Navy Cash Cards in October. The Navy Cash card is a branded debit card that looks like a typical debit or check card. Navy Cash combines a chip-based electronic purse with the traditional magnetic stripe. The electronic purse replaces currency aboard ship. The process allows Sailors to continue to have the capabilities of the Navy Cash Card, but now includes the ability to receive an electronic receipt for each transaction off ship. Additionally, Sailors will now be offered access to several thousand additional ATMs worldwide.

VA Moving Hundreds of Professionals Back to Healthcare Jobs

The U.S. Department of Veterans Affairs has announced that it has moved nearly 430 medical professionals from taxpayer-funded union work back to health care jobs serving veterans. The move looks to improve VA's ability to deliver health care to veteran patients, and took effect Nov. 15 when VA repudiated certain provisions of master collective bargaining agreements with the following unions: American Federation of Government Employees, National Federation of Federal Employees, National Association of Government Employees and National Nurses United. The repudiation will apply to all of VA's nearly 104,000 title 38 employees.

#### **TRDP and FEDVIP Update**

The current TRICARE Retiree Dental Program (TRDP) will end Dec. 31, 2018, and will be replaced by the Federal Employees Dental and Vision Insurance Program (FEDVIP) dental coverage options. Vision plans will also be available to eligible TRICARE beneficiaries through FEDVIP. The first opportunity to enroll in FEDVIP is during the 2018 Federal Benefits Open Season, which began on Nov. 12, 2018, and runs through Dec. 10, 2018. Coverage begins on Jan. 1, 2019. In general, retired uniformed service members and their families who were eligible for TRDP in 2018 are eligible for FEDVIP dental coverage, and if enrolled in a TRICARE health plan, FEDVIP vision coverage, beginning in 2019. Family members of active-duty uniformed service members who are enrolled in a TRICARE health plan are eligible for FEDVIP vision coverage. Learn more.

This week, the Defense POW/MIA Accounting Agency announced eight new identifications, and the burial date and location for 11 previously identified servicemen.

Returning home with full military honors are:

**Army Cpl. Francisco Ramos-Rivera**, 33, of Puerto Rico, whose remains were previously identified, will be buried Nov. 29 in San Juan, Puerto Rico. Ramos-Rivera was a member of Company H, 2nd Battalion, 19th Infantry Regiment, 24th Infantry Division, engaged in combat

operations against North Korean forces near Taegon, South Korea. As U.S. forces regrouped after their evacuation, Ramos-Rivera could not be accounted for and was declared missing in action on July 20, 1950. Read about Ramos-Rivera.

Army Pvt. Robert J. Sipes, Jr., 19, of Irvington, Ky., whose remains were previously identified, will be buried Dec. 5 in his hometown. Sipes was a member of Company L, 3rd Battalion, 7th Cavalry Regiment, 1st Cavalry Division. He was killed in action on Nov. 30, 1950, during heavy fighting between the Chinese People's Volunteer Forces and the 7th Cavalry Regiment near the village of Unsan, North Korea. His remains were processed through a 7th Cavalry Regiment Collection Station on Dec. 1, 1950, and interred at the United Nations Military Cemetery (UNMC) Pyongyang, on Dec. 2, 1950. Read about Sipes.

Army Air Forces 1st Lt. Eugene P. Ford, 21, of Latrobe, Pa., whose remains were previously identified, will be buried Dec. 4 in Arlington National Cemetery, near Washington, D.C. Ford was a member of the 765th Bombardment Squadron, 461st Bombardment Group, 15th Air Force. On Dec. 17, 1944, Ford's B-24J, known as the Tulsamerican, led a group of six B-24s on a bombing mission targeting oil refineries at Odertal, Germany. After emerging from a cloud bank near the target, the aircraft were attacked by more than 40 German Me-109 and FW-190 fighters. Three of the six aircraft were shot down and the other three suffered damages. Ford's plane was heavily damaged, forcing him to abort the mission and crash land

in the Adriatic Sea near the Isle of Vis in present-day Croatia. Seven crewmembers survived and were rescued, but Ford and two others were killed in the crash. Read about Ford.

Marine Corps Reserve Staff Sgt. Richard J. Murphy, Jr., 26, of Chevy Chase, Md., whose remains were previously identified, will be buried Dec. 1 in Silver Spring, Maryland. Murphy was a member of 6th Marine Regiment, 2nd Marine Division, which landed at Red Beach, Saipan. Reports provide little information of what happened to Murphy after landing on Saipan, and he was declared missing in action as of June 15, 1944. On May 22, 1945, his status was amended to killed in action. Read about Murphy.

Marine Corps Pfc. Clarence E. Drumheiser, 21, of Fresno, Calif., whose remains were previously identified, will be buried Dec. 8 in Prairie View, Texas. Drumheiser was assigned to Company D, 1st Battalion, 6th Marine Regiment, 2nd Marine Division, Fleet Marine Force. On Nov. 19, 1943, Drumheiser's unit landed on the small island of Betio in the Tarawa Atoll against stiff Japanese resistance. Drumheiser was killed on the third day of the battle, one of approximately 1,000 Marines and sailors killed in the intense fighting. Read about Drumheiser.

Navy Fireman 1st Class Bert E. McKeeman, 25, of Council Bluffs, Iowa, whose remains were previously identified, will be buried Dec. 1 in his hometown.

McKeeman was assigned to the USS Oklahoma, which was

moored at Ford Island, Pearl Harbor, on Dec. 7, 1941, when the ship sustained multiple torpedo hits and quickly capsized, resulting in the deaths of 429 crewmen, including McKeeman. Read about McKeeman.

Navy Fireman 2nd Class Martin A. Gara, 20, of Chicago, whose remains were previously identified, will be buried Dec. 4 in Santa Fe, N.M. Gara was assigned to the USS Oklahoma, which was moored at Ford Island, Pearl Harbor, on Dec. 7, 1941, when the ship sustained multiple torpedo hits and quickly capsized, resulting in the deaths of 429 crewmen, including Gara. Read about Gara.

Navy Seaman 1st Class William G. Bruesewitz, 26, of Appleton, Wisc., whose remains were previously identified, will be buried Dec. 7 in Arlington National Cemetery, near Washington, D.C. Bruesewitz was assigned to the USS Oklahoma, which was moored at Ford Island, Pearl Harbor, on Dec. 7, 1941, when the ship sustained multiple torpedo hits and quickly capsized, resulting in the deaths of 429 crewmen, including Bruesewitz. Read about Bruesewitz.

Navy Fireman 2nd Class Carl D. Dorr, 27, of Anderson, S.C., whose remains were previously identified, will be buried Dec. 7 in Greenville, S.C. Dorr was assigned to the USS Oklahoma, which was moored at Ford Island, Pearl Harbor, on Dec. 7, 1941, when the ship sustained multiple torpedo hits and quickly capsized, resulting in the deaths of 429 crewmen, including Dorr. Read about Dorr.

Navy Fireman 1st Class Albert U. Kane, 26, of Fort

Worth, Texas, whose remains were previously identified, will be buried Dec. 7 in Dallas. Kane was assigned to the USS Oklahoma, which was moored at Ford Island, Pearl Harbor, on Dec. 7, 1941, when the ship sustained multiple torpedo hits and quickly capsized, resulting in the deaths of 429 crewmen, including Kane. Read about Kane.

Navy Aviation Machinist's Mate 2nd Class Durell Wade, 24, of Calhoun City, Miss., whose remains were previously identified, will be buried Dec. 7 in the Mississippi Veterans Memorial Cemetery, in Newton County, Miss. Wade was assigned to the USS Oklahoma, which was moored at Ford Island, Pearl Harbor, on Dec. 7, 1941, when the ship sustained multiple torpedo hits and quickly capsized, resulting in the deaths of 429 crewmen, including Wade. Read about Wade.

Marine Corps Reserve Pfc. Nicholas J. Gojmerac was a member of Company Q, 4th Raider Battalion, 1st Marine Raider Regiment, when his unit assaulted a Japanese stronghold at Bairoko Harbor, New Georgia Island, Solomon Islands. He was reported missing in action on July 20, 1943, after he was last seen crawling through heavy fire to provide medical care to an injured Marine while he was mortally wounded himself. Interment services are pending. Read about Gojmerac.

Navy Reserve Aviation Machinist's Mate 1st Class John O. Morris was a member of Carrier Aircraft Service Unit (CASU) 17 and was tasked with securing the small island of Betio in the Tarawa Atoll. In November 1943, U.S.

personnel on the island encountered fierce resistance by the Japanese, and almost 1,000 Marines and sailors were killed, and another 1,000 were wounded in the battle. On Dec. 16, 1943, Morris was killed when a machine gun he was test-firing accidentally discharged, resulting in his death. Interment services are pending. Read about Morris.

Army Pfc. Leo J. Duquette a member of Company L, 3rd Battalion, 21st Infantry Regiment, 24th Infantry Division, engaged in combat operations against North Korean forces near Choch'iwon, South Korea. Duquette could not be accounted for and was declared missing in action on July 11, 1950. Interment services are pending. Read about Duquette.

Army Pfc. John W. Martin was a member of Medical Company, 32nd Infantry Regiment, 7th Infantry Division. In late November 1950, his unit was assembled with South Korean soldiers in the 31st Regimental Combat Team on the east side of the Chosin River, North Korea, when his unit was attacked by Chinese forces. Martin was among more than 1,000 members of the RCT killed or captured in enemy territory and was declared missing on Dec. 2, 1950. Interment services are pending. Read about Martin.

Army Pfc. Lewis E. Price was a member of Company E, 2nd Battalion, 109th Infantry Regiment, 28th Infantry Division. In November 1944, his unit moved into the Hürtgen Forest in Germany, to relieve U.S. forces who had been fighting for weeks. The fighting in and around the forest was frequently chaotic, and while details surrounding

his loss are sparse, he was reported missing in action as of Nov. 6, 1944. Interment services are pending. Read about Price.

Navy Reserve Ensign Charles M. Stern was stationed aboard the USS Oklahoma, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft on Dec. 7, 1941. The battleship sustained multiple torpedo hits, which caused it to quickly capsize. The attack on the ship resulted in the deaths of 429 crewmen, including Stern. Interment services are pending. Read about Stern.

Navy Machinist's Mate 1st Class Ulis C. Steely was stationed aboard the USS Oklahoma, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft on Dec. 7, 1941. The battleship sustained multiple torpedo hits, which caused it to quickly capsize. The attack on the ship resulted in the deaths of 429 crewmen, including Steely. Interment services are pending. Read about Steely.

Navy Electrician's Mate 3rd Class Charles H. Harris was stationed aboard the USS Oklahoma, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft on Dec. 7, 1941. The battleship sustained multiple torpedo hits, which caused it to quickly capsize. The attack on the ship resulted in the deaths of 429 crewmen, including Harris. Interment services are pending. Read about Harris.
