# **Blue Water Navy Bill Update**

VFW National Commander B.J. Lawrence met yesterday afternoon with Sen. Mike Enzi (R-Wyo.), who earlier this week blocked the passage of H.R. 299, the Blue Water Navy Vietnam Veterans Act of 2018, because he believes it costs too much. "If we can afford to send our military to war, it's unacceptable that we cannot afford to take care of them when they return home wounded, ill or injured," said Lawrence, who called the meeting very productive. "I met with Senator Enzi to make it clear that VFW members expect the Blue Water Navy to pass before the end of the year. The senator assured me that he wants to provide Blue Water Navy veterans the benefits they have earned and is working with his colleagues, including Senate VA Committee Chairman Johnny Isakson, to get this bill passed. I told him the VFW will work with him to make it happen, but we will hold him accountable if it does not," he said. "We also met with key staff for Senate Majority Leader Mitch McConnell (R-Ky.) and Sen. Mike Lee (R-Utah) to let them know that the VFW wants the Senate to pass H.R. 299 now!" # VVA Condemns Obstruction of "Blue Water Navy" Bill by Sen. Enzi

(Washington, D.C.) -- "It is beyond disappointing that a single senator, Mike Enzi (R-WY), has obstructed H.R. 299, Blue Water Navy Vietnam Veterans Act, a bill that was passed in the U.S. House of Representatives by a vote of 382-0 and would assuredly pass in the Senate if the members of that body were given the opportunity to vote on it," said John Rowan, VVA National President.

On Monday, December 10, Sen. Kirsten Gillibrand (D-NY) brought up the Blue Water Navy bill on the floor of the Senate. When she asked for unanimous consent, it was the senior senator from Wyoming, chairman of the Senate Budget Committee, who objected, citing cost concerns and saying that it would cause "budgetary and operational pressures that would happen at the VA."

Earlier this year, VA Secretary Robert Wilkie voiced opposition to the legislation, reversing an earlier commitment by his predecessor, Dr. David Shulkin, to "do the right thing."

"Congress is only too glad to throw money, and lots of it, at the Department of Defense for questionable programs, citing the need for a strong defense," said Rowan. "The Senate is being prevented from 'doing the right thing' for a relative handful of veterans who served with honor in the waters off the coast of Vietnam and are now hurting from effects of exposure to Agent Orange."

"Contrary to the VA's assertions, we have the

science that shows the pathways of exposure to this insidious herbicide. So we endorse the sentiments of two legislators, a Republican senator and a Democratic congressman, who make the case for passing this long-needed legislation."

"This is an issue of justice," said Senator Steve Daines (R-MT). "This is an issue of bureaucracy, frankly, not doing the intent of what Congress was, when it was originally passed. And this would clarify that so that we can make sure these vets get the benefits they deserve."

"All too often," said Rep. Tim Ryan (D-OH), "members of this Congress are willing to pay lip service to the sacrifices our military and military veterans make, then fall into the trap of playing politics when there's a chance to actually do something to help them."

This year's bill would add improvements for homelessness programs, transition assistance, Veteran-owned small businesses, student Veterans, and many other beneficial proposals. Included in this package is the VFW-supported SIT-REP Act which would protect student Veterans from penalties due to delayed GI Bill payments. The VFW is glad to see Congress is still working to improve benefits for Veterans right up to the holidays, and we hope when they return from their break after the new year they are ready to continue right where they left off, working for Veterans.

# VA Secretary Promises Full GI Bill Housing Benefits Payments

Department of Veterans Affairs (VA) Secretary Robert Wilkie issued the following statement on GI Bill Housing Benefit Payments: "To clear up any confusion, I want to make clear that each and every **post-9/11 GI Bill** beneficiary will be made 100 percent whole, retroactively if need be, for their housing benefits for this academic year based on Forever GI Bill rates and not on post-9/11 GI Bill rates. Although VA has encountered issues with implementing the Forever GI Bill on Congress' timeline, we will work with lawmakers to ensure that, once VA is in a position to process education claims in accordance with the new law, each and every beneficiary will receive retroactively the exact benefits to which they are entitled under that law."



# 2018 Tax Statement Release Schedule

2018 tax statements for military, retiree, annuitant and federal civilian employee customers serviced by the Defense Finance and Accounting Service will be distributed mid-December through January 2019.

The IRS tax forms will be available via myPay, the Department of Defense online pay account management system (https://mypay.dfas.mil/) for most of the 6.4 million DFAS customers. In many cases, the electronic online forms are available much earlier and more securely than those sent to customers electing delivery by mail.

DFAS continues to provide IRS Forms 1095-B or 1095-C for military, retiree and federal civilian employees who receive healthcare insurance coverage through the Tricare or Federal Employee Health Benefit programs.

# AF Reactivates 308th Fighter Squadron

The Air Force 308th Fighter Squadron was reactivated in a ceremony at Luke Air Force Base, Nov. 30. The squadron will house the Royal Netherlands Air Force's and the Royal Danish Air Force's F-35A Lightning IIs as part of a training partnership. With Lt. Col. Robert Miller assuming command, the fighter squadron is scheduled to begin operations in December, 2018. Throughout the next two years, the Dutch and the Danish air forces will be sending their jets to populate the squadron and help Luke AFB's mission of training the world's greatest fighter pilots. The 308th FS's goal is to train as efficiently as the rest of Luke AFB's fighter squadrons.




## Now is the Time to Get a Vote on Agent Orange Reform

The "Blue Water Navy Vietnam Veterans Act" (H.R. 299) has passed the House unanimously (382-0) and now is in the Senate Veterans Affairs Committee awaiting a vote. The proposal would clarify that service members serving off the coast of the Republic of Vietnam during the Vietnam conflict and those serving near the Demilitarized Zone (DMZ) in Korea have a presumption for filing disability claims with the Department of Veterans Affairs (VA) for ailments associated with exposure to the Agent Orange herbicide. The legislation will also extend health care, vocational training & rehabilitation and monetary allowance to a child who was born with spina bifida if at least one of the child's parents served in Thailand between January 9, 1962 and May 7, 1975 and had been exposed to a herbicide agent during that period. The bill also now includes changes and improvements to VA's home loan program.

Please use the FRA Action Center to ask your Senators not to delay any more in the closing days of the 115th Congress and pass H.R. 299 and send it to the President to sign into law."

## House Committee on Veterans' Affairs Examines VA Appeals Reform

The VFW attended a hearing on Wednesday of the House Committee on Veterans' Affairs to examine if VA is ready to implement the Veterans Appeals Improvement and Modernization Act of 2017. Implementation of the new law is set for February 2019 and aims to modernize the claims and appeals process by providing veterans multiple review options and shorter time for claim resolution. Recent problems with the rollout of the Forever GI Bill this fall prompted lawmakers to press VA on its IT capabilities related to these changes. "We're updating two critical VA systems, and we have actually had boots on the ground working very hard long before this bill passed," said Lloyd Thrower, VA's deputy chief information officer. The VFW submitted a statement expressing further concerns regarding VA's IT platforms, as well as their poorly executed "Informal Conference" option for Higher Level Review (HLR) claims. The VFW will continue to monitor the implementation of this law. Watch the hearing, learn more about changes to claims appeals.

# Navy Seeks Volunteers for Data Challenge

The Navy is launching its first Navy-wide Sustainment Data Challenge, and is seeking Navy workforce volunteers to form a challenge team that will develop solutions impacting the future of Navy readiness. The application period is open through Jan. 8, 2019. If interested in participating, organize and apply as a team by Jan. 8, 2019. Teams will attend a virtual kickoff event to gather context, rules, starting data sets and access to subject matter experts. Teams will submit checkpoint progress briefs as scheduled, and one of the checkpoints may be used to down-select amongst the teams. # SENATE KILLS BILL TO RESTORE BENEFITS TO VIETNAM-ERA NAVY VETERANS

Sen. Mike Enzi (R-WY) last night killed HR 299, the

Blue Water Navy Veterans Act, which would have restored Agent Orange benefits for Navy veterans who served in the harbors and coastal waters of Vietnam.

The bill passed the House of Representatives six months ago, and stalled in the Senate Veterans Affairs Committee. Department of Veterans Affairs officials also reversed course several months ago and withdrew support for the bill, citing the longterm cost of the benefits.

"While veterans are suffering and dying from exposure to Agent Orange, the VA is playing games," said Cdr. John Wells (USN, Ret.), who heads Military Veterans Advocacy and who has been working to pass the bill for years. "By changing cost estimates submitted to the Congressional Budget Office (CBO), the very agency charged with protecting veterans' interests has caused a huge setback in justice for these veterans."

Despite considerable work to find offsets for the cost of restoring benefits that were taken from Vietnam veterans in 2002, and despite broad, bipartisan support in the Senate, the bill is effectively dead for the year. "I urge the body to pass the Blue Water Navy bill by unanimous consent because this is about justice, this is about a bureaucracy making a decision and really not following the intent of this Congress. This is correcting something that was done wrong back in 2002," said Sen. Steve Daines (R-MT)

"There have been four different health studies by the C.D.C. about the detrimental effects of Agent Orange exposure, and the Blue Water Navy veterans have been shown to suffer those exact diseases (and) at the same rate of the other exposed veterans," said Sen. Kirsten Gillibrand (D-NY). "But some of my colleagues are wrongly insisting on a fifth study. We do not have another year to wait. Some of our veterans will not last that long. Many Blue Water veterans have already passed away from the disease associated with Agent Orange exposure. The 1991 bill to provide coverage for veterans exposed to Agent Orange didn't discriminate between those who served offshore and those who served on rivers or on the ground, yet due to a decision by a V.A. bureaucrat in 2002, the coverage for those who served offshore was wiped out. It doesn't make any sense, and we must help all our veterans."

"I am not giving up and Military Veterans Advocacy is not giving up," Wells said. "Not only will we seek passage of the bill again in the next Congress, but we are also taking this fight to court. As Sen. Gillibrand said last night, a bureaucrat's decision 16 years ago thwarted the intent of Congress. If Congress won't correct this egregious injustice, perhaps the federal courts will."

The Court of Appeals for the federal circuit appearing en banc heard arguments on the restoration of benefits last Friday, Dec. 7, in a case brought by Military Veterans Advocacy.

#### Mental Health Care Available Downrange

Deployed mental health providers help give medical care downrange. They give classes on sleep, work with units on basic stress management and provide one-on-one counseling or targeted interventions. One such intervention is the Combat Operational Stress Control program, which is only offered to deployed service members. This program delivers educational materials and gives first responders a chance to speak specifically about combat operational stress, over the course of four sessions. #### VA to Develop New Patient Safety Innovations

VA announced 10 Patient Safety Centers of Inquiry (PSCI) will receive funding to further research for innovative ways to improve patient safety. The PSCI program was developed in 1999 and has resulted in many current patient safety standards such as protocols to decrease patients falling, reducing infections, suicide prevention, moderate sedation techniques for non-anesthesiologists, and a cancer care tracking system. Currently, the program is headquartered in Ann Arbor, Mich., where the facility will spend the next three years focusing on the appropriate use of catheters and peripherally inserted central catheter lines. The nine other facilities awarded funding for this initiative will focus on improving outcomes, with a specific focus on medication safety, for patients going back and forth between VA and non-VA care; preventing diagnostic errors by improving timely follow-ups for abnormal test results; creating

automated risk-adjusted metrics that are adaptable to the diverse care settings across VA's health system; transitions for elderly veterans and those with complex conditions with a focus on testing 30day readmissions and patient satisfaction; identifying patients at high risk for adverse opioid events and monitoring opioid use to provide guidance on tapering opioid prescriptions and providing support networks for patients with opioid use disorders; prevention of adverse events related to mobility/immobility; practical solutions to reduce suicide among veterans not receiving VA care; and to test evidence-based programs to decrease suicide risk following psychiatric discharges. Another New Study Finds VA Outperforms non-VA Care A newly published study researched by Dartmouth College found VA mostly outperforms non-VA health care systems and facilities in their same regions when comparing mortality rates and patient safety. Researchers conducting the study compared data from VA hospitals against non-VA proximate facilities in 121 regions. In 14 out of 15 measures, or over 93 percent, results show VA performed significantly better. The study was initiated after Dr. William Weeks, a former VA employee who now works as a professor at Dartmouth Institute for Health Policy and Clinical Practice, was skeptical of multiple previous studies with results concluding VA hospitals outperform other medical systems. Dr. Weeks told reporters he felt compelled to further study the issue to compare data at a regional level compared to previous studies which focused on national level data. He also said that he wanted to research the regional perspective for veterans who might have the option to use their local VA facility or a non-VA facility nearby. Read more about the study.



#### Navy Exchange Offers Awards to Students

To find a network pharmacy, call Express Scripts at 1-877-363-1303, or search the network pharmacy locator. If possible, visit the pharmacy where the prescription was filled. If you use a retail chain, you can fill your prescription at another store in that chain. If your provider is available, he or she may call in a new prescription to any network pharmacy. You can request assistance at another pharmacy, but it is at that pharmacy's discretion to help you.

#### **MIA Update**

This week, the Defense POW/MIA Accounting Agency announced 13 new identifications. Returning home with full military honors are:

**Navy Capt. James R. Bauder** was an F-4B pilot assigned to Fighter Squadron Twenty One, USS Coral Sea, in South East Asia. On Sept. 21, 1966, during a night reconnaissance mission over North Vietnam, contact with Bauder's aircraft was lost and his plane did not return to the ship. An extensive search was conducted with negative results. Based on this information, Bauder was declared missing in action. Interment services are pending. Read about Bauder.

**Army Pfc. Karl L. Dye** was a member of Battery B, 52nd Field Artillery Battalion, 24th Infantry Division, engaged in combat operations against North Korean forces, near Taejon, South Korea. In July 1950, he was seriously wounded by an enemy mortar shell and placed in an ambulance. The ambulance allegedly encountered an enemy roadblock. Dye was reported missing in action on July 16, 1950. Interment services are pending. Read about Dye.

Army Air Forces 1st Lt. Allen R. Turner was a C-109 pilot assigned to the 1330 Army Air Force Base Unit, Air Transport Command. On July 17, 1945, during a routine flight from Jorhat, India, to Hsinching, China, over "The Hump," his aircraft crashed in a remote area. All four passengers were declared deceased after an extensive search effort failed to identify the crash site. Interment services are pending. Read about Turner. Army Pfc. Marvin E. Dickson was a member of Headquarters Company, 1st Battalion, 110th Infantry Regiment, 28th Infantry Division. On Nov. 13, 1944, while attempting to reestablish broken telephone communications lines between headquarters and outposts in the Hürtgen Forest in Germany, he and three others were attacked. Surviving members could not confirm Dickson's death, nor provide the location to where he was killed. He was listed as missing in action and on Nov. 14 his status was amended to killed in action. Interment services are pending. Read about Dickson.

Navy Seaman 2nd Class John C. Auld was stationed aboard the USS Oklahoma, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft on Dec. 7, 1941. The battleship sustained multiple torpedo hits, which caused it to quickly capsize. The attack on the ship resulted in the deaths of 429 crewmen, including Auld. Interment services are pending. Read about Auld.

Navy Water Tender 1st Class Edwin B. McCabe was stationed aboard the USS Oklahoma, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft on Dec. 7, 1941. The battleship sustained multiple torpedo hits, which caused it to quickly capsize. The attack on the ship resulted in the deaths of 429 crewmen, including McCabe. Interment services are pending. Read about McCabe.

Navy Electrician's Mate 3rd Class Roman W. Sadlowski was stationed aboard the USS Oklahoma, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft on Dec. 7, 1941. The battleship sustained multiple torpedo hits, which caused it to quickly capsize. The attack on the ship resulted in the deaths of 429 crewmen, including Sadlowski. Interment services are pending. Read about Sadlowski.

Navy Fireman 3rd Class Kenneth L. Jayne was stationed aboard the USS Oklahoma, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft on Dec. 7, 1941. The battleship sustained multiple torpedo hits, which caused it to quickly capsize. The attack on the ship resulted in the deaths of 429 crewmen, including Jayne. Interment services are pending. Read about Jayne. Navy Signalman 3rd Class Charles E. Nix was stationed aboard the USS Oklahoma, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft on Dec. 7, 1941. The battleship sustained multiple torpedo hits, which caused it to quickly capsize. The attack on the ship resulted in the deaths of 429 crewmen, including Nix. Interment services are pending. Navy Seaman 1st Class Camillus M. O'Grady was stationed aboard the USS Oklahoma, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft on Dec. 7, 1941. Navy Machinist's Mate 1st Class Fred M. Jones was stationed aboard the USS Oklahoma, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft on Dec. 7, 1941. The battleship sustained multiple torpedo hits, which caused it to quickly capsize. The attack on the ship resulted in the deaths of 429 crewmen, including Jones. Interment services are pending.
