#### **Combat-Related Special Compensation**

## Many vets missing out on money


Just because an Air Force veteran was not injured storming the beaches at Normandy does not mean he or she may not be entitled to receive Combat-Related Special Compensation.

Many Air Force veterans may be missing out on hundreds, if not thousands, of dollars every month because they have not applied for the compensation, said Ann Lacey of the CRSC office at the Air Force Personnel Center here.

"Don't let the term 'combat' throw you; there are many circumstances which are combat related that could justify approval of extra tax-free money for you!" she said.

CRSC is designed to restore military retirement pay that has been offset by Department of Veterans Affairs compensation when evidence exists to confirm the associated disabilities are combat related. For example, if a veteran is currently rated for a disability of 10 percent with the VA, he or she receives a check from the VA for \$115 each month, but his or her retired pay is reduced by that same amount. If that disability is found to be combat-related by the CRSC review board, he or she would continue to receive the monthly check from the VA for \$115 along with the remainder of the retired pay, but begin to receive an additional monthly check from CRSC for \$115.

Many disabilities that resulted from conditions during



peacetime may meet the criteria for CRSC, said Ms. Lacey. As examples she cites an aircraft mechanic who works on the flight line and begins to lose his hearing while in-service; a personnel technician who dives for cover during a simulated air raid and injures her shoulder; and a pararescue journeyman who makes a peacetime parachute jump and breaks his ankle upon landing.

"If you're not sure the circumstances surrounding your disability meet the combat-related criteria, it would be beneficial for you to apply for CRSC and let the board make a determination for you," Ms. Lacey said.

There are a few prerequisites to consider before submitting an application. To meet the basic eligibility (See CRSC on Page 3)

# SBP officials offer reminders to military retiree community

Survivor Benefit Plan officials offer the following reminders to members of the military retiree community:

The SBP "Paid Up" provision which allows retirees to stop paying premiums after 30 years of premium payment and reaching age 70 does not go into effect until Oct 1, 2008. Retired pay received in the Nov 1, 2008, payment will be the first to reflect no deduction.

In the event of the death of an Air Force retiree, the next of kin should call the Air Force Casualty Assistance Office toll free at (877) 353-6807 and the Defense Finance and Accounting Service at (800) 269-5170.

Retirees who are not married on the date of retirement have one year after marrying to provide SBP coverage for the first spouse after retiring. A written request must be received by DFAS before the first anniversary of that marriage.

Remarriage options (increase base amount, terminate coverage, or resume previous coverage) are available when spouse coverage has been suspended due to death or divorce. It is important to contact DFAS immediately at (800) 321-1080 upon marriage to ensure the change time does not expire.

# AFTERBURNER NEWS FOR USAF RETIRED PERSONNEL

The Afterburner is authorized by Air Force Instruction 36-3106. When funding permits, it is printed three times a year by the Retiree Services Branch. Distribution: individuals entitled to Air Force retired pay; unremarried surviving spouses of retirees (automatically if they are entitled to an annuity under Survivor Benefit Plan and/or the Retired Serviceman's Family Protection Plan, or the Reserve Component Survivor Benefit Plan); unremarried nonannuitant surviving spouses of deceased Air Force members who were entitled to receive retired pay, may receive the Afterburner by requesting it from the address below. The Afterburner is not sent to former spouses nor to retirees of other services. Additional copies are not available. The Afterburner address:

Only one Afterburner was printed and mailed last year in August. This edition, along with previous editions dating back to September 2001, are currently posted on the Air Force Personnel Center's Web site at http://ask.afpc.randolph.af.mil/ and can be found by clicking on the "Retirees/Veterans" icon. After clicking on the "Retirees/Veterans" icon, then click on "Afterburner, News-USAF Retired Personnel" under the blue "Military Retiree Services" heading in the upper left-hand corner. Next, click on the appropriate answer number for "Afterburner -- News for USAF Retired Personnel" and then scroll down (using the innermost scroll bar) and all the Afterburners will be there.

Retirees and survivors, who are interested in maintaining currency with information and news affecting military benefits, are urged to subscribe to the Air Force Retiree News Service for the latest information affecting the retiree community. Instructions on how to subscribe, unsubscribe and change an e-mail address can also be found on the Web site.

In addition, retired members are encouraged to join one or more military-related organizations serving the total military force. Some print monthly publications, and offer Web sites that are kept current and disseminate updates by electronic mail.

#### Annual Air Force Assistance Fund drive continues for retirees

Officials point out that active-duty and retired Air Force communities have long benefited from these charities whose return on the investments of contributions and loan repayments enable them to provide more than \$7 in assistance for every \$1 contributed during the annual

campaign.

criteria to be considered for CRSC, veterans must:

- -- Be retired with 20 (or more) years of activeduty military service, or retired at age 60 from the Guard or Reserve.
- -- Be receiving military retired pay. Veterans who waived military retirement pay for Civil Service credit are not eligible to apply for CRSC.
- -- Have a compensable VA disability rating of 10 percent or higher.
- -- Receive military retired pay that is reduced by VA disability payments.

Copies of the Application for Combat-Related Special Compensation, DD Form 2860, and more information on the program can be downloaded from the AFPC Web site: http://ask.afpc.randolph.af.mil/. People can call the Air Force CRSC office toll free at (800) 616-3775 for assistance, or e-mail them at afpc.dppdc.afcrsc@randolph.af.mil.

Ms. Lacey believes applying is worth the effort. "It will take a little time to complete the application and make copies of your documentation, but it could mean qualifying for monthly tax-free compensation for the rest of your life," she said.

address and telephone number are listed. Once a location is found, it is best to call first to ensure hours of operation and any other necessary information.

#### Whatever happened to my 'ol buddy?

To locate Air Force retirees or active-duty members:

- -- Write a letter to the person you are trying to locate
  - -- Seal it in a stamped envelope
- -- Enter your return address (including retired grade) on the stamped envelope
- -- Send the letter and the addressee's name, grade and Social Security number or service number (if known) in another envelope to HQ AFPC/DPDXIDL, 550 C Street West Ste 50, Randolph AFB TX 78150-4752.

Please keep in mind that the following information is required to make a positive identification:

- -- Full name to include a middle initial, rank (officer/enlisted/GS)
- -- Social Security number or Air Force serial number
- -- Date of birth or an Air Force duty history including the place, month and year of assignments after June 1970. (No assignment information is available before June 1970.)

This locator assistance is not available for Airmen who served on active duty but did not retire.

## Mail Call!

### Change-of-address procedures -- e-mail, snail mail

The Retiree Services Branch hears from many of you who move or change e-mail address, and in most cases this notification is not necessary.

If you rely on "snail mail" -- meaning you use an envelope and stamp for correspondence – and you are a military retiree or a surviving spouse who receives Survivor Benefit Plan annuity payments, it is very important that you notify the Defense Finance and Accounting Service of your change of address. There is no need for you to notify the Retiree Services Branch at the Air Force Personnel Center. When, and if, funding for Afterburner postage becomes available again, the branch relies on the address you have on record with DFAS to generate mailing labels.

The only people who need to notify the Retiree Services Branch when they move are those surviving spouses **not** entitled to SBP payments who have already registered with the editor to receive hard-copy Afterburners.

If you are subscribed to receive the Air Force Retiree News Service via e-mail and change your e-mail address, then you should go to the AFPC Web site at http://ask.afpc.randolph.af.mil/ and click on the "Retirees/Veterans" icon. Next, click on the line "Air Force Retiree News Service" under the blue "Military Retiree Services" heading in the upper left-hand corner. Then click on the appropriate answer number



for changing an e-mail address. Remember, changing your e-mail address involves unsubscribing your old address, and then subscribing with your new address. However, if you no longer have access to an old e-mail address, simply "subscribe" and eventually AFRS releases will stop being sent to that out-of service address.
