#### **VIEW FROM THE BRIDGE**

Chairman's Remarks

Monday March 29th was National Vietnam Veterans Day, a date which unfortunately passes without the recognition it deserves. Over 58,000 Americans died in support of that war, which ranks as the fourth highest death rate in United States history. Only the Civil War and the two World Wars

sacrificed more Americans. But that is only the official count. Tens of thousands, or probably more accurately hundreds of thousands, of American service members have died of illnesses related to the use of herbicide. This includes not only those who served in-country, but those who were offshore, in Thailand, Laos, Korea, Cambodia, Guam, Okinawa, the Panama Canal Zone and the Philippines. In addition, the herbicide was used throughout the United States in places like CBC Gulfport MS, Eglin AFB FL, Fort Drum NY, and Fort McClellan AL. Some Veterans Service Organizations have written off the Vietnam and Vietnam Era Veterans, MVA has not. We will continue to push for all victims of military toxic exposure - be it herbicide, radiation, burn pits, or any other poison.

Some good news on the legislative front, Senator Boozman of Arkansas has introduced a bill to cover Veterans in Thailand through June of 1976 when our forces departed. Congressman Bruce Westerman has a companion bill in the House. Watch for these two bills to become a "Bill of the Week" in the near future.

We are supporting a bill to cover the K-2 Veterans who were exposed to ionizing radiation in

Uzbekistan. We are also supporting benefits for those Veterans exposed to radiation in the Enewetak Atoll. Both of these efforts have been highlighted as Bills of the Week.

On the litigation front, our cases for Thailand, Guam, and to extend the line for Blue Water Navy personnel outside of the territorial sea are moving forward. We have contacted the VA about covering Phu Quoc Island, which lies outside of the area covered by the Blue Water Navy Act and are awaiting their response. Meanwhile Mike Yates is working hard to expand our data base of deck logs, many of which are not covered on the National Archives website. We have asked the VA to reissue and update the "Ships List" and are awaiting a response. We are waiting for the VA to respond to our Panama Canal Zone rulemaking request, and we continue to gather materials to submit a rulemaking request on Okinawa.

In a recent success, the MVA supported Save Lives Act was signed by President Biden. This will provide covid vaccines to all Veterans, their spouses, and care givers. We have some members in the Philippines who were denied vaccines by the Veterans Health Administration in Manila. This bill will now cover them.

We have also brought noted Veterans' law attorney Robin Hood onboard as our volunteer Director of Litigation. Robin will begin to assume more duties on the litigation front freeing me up for other matters.

Our other Robin, Robin Barr, continues to work miracles in keeping the administrative side of MVA humming. Any administrative or membership questions please contact her at Robin.Barr@mvadvocacy.org.

I cannot say enough about our Bill of the Week program. It has been successful with a number of positive comments from our members and from Congress. But we are not getting the participation that I hoped for. Please use the links to send a prewritten e-mail to your Member of Congress and Senators. Do not get discouraged if you do not get a response. IT IS A NUMBERS GAME ON THE HILL and all offices have people designated to record these types of support emails and provide a summary to the Member or the Senator. # President Signs Veterans Vaccine Bill into Law

The House unanimously approved a Senate amendment and passed the "VA Vaccine Act" (H.R.1276) sending it to the president, who signed it into law. "Today, we sent vital legislation to the

President's desk that will ensure VA has the authority to provide COVID-19 vaccines to all Veterans, caregivers, and Veteran spouses who walk through its doors," said House Veterans Affairs Committee Chairman Takano (Calif.). "VA has proven itself as one the most effective vaccinators in the nation - but it's clear VA needs additional authority to continue leading this effort to get as many shots into arms as possible. After hearing some Veterans were turned away because they weren't eligible for VA care, I saw a need and worked with Ranking Member Bost (III.), to speedily pass the bill in two weeks. This expansion must be contingent on having adequate supply of the vaccine and VA must continue to prioritize vaccinations and healthcare delivery for our nation's Veterans that are enrolled in VA care. ... When COVID-19 vaccine supply is readily available, our bipartisan legislation will give VA the authority it needs to vastly ramp up its vaccination efforts, and I look forward to President Biden signing my bill, as amended, into law." The bill will expand the VA's authority to provide vaccines to:

 Veterans who are not currently enrolled in the VA's health care system, including Veterans without compensable service-connected disabilities and Veterans who have incomes above VA's threshold;

- Caregivers of Veterans who are enrolled in various VA home-based and long-term care programs;
- Veterans living abroad who rely on the Foreign Medical Program (including those who reside in the Philippines);
- Spouses of Veterans; and
- CHAMPVA recipients (spouses or children of permanently and totally disabled Veterans or of Veterans who have died from service-connected disabilities).

According to Stars and Stripes, the legislation requires the VA to offer coronavirus vaccines to 24 million more people.

**SAVE LIVES Act Signed Into Law** 

On Wednesday, President Biden signed into law VFW-supported H.R. 1276, Strengthening and Amplifying Vaccination Efforts to Locally Immunize All Veterans and Every Spouse (SAVE LIVES) Act. The law allows VA to provide a COVID-19 vaccine to all Veterans, their spouses, caregivers, and Civilian Health and Medical Program recipients regardless of their eligibility for VA health care. Veterans who are already using VA health care will have priority. "COVID-19 has wreaked havoc on all Americans including Veterans and their families," VFW National Legislative Director Pat Murray said in a statement. "The end may be near, but we will not come out of this until everybody possible has vaccinations."

## Protect Yourself from COVID-19 Cyber Scams

Many people are anxiously anticipating their turn to receive their COVID-19 vaccine. Cybercriminals know this. That's why the latest cyber-crimes involve scams to trick people into signing up for fraudulent vaccine appointments or giving away their personal information.

Scammers are using telemarketing calls, text messages, emails, social media platforms, and door-to-door visits to perpetrate these and other COVID-19-related scams. Make sure you're informed on the ways you can best protect your personal information.

Follow these 4 tips to stay cyber safe:

1. Do not respond to, or open hyperlinks in text messages or emails about COVID-19 from unknown individuals or sources. Be extra cautious,

especially with messages purporting to be from clinics trying to schedule an appointment — these can be fraudulent attempts to get you to download malware or click on malicious content.

- 2. Do not give your personal or financial information to anyone who claims to be offering Department of Health and Human Services grants or says they are a contact tracer. Legitimate government workers will never ask for your Medicare number or financial information, or attempt to set up a COVID-19 test for you and collect payment information for the test.
- 3. Ignore offers or advertisements for COVID-19 testing or treatments on social media sites. If you make an appointment for a COVID-19 test online, make sure the location is an official testing site.
- 4. Avoid posting your vaccination record card on social media. This personal information can be used to craft convincing, individually-tailored phishing campaigns to trick you into clicking on dangerous links.

If you suspect COVID-19 health care fraud, report it immediately call 800-HHS-TIPS (800-447-8477).

#### **LEGISLATIVE NEWS**

We are now at a point where we will be very busy

over the next year. It took 10 years with constant work to get the Blue Water Navy Bill passed. Let's not see a repeat of our efforts for the Toxic Exposure bills. MVA Secretary Mike Kvintus and I will be working together by guiding you all to make these bills cross the finish line. Robin Barr, John Wells, and I are working on a list of bills that we support. We are sending support letters to the sponsor of each bill, as well as to every Congressman and Senator that we are meeting with virtually. There are 61 new Congressmen. We have already met with about 2/3 of them.

Bills that were introduced under the previous session are now being reintroduced. Some of those bills are:

- S 454 Senator Blumenthal's K2 Bill
- HR 1355 the House companion bill for S 454
- S 952 Senator Gillibrand's Warfighter's Bill
- S 927 Senator Tillis' TEAMS Act
- HR 2127 the House companion bill to the TEAMS
   Act

I will update you all in the next newsletter. We need each and every one of you to utilize our Bill of the Week program and contact your Members of Congress and Senators to help get these bills passed.

HVAC Subcommittee Hearing on Improving Female Veterans' Health

The House Veterans' Affairs Subcommittee on Health and Women Veterans Task Force conducted a joint hearing to look beyond the "Deborah Sampson Act" and continue to improve women Veterans' health care. The FRA is thankful that Congress passed, and former President Trump signed into law the "Johnny Isakson and David P. Roe, M.D. Veterans Health Care and Benefits Improvement Act" (H.R.7105) last year. It includes major provisions of the FRA-supported Deborah Sampson Act. The intent of the Act is to assist female Veterans by including the creation of the VA Office of Women's Health, which provides \$20 million to retrofit VA hospitals with women's health spaces and makes permanent a program to provide child care at VA facilities, as well as other measures.

During the hearing, Department of Veterans Affairs (VA) staff responded to questions concerning VA's policies and procedures regarding implementation of the act. The FRA welcomes the oversight hearing and wants to increase access to gender-specific medical and mental health care to meet unique needs of women service members and women Veterans.

### AT-RISK VETERANS: WHO, WHAT, AND WHY

Hello Veterans and MVA members. My name is Brian O'Callaghan, and I am MVA's Director of At-Risk Veterans services. I am a Marine Corps combat Veteran and former Capitol Hill staffer. I also contend with multiple service-connected disabilities, including PTS and TBI, which through a long, circuitous route, brought me to MVA and my current role.

Our At-Risk Vets program is designed to advocate for issues that most affect Veterans facing homelessness, justice system involvement, and mental health issues. Our goal is to ensure that the VA and other government bodies fulfill our collective promise to provide the best, and swiftest possible care and intervention for Veterans facing these massive challenges.

Allow me to provide a brief introduction to our efforts.

Over the last year, we have worked to keep Congress focused on the plight of Veterans who are homeless or may become homeless as a result of the COVID-19 pandemic. And despite the obvious limitations placed on travel and in-person meetings, we have had some success. The following links show a couple of our media efforts:

On the mental healthcare front, we submitted a rule making request to the Secretary of the VA back in January. Our goal was to require VA doctors to better inform Veterans about the dangers of several psychotropic medications, their alternative treatments, and then require signatory informed consent from the Veteran before starting medication regimens that increase the likelihood of suicide, criminal behavior, or substance abuse. Our intent is to mirror the successful program the VA has implemented for opioids, but alas, the VA denied our request. However, the fight is far from over. We plan to submit an updated request and if that one is denied, we plan to move this effort to litigation.

I hope this brief introduction helps you understand the work we are doing to advocate on behalf of some of the most vulnerable Veterans. I promise to provide more in-depth articles in the future. Thank you for your service and thank you for your support of our MVA mission.

### VA Co-Payment Debts During COVID-19 to be Canceled, Refunded

VA co-payments received between April 6, 2020, and September 30, 2021, will be waived, refunded, or forgiven under the American Recovery Plan.

The VA is canceling and refunding copayments for the following benefits:

All medical care received through VA between April 6, 2020, and September 30, 2021
All prescription medications received through VA between April 6, 2020, and September 30, 2021

We hope this will help Veterans and their families during this challenging time.

If you're a Veteran who receives care through VA, here's what this means for you:

If you received a statement with copayments for services or medications received on April 6, 2020, or later, we'll remove these copayments from your account. You won't have to pay these copayments.

If you already paid any copayments for services or medications received on April 6, 2020, or later, we'll send you a refund.

If you have unpaid copayments for services or medications received before April 6, 2020, we won't require or expect you to make payments on your account until October 1, 2021. We won't add any interest or fees to your accounts. And we won't take any collection actions on these specific copayments. If you'd like to voluntarily make payments during this time, you can. But we won't require or expect payments until October 1, 2021. Find out how to pay your VA copay bill

We don't need anything from you at this time to process your refund. Please check back often for updates on when to expect refunds to start. We ask for your patience as we adjust statements and process refunds.

Press Conference on Comprehensive Toxic Exposure Bill

On Tuesday, VFW National Legislative Service Associate Director Kristina Keenan participated in a press conference held by Sens. Thom Tillis (R-NC) and Maggie Hassan (D-NH) to introduce S. 927, the Toxic Exposure in the American Military (TEAM) Act. This legislation aligns directly with the VFW's priority to establish a permanent framework to address past, present, and future toxic exposures in the military at locations both domestic and abroad. Unlike other bills which address toxic exposures in a piecemeal fashion, the VFW believes the TEAM Act will not only take care of a significant number of Veterans but would provide VA the guidance necessary to address all toxic exposures in the military. The VFW also supports the companion bill, H.R. 2127, introduced by House Committee on Veterans' Affairs Ranking Member Mike Bost (R-IL). The VFW looks forward to working with Sens. Tillis and Hassan, and Ranking Member Bost on this comprehensive legislation to provide America's Veterans with the care and benefits they need.

#### **BLUE WATER NAVY ASSOCIATION**

As you know, we have an ongoing project called the Deck Log Project. Ed Ball started it and I took over after he retired. This is a very slow, detailed project

because we want to get it right. I am going to give you an example of what happens:

I have been working on the Deck Logs for the USS Mattaponi AO-41 for the dates it shows, it earned the Vietnam Service Medal. I was able to find the Deck Logs from 1963 until 1970 with the exception of 1966 and 1968. During the years I was able to find, I found that the USS Mattaponi had around 85 days it was within the Territorial Seas. In the Deck Logs, I found over 265 entries for other ships that were with it. I was able to add over 350 entries to the Master Deck Log list.

I want to remind everyone of the rules we have. Please review them in the file section. Being the largest and oldest section brings a lot of responsibility. We need to set the example for the other sections. For the work we have been doing the last few years, we have set the bar very high. We are the default experts on how we run the Facebook pages and we are known for it. For those of you that have not been on the Blue Water Navy Facebook page, we know that Congress does monitor our page(s).

Senate Introduces Bill to Extend and Improve Care and Benefits for Gulf War Illness

On Thursday, Sen. Robert Menendez (D-NJ) introduced a bill that addresses the VFW's concerns surrounding care and benefits for Persian Gulf War Veterans outlined in the Independent Budget. Although U.S. military operations in the Persian Gulf are currently ongoing, the authorization to provide benefits will expire on December 31, 2021. The Improving Benefits for Gulf War Veterans Act would permanently extend VA's authority to grant benefits for Gulf War Illness and would broaden the definition of Persian Gulf Veteran to include those who served in Afghanistan, Israel, Egypt, Turkey, Syria, and Jordan. Additionally, since Gulf War Illness is difficult to identify, the bill would create a single Gulf War Disability Benefits Questionnaire (DBQ) for the associated symptoms and would provide training to VA medical examiners for Gulf War disability claims. The VFW looks forward to working with Sen. Menendez to pass this significant legislation. Learn more.

#### **THAILAND**

U.S. Senator John Boozman's Statement for Thailand Veterans Legislation

WASHINGTON - U.S. Senator John Boozman (R-

AR) called on the Senate to advance his bipartisan legislation, S 657, to ensure Veterans who served in Thailand during the Vietnam War-era get the benefits they have earned and to help address health care needs that resulted due to Agent Orange exposure.

"Americans who served our country, and to this day are paying a high price as a result, have been carelessly hindered by the current limitations on the presumption of toxic exposure to Agent Orange, but they aren't forgotten. We have an obligation to ensure they get the benefits they are due, and I am committed to supporting their cause", Boozman said on the Senate floor.

Boozman recognized the efforts of Mena, Arkansas Veteran Bill Rhodes, who developed illnesses linked to herbicide exposure. Rhodes served in the U.S. Marine Corps and was stationed in Thailand in 1973. His benefits claim was denied by the Department of Veterans Affairs.

"He did his homework. He spent time looking for documentation to support his claim and realized this is a problem that needs a legislative fix because the Department's policy limits benefits for Vietnam Warera Thailand service", Boozman said. "I appreciate

the determination and tireless effort of Mr. Rhodes. He's said this legislation gives him some hope, but he won't be proud of his work until the bill is passed".



Request with evidence to the VA Secretary and are waiting for a decision. As director, I believe the evidence is clearly in favor for those Veterans of Panama who have a disease as outlined by the VA. This Rulemaking Request can be seen on the MVA website here:

The MVA received a letter back from the VA Undersecretary regarding our Rulemaking Request. It is not a No, not a Yes, but a "we are still reviewing the evidence." I continue to research and provide more proof, but, again, it is my belief the proof provided to the VA is in your favor for exposure. I invite everyone to thoroughly read our Rulemaking Request and the References provided to the VA.

In my research of the EPA studies of these chemicals, their own Position Document on 2,4,5-T states TCDD comes up through the food chain. Their report was from a study of agricultural spraying of fields. The cows ate the sprayed fields, the people ate the meat. This is not rocket science, but a travesty that Veterans need to prove they were near a perimeter or directly sprayed upon.

2,4-D which causes many cancers was used in

Gatun Lake for many years, beginning in 1948. We bathed, fished, and recreated in these waters. We have records of 2,4-D & 2,4,5-T shipped/stored and used in Panama. We have pictures from 2020 of what appears to be Agent Orange barrels used for fencing around the new marina at Fort Sherman.

We continue to await a decision and I am hopeful that the VA Secretary will someday soon add Panama to the list of places where dioxin (TCDD) was used.

Wins recently for Panama CZ Veterans....we have had a handful of Veterans win in 2020 by using these shipment records. The judge ruled in favor of the Veteran due to "overwhelming evidence" when speaking of the U.S. Census records. The shipments form 1958-1977 can be seen in the references attached to our Rulemaking Request.

Asked for a bill to be introduced in Congress...
on a second-pronged approach, we met again with
one of the congressional aides we had met with in
January to continue to ask for assistance from the
House of Representatives for introduction of a bill to

We have asked that the representative relay to the GAO that we want the GAO to send individuals to test for these chemicals in the old Canal Zone. I am positive they will be found if they agree to look.



As of March 8, 2021, they have entered into a phased expansion of their onsite work force, but they are still not accepting non-emergency records requests. There is no set timeline for return to full operation. When they do, I assume there will be a huge backlog and waiting time. If you are looking for records for Veterans separated after calendar year 2002, they are available electronically. You can use the online application at
