Re: Teleconference Between DND and VAC Concerning Agent Orange Compensation Package

I made the following ATIP requests to the Department of National Defence (DND):

"Please provide all notes, minutes, e-mail transmissions, and any and all other documentation pertaining to the Teleconference Meeting between Karen Ellis ADM (IE), DND, Alexandre Pérusse of the Herbicides Project (DND), and Sonia Heikkila, SAEI (DND), held on February 13, 2006."

And to Veterans Affairs Canada (VAC):

"Please provide all notes, minutes, e-mail transmissions, and any and all other documentation pertaining to the Teleconference Meeting between Brian Ferguson ADM (VSB) VAC, Darragh Mogan, Executive Director (VAC), and Sandy Williamson, Director (VAC), held on February 13, 2006."

Unfortunately, VAC advised that they held no documents with regard to my request, and DND only provided documents with regard to the preparation for the meeting, but none related to the actual meeting itself. I have enclosed the referenced documents for your ease of reference.

Given that you are pursuing a class action law suit on behalf of veterans who were affected by the Agent Orange spraying, you may want to be aware of the public servants who were involved in planning the compensation package. They may be of some assistance during the discovery process of the litigation.

This is further to your Access to Information Act (ATIA) request received July 31, 2008 for:
