## A BILL

To amend title 38, United States Code, to ensure that certain diseases are covered by the presumption of service connection relating to the exposure to herbicides by certain veterans who served in the Republic of Vietnam, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Keeping Our Promises  
5 Act”.

1 **SEC. 2. ADDITION OF DISEASES TO PRESUMPTION OF**  
2 **SERVICE CONNECTION FOR VETERANS EX-**  
3 **POSED TO CERTAIN HERBICIDES WHILE**  
4 **SERVING IN THE REPUBLIC OF VIETNAM.**

5 (a) SPECIFIED DISEASES.—Subsection (a)(2) of sec-  
6 tion 1116 of title 38, United States Code, is amended by  
7 adding at the end the following new subparagraphs:

8 “(K) Prostate cancer becoming manifest to a  
9 degree of disability of 10 percent or more.

10 “(L) Cancer of the urinary bladder becoming  
11 manifest to a degree of disability of 10 percent or  
12 more.

13 “(M) AL amyloidosis becoming manifest to a  
14 degree of disability of 10 percent or more.

15 “(N) Early-onset peripheral neuropathy becom-  
16 ing manifest to a degree of 10 percent or more with-  
17 in one year after the last date on which the veteran  
18 was exposed to an herbicide agent during active mili-  
19 tary, naval, or air service.

20 “(O) Parkinson’s disease (including  
21 Parkinsonism and Parkinson-like syndromes) becom-  
22 ing manifest to a degree of disability of 10 percent  
23 or more.

24 “(P) Ischemic heart disease becoming manifest  
25 to a degree of disability of 10 percent or more.

1           “(Q) Stroke becoming manifest to a degree of  
2           disability of 10 percent or more.

3           “(R) Hypothyroidism becoming manifest to a  
4           degree of disability of 10 percent or more.

5           “(S) Hypertension becoming manifest to a de-  
6           gree of disability of 10 percent or more.”.

7           (b) ADDITIONAL DISEASES.—

8           (1) EXTENSION OF SUNSET.—Subsection (e) of  
9           such section 1116 is amended by striking “2015”  
10          and inserting “2030”.

11          (2) PROHIBITION OF COST AS FACTOR.—Sub-  
12          section (b) of such section 1116 is amended by add-  
13          ing at the end the following new paragraph:

14          “(4) In making determinations for the purpose of this  
15          subsection, the Secretary may not take into account the  
16          costs to the United States relating to paying compensation  
17          under this section pursuant to such determination.”.

18          (3) TIMING AND SUBMISSION OF DETERMINA-  
19          TIONS.—Subsection (c)(1) of such section 1116 is  
20          amended—

21                  (A) in subparagraph (A), by striking “60  
22                  days” both places it appears and inserting “120  
23                  days”; and

24                  (B) in subparagraph (B)—

1           (i) by inserting “and submit to the  
2           Committees on Veterans’ Affairs of the  
3           House of Representatives and the Senate”  
4           after “publish in the Federal Register”;  
5           and

6           (ii) by inserting “, and any other fac-  
7           tor that contributed to,” after “scientific  
8           basis for”.
