SUBJECT: Exploring the Registration of Herbicide Orange

During our recent move from 4C-885 to 4C-916, we uncovered the enclosed material. It has been awhile since this was a viable possibility and no doubt much of these data have been superseded. In short, this is no longer an active file for SAF/MIQ nor would it make a useful reference file to us.
