There will be a meeting of the Science Panel of the AOWG at 9:30 a.m. on March 15, 1984, in Room 337-339A, HHH Building. The two main agenda items are as follows:

- 1) We will finalize the draft Subcommittee Review of International Studies on the Possible Association between Dioxin and Soft Tissue Sarcomas. This has been sent to you under separate cover from Dr. Hodder's office.
- 2) We have been requested to review the VVA critique of the Ranch Hand II Mortality Report. I have enclosed a copy of this critique and initiating documents as well as a copy of the Ranch Hand II Mortality Report. I hope that you will bring written comments on the VVA critique to the meeting.

You will have received a copy of the Ranch Hand II Morbidity Report released February 24, 1984. In anticipation of our being asked to review this report, I suggest that you consider how best to do this as a group effort. We can have a brief discussion of this at the meeting.
