SUBJECT Recap of Action from 21 April 1986

1. Reports from Fingerhut, Layde, Murray and Christian were received. Write-up submitted by Blair at the previous meeting was reviewed. All members of the Subpanel should carefully review the meeting and be prepared to reach closure on many of the questions posed in earlier meetings.
2. Recap of Requested Action:
 - H. Kang & D. Barnes - Complete risk assessments for Agent Orange components.
 - J. Bricker - Complete document on "Agent Orange Exposure Probability Modeling."
 - J. Murray - If possible, complete task reports.
 - A. Young & C. Keller - Submit outline for final report and prepare suggested conversion factors for Ranch Hand direct and indirect exposures.
3. Our next meeting is scheduled for Friday, 2 May 1986, 1:00-3:30 P.M., Room 5026, NEOB. I would also propose that the final meeting be held on Wednesday, 14 May 1986, at the same location and at the same time.
