Why were veterans exposed to Agent Orange on Guam fighting the Vietnam war left out of Nehmer Law ?

We , veterans of the Vietnam War , that killed more enemy during the Vietnam War from Andersen AFB were left out of everything including the Vietnam Campaign Medal, Vietnam Service medal, and were an expeditionary force because many of us were Arc Light to the Vietnam War with the B52s and KC135s from our 22 ARC LIGHT BASES. I personally handled, mixed and power sprayed Agent Orange herbicides on Andersen AFB and off base for the U.S. Air Force. I directly exposed thousands of veterans and a lot of military dependent children who were directly exposed. I caused alot of disease on Guam and lots of unborn babies died because of me. Dr Robert Haddock and Dr Yvette Paulino need your help sir. They are epidemiologists on Guam facing several epidemics on Guam from the severe contamination from the Agent Orange herbicides, TCE and PCE plumes in the water wells. Please write to me sir and please help the veterans and their families exposed to Agent Orange. Many are dead denied by the VA. I have fought them for 25 years. They covered up evidence in my medical records. We have a New Yorker named Brian Kerwin an officer with the 43rd Bomb Wing Intelligence office who has days to live. He is or was a SENIOR ADJUDICATOR with the Buffalo VA Regional Office who personally witnessed me power spraying Agent orange herbicides on Guam as did SSgt Ralph Stanton and others. I hope you are listening to me sir. Please talk to me sir and tell me what else I can do to help what I have caused under orders from the U.S. Air Force in 1968 to 1978 on Guam. They said it was peaceful exposure as my unit was in direct support of bombing Vietnam. It does not make



sense. I was sterilized by AO and I am very ill. My daughter is ill and now her daughter was born with multiple birth defects and heart mur mur as well as autistic symptoms .
