
To Whom It May Concern:

I am writing this letter in support of Manuel Hernandez.

I was stationed at Camp Casey in 1965-66. I was assigned to Recon Platoon, HHC, 1/31<sup>st</sup> Infantry Regiment, 7<sup>th</sup> Infantry Division as a section leader.

In the late summer of 1965, I observed the spraying of chemicals around the fence line, guard towers and observation posts of our company area at Camp Casey. This application of chemicals was done several times during my tour in Korea. The 13<sup>th</sup> Engineers, assisted by 8<sup>th</sup> Army personnel did the spraying.

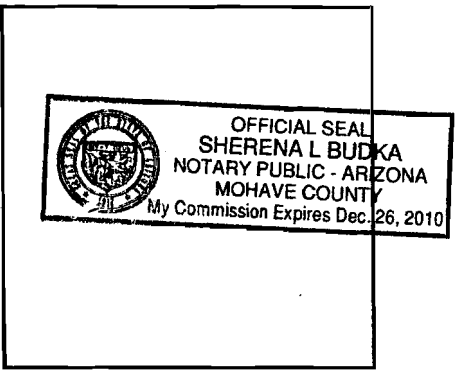
