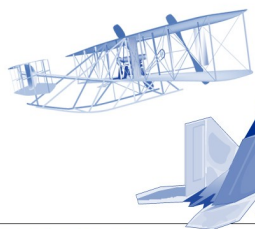

Cody joins retiree council

A new face will now be sitting at the head of the Air Force Retiree Council table. Chief Master Sgt. of the Air Force James A. Cody, who retired in March, is succeeding retired Chief Master Sgt. of the Air Force Rodney J. McKinley on the council.

Cody's appointment was announced in June by Air Force Chief of Staff Gen. David L. Goldfein.

The chief joins retired Lt. Gen. Stephen L. Hoog, who left active duty in October 2015, as a council co-chair. The co-chairs serve as personal advisers to the chief of staff and the secretary of the Air Force on all issues regarding retirees and their families.

Cody entered the Air Force in 1984. His background includes various duties in air traffic control at the unit and major-command levels.

His assignments include bases in New Hampshire, California, Virginia and Florida. The chief also served overseas in Germany, South Korea, Turkey, and deployed in support of Operations Southern Watch and Enduring Freedom. He served as the 17th chief master sergeant of the Air Force. Cody currently lives in Florida.

"I'm looking forward to serving alongside General Hoog and with the rest of the Air Force Retiree Council," said Chief Cody. "Our Air Force retiree family has more than 900,000 people who have earned dedicated attention to ensure their concerns are being heard and addressed."

Meeting at the Air Force Personnel Center each May, the council receives briefings on the Air Force's current structure and key topics from senior members of the Air Staff and other Air Force elements. This information helps the 21-member panel address issues submitted from nearly 100 base retiree activities offices worldwide. Subjects range from health care concerns to publication of the *Afterburner* to various benefit and entitlement enhancements.

The council forwards its recommendations on key issues to the Air Force chief of staff and subject matter experts.

Life changes: DFAS must know when they occur

Retirees must keep the Defense Finance and Accounting Service informed whenever changes happen that could affect retired pay.

Life-changing events such as marriages, divorces, births, etc., must be reported directly to Retired and Annuitant Pay as soon as possible.

The following are examples of life-changing events and how these events could impact your account:

Marriage — Survivor Benefit Plan, arrears of pay beneficiary, federal income tax

Divorce — SBP, arrears of pay beneficiary, federal income tax

Death of a spouse — SBP, arrears of pay beneficiary, federal income tax

Birth of a child — SBP, arrears of pay beneficiary, federal income tax

Moving to a new residence (even if just for the winter months) — general correspondence delivery, 1099-R and retiree account statement mailing, state income tax withholding, receipt of *Afterburner*

Opening, changing or closing a bank account — net pay and

allotment direct deposit

Changing the email address stored in myPay — myPay account change notifications, receipt of *Afterburner*, myPay notifications for 1099-R and retiree account



statement availability

Paying off and/or closing an insurance policy — net pay and

allotment direct deposit

By keeping information current in myPay and submitting the appropriate paperwork when a life-changing event occurs, retirees will help DFAS improve the service it provides. By reporting these events when they happen, beneficiaries will have fewer issues and concerns to resolve later.

VA announces daily online listing of burial schedules

Veterans Affairs officials have announced that there will be an online listing of burial times for all VA cemeteries.

The move, which will cover the 168 facilities operated by National Cemetery Administration directly, will allow those who wish to attend funerals a more centralized location for information related to the funeral.

Attendees will be able to search by either the location of the funeral or by the name of the veteran being buried, and updates will be provided hourly.

Officials announce 2018 TRICARE changes

WASHINGTON -- Congress passed a law in 2016 ordering TRICARE to make changes to how it operates. Tricare-For-Life users are the only group not affected by any changes.

Coverage-year changes

Currently, TRICARE operates on the October to September fiscal year for most coverages. But that changes in 2018.

Starting Jan. 1, TRICARE will instead operate on a calendar year.

That means annual enrollment fees for some users, such as retirees, will be due Jan. 1 instead of Oct. 1, and all catastrophic caps and annual deductibles will reset on Jan. 1 instead of Oct. 1.

Contractor changes

Rather than dividing the United States into three regions covered by three contractors, TRICARE will be split into two regions starting Jan. 1: TRICARE East and West.

TRICARE East will be managed by Humana Military. TRICARE West will be managed by Health Net Federal Services.

The new East region will include the District of Columbia; Alabama; Arkansas; Connecticut; Delaware; Florida; Georgia; Illinois; Indiana; the Rock Island Arsenal area of Iowa; Kentucky; Louisiana; Maine; Maryland; Massachusetts; Michigan; Mississippi; the St. Louis, Missouri, area; New Hampshire; New Jersey; New York; North Carolina; Ohio; Oklahoma; Pennsylvania; Rhode Island; South Carolina; Tennessee; most of Texas; Vermont; Virginia; West Virginia and Wisconsin.

The new West region will include Alaska; Arizona; California; Colorado; Hawaii; Idaho; all of Iowa except the Rock Island Arsenal area; Kansas; Minnesota; all of Missouri except the St. Louis area; Montana; Nebraska; Nevada; New Mexico; North Dakota; Oregon; South Dakota; west Texas; Utah; Washington and Wyoming.

Update payment information

People who pay an annual or monthly fee to use

TRICARE will likely need to change where that payment goes, thanks to the contractor change.

TRICARE officials said the regional contractors will contact people to update payment information.

New names for plans

TRICARE Standard and Extra have been combined into one newly named plan, TRICARE Select.

The coverage available is the same -- the only thing that has changed for users is the title.

The title change, however, is likely to cause chaos in some patient-doctor office interactions as office staff learn of the roll-over and all users get used to the new terminology.



Blocked from flipping plans

Many TRICARE users like the freedom of switching between TRICARE Prime and Standard based on their current life situations. That flexibility, however, is going away with the new TRICARE Select system. Instead, users will be able to switch only during annual open enrollment or when they have a "qualifying life event" such as a birth or marriage.

Watch for auto-enrollment

If you are stationed far away from a military treatment facility -- what TRICARE calls "outside a Prime treatment area" -- and currently use TRICARE Standard or Extra, you'll be automatically moved to TRICARE Select.

If you want to instead use TRICARE Prime Remote, you have until the end of March, 90 days after the switch, to make that decision. Otherwise, you'll have to wait for the annual open enrollment or until you have a "qualifying life event."

Retirees transition to new club membership portal

JOINT BASE SAN ANTONIO-LACKLAND, Texas -- For many Air Force retirees, a club membership is one way to stay connected to the service they love. Air Force Services Activity officials are encouraging retirees to activate their new Air Force Club Member Portal accounts before losing that connection.

"Our retiree population is a special part of our Air Force family. Their contributions to shaping the Air Force of today are invaluable and we want to keep them connected to our Airmen and our installations," said Col. Donna Turner, the AFSVA commander.

The Air Force began transitioning away from a club credit card to the Air Force Club Member Portal at six pilot installations in May: Osan Air Base, South Korea; Thule AB, Greenland; Whiteman Air Force Base, Missouri; Eglin AFB, Florida; Joint Base San Antonio-Randolph, Texas, and JB Charleston, South Carolina.

Current member information was automatically loaded on the club portal, but members need to log in and update payment information to maintain their membership. The free MemberPlanet app is available in the App Store or Google Play. The web- and app-based system allows members to choose their payment methods and receive real-time event information directly on their smart devices or computers through the

"Members can now use their credit or debit card of choice," said Jonathan Boyd, the AFSVA chief of non-appropriated fund food and beverage operations. "It's an easy process ... you simply update your profile using your smartphone, tablet, laptop or desktop computer."

Members without easy access to smart devices or computers can also stop by their local club for assistance.

"Through the club portal, club members will have easy access to a wide variety of information such as events and special programs scheduled, meal specials and other

notifications in near real time," Boyd said.

The portal was rolled out across the Air Force Aug. 1, 2017. Members can either show their digital membership card through the MemberPlanet App on their smart devices or print a card from the app. The card features the member's name, preferred club, and an expiration date.

"Air Force Club membership is a tradition," Turner said. "It's where our Airmen experience, learn and share our Air Force culture. Our clubs provide resiliency to our Airmen and their families. This new approach to membership will make it easier for our Airmen to stay connected with our Air Force tradition and build on the culture and esprit de corps established by those who have previously served."

Gold Star:

Families of fallen Airmen gain special access cards for enhanced base support

JOINT BASE SAN ANTONIO-RANDOLPH, Texas -- The Air Force family tree has many different branches representing Airmen and their families. One strong branch grows a bit taller and its leaves shine a bit brighter. That branch represents the service's Gold Star families.

Gold Star families are survivors of military service members who lost their lives during armed hostilities, including deployments supporting military operations against an enemy and/or during an international terrorist attack.

The Air Force's Gold Star program provides lifetime enhanced support and outreach for each survivor, or until the survivor no longer needs or desires the services. The program is designed to let families know the Air Force cares for them and will continue to embrace them as part of the Air Force family.

"Our primary purpose is to continue recognizing and honoring the sacrifice these families and their loved ones made in the service of our nation, said Vera Carson, Air Force Families Forever program manager at the Air Force's Personnel Center. "Gold Star families fall under the Air Force Families Forever program, which ensures all families of our fallen Airmen are never forgotten."

Air Force Chief of Staff Gen. David Goldfein directed the provision of additional lifelong support to Gold Star families in April 2017. Gold Star family members (parents, adult children and siblings) are now being offered the opportunity to receive a Gold Star identification card, which

authorizes access to Air Force bases in the continental U.S., Alaska and Hawaii. For additional information, contact an Air Force Families Forever representative at an Airman and Family Readiness Center.

By allowing these families unescorted access to Air Force installations, they can visit their loved one's gravesite, attend memorials and basewide events, and stop by the Airman and Family Readiness Center for immediate and long-term compassionate support.

"General Goldfein and his wife, Dawn, want to ensure our Gold Star families remain a part of the Air Force family; this special ID card is helping us make that happen," said Carla Diamond, Air Force Gold Star and Surviving Family Member representative. "We are reaching out to surviving family members, establishing contact and ensuring that their needs are met."

One resource for survivors is the Tragedy Assistance Program for Survivors, or TAPS. This program

provides emotional support and healing to anyone grieving the death of a military loved one. The TAPS staff provides military survivor seminars, Good Grief Camps for young survivors, peer mentors and resources relating to grief and trauma.

Taking care of each Airman's family is vital to ensuring an Airman is prepared and mission ready.

"Supporting family members is critical in making sure our Airmen are resilient and ready to meet their mission objectives and serve our nation daily," said Randy Tillery, the director of Airmen and Family Care. "The Gold Star program reminds our surviving family members they are still an important part of the greater Air Force family."

Combat compensation restores VA pay offset

Combat-Related Special Compensation is designed to restore military retirement pay that has been offset by Veterans Affairs compensation when evidence exists to confirm the associated disabilities are combat related.

For example, veterans currently rated for a disability of 10 percent with the VA, receive a check from the VA for \$133 each month, but their retired pay is reduced by that same amount. If the disability is found to be combat-related by the CRSC Review Board, they would continue to receive the monthly check from the VA for \$133 along with the remainder of the retired pay, and begin receiving an additional monthly check from CRSC for \$133.

Combat-related disabilities are those incurred with documented proof:

- In the performance of duty under conditions simulating war (exercises, field training)
- While engaged in hazardous service (flight, diving, parachute duty)
- Through an instrumentality of war (combat vehicles, weapons, Agent Orange)
- As a direct result of armed conflict.

Many disabilities that resulted from conditions during peacetime may meet the criteria for CRSC, said Tess Hatcher, CRSC office section chief at the Air Force Personnel Center.

As examples, Hatcher cites an aircraft mechanic who works on the flight line and begins to lose his hearing while in-service; a personnel technician who dives for cover during a simulated air raid and injures her shoulder; and a para-rescue Airman who makes a peacetime parachute jump and breaks his ankle upon landing.

There are a few prerequisites to consider before submitting an application. To meet the basic eligibility criteria to be considered for CRSC, veterans must:

- Be in a retired status
 - Be entitled to retired pay that is offset by VA disability payments
 - Have at least a 10 percent VA disability rating
- “Please note that if you waive your military retirement for civil service credit, you are not eligible for CRSC,” said Hatcher.

Program offers long-term care peace of mind

Officials with the Federal Long-Term Care Insurance Program, or FLTCIP, believe some enrollees may occasionally question whether long-term insurance is worth the cost; however, they ultimately realize the emotional and financial reassurance this protection offers outweighs the cost of premiums.

When assessing the FLTCIP's value, consider these benefits:

- ◆ FLTCIP pays up to 100 percent for home-based care, and it will pay for informal care services provided by a friend, relative, or private caregiver.
- ◆ Beneficiaries remain independent and in control by reducing reliance on loved ones.
- ◆ Enrollees have unlimited access to the FLTCIP's care

coordinators, who are registered nurses experienced in long-term care.

Coordinators can help find high-quality care providers, arrange for discounted services, monitor care, and assist with changing care plans as needs change.

The program protects savings and assets by paying for continuing custodial care and assistance with

bathing, dressing, eating, and other daily activities. The current national average for long-term care services for a home health aide is \$19 an hour, while a nursing home is \$227 a day for a semiprivate room, according to FLTCIP officials.

Air Force Retiree Activities Offices

Retiree Activities Offices are made up of retired volunteers from all services, including surviving spouses. Their charter is to coordinate, establish and staff an office on an active-duty, Reserve or Guard base through command channels that will assist retirees and surviving spouses with a myriad of actions.

These actions include: serving as an information center for TRICARE, base services, etc.; offering referrals for financial assistance and pay matters; counseling active-duty Airmen nearing retirement; and providing

guidance on retirement issues.

Another major activity involves working with base agencies to set up Retiree Appreciation Day events offering briefings by different agencies on respective services, tax preparation and advice (at selected locations); staff judge advocate assistance, base tours, Defense Finance and Accounting Service, etc.

People with an online myPay account automatically receive an Afterburner via email at the address on file with the Defense Finance and Accounting Service.

Others who wish to subscribe electronically need only navigate to the Air Force Retiree Services website, scroll to the lower right-hand corner, and enter their email address in the box under “Join our Mailing List.” Next, click “Submit” and a second screen will pop-up giving users an option for email service by selecting “AFTERBURNER—Retiree News Service” from the list of subscription topics.



Remember, people who do not have a myPay account or subscribe electronically will receive a hard-copy Afterburner at the mailing address on file with DFAS. (The Afterburner office does not maintain mailing addresses.)
