## ***This-N-That***

After nearly a year with the visit of Secretary McDonald to the West Los Angeles Medical Center and the long standing scandal of turning away homeless Veterans, the VA has released proposed "blueprints" of the modifications planned to deal with homeless Veterans.

The plan calls for construction of 1,200 permanent supportive housing units for disabled and traumatized Veterans and more than 700 short-term units for homeless Veterans in the midst of some of the city's toughest neighborhoods. Some permanent housing could open as soon as next year, officials said, perhaps by adapting some of the 388-acre property's historic buildings.

This still doesn't address several other issues that have plagued this facility for the past five plus years.

- 1) Where are all the funds that the director Donna Beiter collected from illegal tenants that supposedly went to helping Veterans?
- 2) Why are there still illegal tenants on VA Land?
- 3) Why was it necessary to spend over a million dollars on security fencing to keep Veterans out and off VA land?
- 4) Why the increased number of Gestapo style police officers and high tech security surveillance equipped vehicles?

Why do these plans not call for more usage of the 388 acres putting in more housing for homeless Veterans is another issue I take personally, especially since several smaller organizations have done this and proven beyond a doubt costs could be maintained at no more than \$8-\$12 thousand dollars per home, take up small footprints, look nice and still deal with the never ending problems?

Even by their own numbers which are more than double what we've known all along of 44,000 this only puts a very small dent in a very significant problem.

Granted it's a start, but why not address the problem as a whole, come up with a plan and blueprints to solve much more?

And why do they still not hold this medical centers director Donna Beiter fully accountable for all the monies brought in from rents and leases?

Then we have the issue of executives who were caught scamming the VA system to the tune of several thousand dollars who were never charged, recently demoted and allowed to return to work, then the review judge over turns the decision and allows them to not only return to work but in their former positions.

None of this makes sense, but then when does anything that the VA does make sense?

But Gibson praised what he called a long and distinguished career and said if anything she was guilty of "an error in judgment, a serious error in judgment" not an ethical violation.

What part of this statement would justify allowing someone to steal from the Federal Government and Veterans? In my eyes, none of it. Just more of the good old boys club at work!

### ***'Vets Only' Jobs at VA are Low-Pay***

The only jobs explicitly reserved for veterans at the Department of Veterans Affairs (VA) are janitors or housekeeping aides, according to a Daily Caller News Foundation analysis of data from USAjobs.gov. According to the Daily Caller, only about 50 job ads, seeking approximately a few hundred workers, are accepting applications exclusively from veterans. Out of those positions, all but a few pay only \$13 an hour. Simultaneously, more than a thousand vacancies, many with no special skill requirements, were being advertised as open only to current civil servants. ### ***Bases No Longer Accept IDs from Five States***

U.S. military installations are no longer allowing visitors to gain base access using official ID cards from five states — and other installations may soon follow. State-issued driver's licenses and identification cards from Illinois, New Mexico, Missouri, Washington and Minnesota can no longer be used to obtain a visitor's pass because those cards don't comply

with federal standards, officials said. DoD officials did not say whether or not enhanced driver's licenses (EDL) from Minnesota or Washington would still be accepted.

### **Statement from VA Secretary Robert A. McDonald**

*On the Need to Reform the Veterans' Appeals Process*

Last week I presented to the Senate Veterans Affairs' Committee the way forward for the important transformation of the Department of Veterans Affairs—what we call MyVA. We aim to improve our care and services to all Veterans. In order to do that, I made clear that we would need Congress' help in legislating a fair, streamlined, and comprehensive process for new appeals, as well as providing much needed resources to address the current pending inventory of appeals. I look forward to working with all stakeholders to design an appeals process that better serves Veterans.

VA will need legislation and resourcing to put in place a simplified appeals process that enables the Department to resolve the majority of our appeals in a reasonable timeframe for Veterans.

The appeals process we currently have set in law is failing Veterans—and taxpayers. Decades worth of law and policy layered upon each other have become cumbersome and clunky. Most importantly, it is now so antiquated that it no longer serves Veterans well as many find it confusing and are frustrated by the endless process and the associated length of time it can take to get an answer.

In 2012, VA made the commitment to end the disability claims backlog. It took too long for Veterans to receive a decision on their claim. Our commitment has resulted in transformational change. The disability claims backlog has been driven down to fewer than 82,000, from a peak of 611,000 in March 2013. At the same time, we have fully transitioned to a paperless, electronic processing system, eliminating 5,000 tons of paper a year. Last year, we decided 1.4 million disability compensation and pension claims for Veterans and survivors – the highest in VA history for a single year and that comes on the heels on two previous record-breaking years of productivity.

As VA has become more efficient in claims processing, the volume of appeals has increased proportionately. While it remains true that 11-12 percent of Veterans who receive a disability rating file for an appeal, more processed claims means more appeals. This is VA's next challenge.

The current pending inventory of appeals stands at more than 440,000 and is estimated to grow rapidly. Right now, Veterans who file an appeal wait an average of three years for appeals to be resolved by the Veterans Benefits Administration (VBA), and an average of five years for appeals that reach the Board of Veterans Appeals' (Board), with thousands lasting much longer. That's unacceptable.

We are applying lessons learned from the transformative change that allowed us to reduce the disability claims backlog. Like our work with the claims processing, the appeals process will need changes in people, process and technology. Upgraded technology will make changes to our mail system and paper records, and incorporate some efficiencies in the way appeals are managed and processed. Retraining and increased staff will be necessary. But they will not be enough. We must also look critically at the many steps in the current complex appeals process used by VA and by Veterans and their advocates to design a process that better serves Veterans.

A new appeals process would provide Veterans with the timely and fair appeals decisions they deserve, and adequate resourcing that permits the VBA and the Board to address the growing inventory of appeals.

### ***Navy Evaluates Ratings to Avoid Discrimination***

Secretary of the Navy (SECNAV) Ray Mabus recently directed a review of the Navy's rating names to ensure they were representative of all Sailors and did not discriminate based on gender. The Navy will look specifically at ratings that referenced "man" in the title, which encompasses more than 20 Navy jobs. As the Navy moves toward the full integration of women serving in all job fields, the service will review its ratings for gender-neutral titles, accurate descriptions of their work, and alignment with civilian related jobs. A report detailing proposed courses of action is due to SECNAV by April 1.

### ***TRICARE OTC Program Becomes Permanent***

TRICARE's over-the-counter (OTC) drug coverage is here to stay. Formerly a demonstration program, the OTC benefit becomes a permanent part of the TRICARE pharmacy benefit on February 1, 2016. Effective that date, TRICARE is making some changes to OTC coverage to bring it in line with other TRICARE pharmacy coverage.

Starting February 1, beneficiaries must pay the usual generic copays for covered OTC drugs. OTC drug coverage will still require a prescription from a doctor. Female beneficiaries can still get Levonorgestrel, an emergency contraceptive used to prevent pregnancy without a copay or prescription at a network or military pharmacy, also known as Plan B—there are no age restrictions or costs for the contraceptive.

Monday, February 1 also brings a change to which drugs are available under the OTC benefit. The allergy medications Cetirizine and Loratadine were previously covered, but now the versions that contain pseudoephedrine will also be covered. However, brand name Prilosec OTC is no longer covered. The generic version, Omeprazole, is still covered, as is the prescription version of Prilosec.

### ***Army Childcare Fee Assistance Program Moving***

A program that helps Soldiers with off-post child care expenses will begin transitioning from the Government Services Administration (GSA) to a contractor, Feb. 22. The Army Fee Assistance program helps Soldiers with the cost of off-post child care when on-post care is unavailable. The transition to the contractor, Child Care Aware of America, or CCAoA, will take place over about eight months. GSA will continue to manage Army Family accounts until the transfer to the contractor is complete in October. The transition will consist of seven geographically defined phases and all families residing within a geographic area will be transitioned to the contractor as a group. With the formal transition, CCAoA will begin management of any families new to the AFA program regardless of their location.

## ***Affordable Care Act***

All Affordable Care Act documents are now posted in myPay. If you find there are errors on your IRS 1095 form and you are military (active or reserve) or a military retiree, you must contact a DEERS representative at 1-800-538-9552 who can assist you. If you are a DoD Civilian you must contact DCPAS Benefits General Inquiry Line at 703-882-5197. If you are a Non-DoD Civilian serviced by DFAS, please contact your Human Resources Benefits office.

If you have questions about the number of dependents on your IRS 1095B, and you are a civilian, please contact your Health Benefits Carrier directly. If you are military (active or reserve) or a military retiree, you must contact a DEERS representative at 1-800-538-9552 who can assist you. ## ***Affordable Care Act Form 1095 for Annuitants***

While downloading the form from the DFAS website is the easiest and quickest way to get it, the 1095B form with your healthcare information related to the ACA will be mailed no later than February 1 to the Sponsor's address on record in the DEERS system.

Please allow 7-10 days for delivery. If the Sponsor's address on record is incorrect, it must be updated on the MilConnect website or at your nearest ID CARD Facility (DEERS office). After the address has been updated, a new form must be requested on the MilConnect website (go to the Correspondence/Documentation tab and select ACA – Corrected IRS Form) or by calling (800) 642-1386.
