Sense of Congress on Agent Orange Blue Water Issue

Congresswoman Elise Stefanik (NY) and Senator Chuck Grassley (IA), have introduced a non-binding Sense of Congress (H Con Res 161 and S Con Res 51 respectively) expressing support for those who served in the bays, harbors, and territorial seas of the Republic of Vietnam between January 9, 1962, and May 7, 1975, and should be presumed to have been exposed to the toxin Agent Orange and should be eligible for all related Federal benefits that come with such presumption under the Agent Orange Act of 1991.

While these measures, if passed, are non-binding, it will show Congressional support for the Blue Water Navy veterans and will hopefully convince the Secretary of the Department of Veterans Affairs (VA) to provide this presumption by regulation.

Phoenix VA Launches Robots

The Phoenix VA Health Care System is [the first hospital in Arizona](#) to deploy Xenex Germ-Zapping Robots to destroy deadly germs and bacteria lurking on hospital surfaces that can cause hospital acquired infections. The portable room disinfection system utilizes pulsed xenon UV light and is effective against even the most dangerous superbugs. The room, bed and equipment are first disinfected by hospital Environmental Management Service staff. Once the room is visually clean, the robot comes in and destroys anything left behind -- it kills all the dangerous bacteria the naked eye cannot see.



Campaign Seeks to Raise Support for Vet Caregivers

A new national public awareness campaign seeks to leverage celebrity appearances to raise public support for veteran caregivers. Walgreens Offer Free Flu Shots

The Veterans Health Administration (VHA) has teamed up with national retail pharmacy Walgreens to provide free flu vaccinations for enrolled Veterans. All Veterans who are currently enrolled in VA care may walk into any of the over 8,000 Walgreens nationally (and the Duane Reade pharmacies in the New York metropolitan area) to receive a vaccination at no cost. After presenting a Veterans Identification Card and a photo ID, a Walgreens pharmacist administers the vaccine and transmits that information securely to VA where it becomes part of the patient's electronic medical record. VA and Tinnitus

Hearing loss, including tinnitus, which is a ringing, buzzing or other type of noise that originates in the head, is the most prevalent service-connected disability among veterans, with more than 30 million veterans suffering from a form of it due to frequent exposure to loud noises from weaponry and aircraft.

Because of the pervasiveness of hearing loss among veterans, the Department of Veterans Affairs (VA) is recognizing October as Audiology Awareness Month by highlighting important VA research on the subject and advances made in treating veterans with hearing loss.

VA researchers conduct a wide range of studies in audiology—from biomedical investigations to large clinical trials and epidemiologic database studies. Much of the work takes place at VA's [National Center for Rehabilitative Auditory Research](#) in Portland, Oregon, one of the world's leading facilities for research in the field. Studies include older veterans whose hearing problems have been compounded by aging and younger veterans who may have suffered hearing loss as a result of blasts in Iraq or Afghanistan.

Hurricane Readiness

The impending threat of Hurricane Matthew has the Eastern Seaboard on high alert status. In preparation for this potentially devastating storm, I have put together some must know information from NOAA for you to review!

The best time to prepare for a hurricane is before hurricane season begins. It is vital to understand your home's vulnerability to storm surge, flooding, and wind. Below are the basics to get started:

- **Know your zone:** Do you live near the Gulf or Atlantic Coasts? Find out if you live in a hurricane evacuation area by contacting your local government/emergency management office or by checking the [evacuation site website](#).
- **Write or review your Family Emergency Plan:** Before an emergency happens, sit down with your family or close friends and decide how you will get in contact with each other, where you will go and what you will do in an emergency. Keep a copy of this plan in your emergency supplies kit or another safe place where you can access it in the event of a disaster. Start at the **Ready.Gov** [emergency plan webpage](#).
- **Put Together an Emergency Supplies Kit:** Put together a [basic disaster supplies kit](#) and consider storage locations for different situations. Check emergency equipment, such as flashlights, generators and storm shutters.
- **Review Your Home Owners Insurance:** Review your insurance policy to ensure that you have adequate coverage for your home.
- **Understand NWS forecast products,** especially the meaning of [NWS watches and warnings](#).

Understanding the New Blended Retirement System

The U.S. Navy has released information on the transition to the Blended Retirement System (BRS) and training requirements. The new Blended Retirement System goes into effect Jan. 1, 2018. However, Sailors who are currently serving in the Navy will be grandfathered into the current retirement system. Active Component Sailors with less than 12 years of service (as of Dec. 31, 2017) and Reserve Component Sailors with fewer than 4,320 retirement points (as of Dec.31, 2017) will be able to opt-in to the new retirement plan if they choose to do so. All Navy servicemembers will be required to complete either the BRS Leader's Training course available now on Joint Knowledge Online (JKO) and Navy E-learning, or the BRS Opt-in Training course that will go live early in 2017. On Memorial Day, May 28, 2012 and concludes on Veterans Day, November 11, 2025. The Commemoration honors all United States veterans who served on active duty in the U.S. Armed Forces at any time between November 1, 1955 to and May 15, 1975, regardless of location. Vet Centers provide all readjustment counseling services at no charge. Those using vet centers are not required to enroll in the VA Health Care System or to have received a service connection for conditions caused by military service. Vet centers provide services regardless of the nature of a veteran's discharge. Shift in VA Private Health Care Program Criticized by Lawmakers

New data show that many veterans using a \$10 billion private health care expansion program are not the ones Congress intended to help.

That's rankled lawmakers charged with oversight of the 2-year-old Veterans Choice Program, launched after an uproar over disturbing reports of veterans who waited for appointments at Department of Veterans Affairs facilities.

In addition it is reported that the VA provided incorrect data to the Congressional Research Service that resulted in [inaccuracies in a CRS report](#) examining the Veterans Choice Program. The authoritative and objective reports produced by the CRS, which is part of the Library of Congress, are heavily relied upon by lawmakers for policy and legal analysis.

A Library of Congress spokeswoman said "CRS is independently aware that the information provided by the VA is inaccurate. CRS will update the report accordingly when corrected information is available."

It was reported that most authorizations for the Veterans Choice Program have been granted for expanding access to care that veterans can't get at traditional Department of Veterans Affairs facilities, not due to explicit wait time or distance problems.

Those two issues — that is, if a veteran had to wait more than 30 days or travel further than 40 miles to get to a VA facility — were the original criteria used to determine whether a veteran was eligible for the Choice program. They were also the reasons why concerned members of Congress moved to plug \$10 billion into the program.
