Help Blue Water Vietnam Vets Exposed to Agent Orange

The “Blue Water Navy Vietnam Veterans Act” has been introduced in both the House and Senate (H.R. 299 & S. 422 respectively). These proposals would clarify that service members serving off the coast of the Republic of Vietnam during the Vietnam conflict have a presumption for filing disability claims with the Department of Veterans Affairs (VA) for ailments associated with exposure to the Agent Orange herbicide. FRA believes Congress should recognize that so-called “Blue water” veterans were exposed to Agent Orange herbicide and authorize presumptive status for VA disability claims associated with this exposure.

VA now Providing Online Daily Burial Schedules for its National Cemeteries

The Department of Veterans Affairs (VA) recently announced a new online Daily Burial Schedule (DBS) for all VA national cemeteries, which will allow families and loved ones to retrieve time and location information for those being interred, via its [National Cemetery Administration](#) (NCA) website. “We pride ourselves on continuously improving customer satisfaction and meeting the wishes of Veterans and their loved ones,” said interim Under Secretary for Memorial Affairs [Ronald E. Walters](#). “We want manageable information for anyone wishing to pay their respects.”

The new feature is available to anyone with a smartphone, tablet or computer. Families may also opt out of using this service. Schedules of interments are posted online and updated hourly at: www.cem.va.gov/dailyburialschedule. The public can search by national cemetery or last name. DBS will give the scheduled committal service date and time, location of the cemetery and funeral home providing services. The location of the committal shelter will be provided at the cemetery. In addition, users may also navigate to the specific VA national cemetery website for directions and further information.

VA operates 135 national cemeteries and 33 soldiers' lots and monument sites in 40 states and Puerto Rico. More than 4 million Americans, including Veterans of every war and conflict, are buried in VA's national cemeteries. VA also provides funding to establish, expand, improve and maintain 105 Veterans cemeteries in 47 states and territories including tribal trust lands, Guam, and Saipan. For Veterans not buried in a VA national cemetery, VA provides headstones, markers or medallions to commemorate their service. In 2016, VA honored more than 345,000 Veterans and their loved ones with memorial benefits in national, state, tribal and private cemeteries.

Safeguarding the Integrity of GI Bill Benefits

Colleagues and Fellow Veterans,

Over the past few years you may have heard us using phrases like, “safeguarding the integrity of GI Bill benefits” and “protecting our beneficiaries from bad actors,” – but what does this really mean? Unfortunately, not every school/institution out there has Veterans’ best interests in mind, so we have been working diligently to ensure that our GI Bill beneficiaries don’t fall victim to schools that employ fraudulent, misleading, or deceptive practices.

Just recently, we had a major “win” that we hope will set a precedent for the future:

As a result of a student complaint in our GI Bill Feedback System, the owners of the College of Beauty and Barber Culture in Chesapeake, Va., were sentenced to jail time and required to pay \$4.5 million in restitution. The school, which enrolled hundreds of Veterans since 2011, only had a handful pass their licensing exam. The investigation also revealed that many students did not receive the required hours of instruction, which contradicted information submitted to VA. We take our Veterans’ education benefits very seriously, which is why we encourage them to conduct thorough research before choosing a school. To assist them, VA is constantly updating the GI Bill [Comparison](#)

[Tool](#) with the number of complaints a school receives, and we add caution flags highlighting important information such as investigations, settlements, accreditation issues, or financial issues.

GI Bill beneficiaries, family, and friends can play a part in helping keep schools honest. Reporting [Principles of Excellence](#) violations and fraudulent schools through [the GI Bill Feedback System](#) can help other Veterans and dependents to avoid bad actors and protect the integrity of the GI Bill education programs. Students can also call the [VA Office of the Inspector General](#) hotline at 1-800-488-8244. In both cases, it's up to you if you want to provide contact information or remain anonymous.

We will continue to work hard to provide the most accurate and timely information to our beneficiaries. As we navigate these sometimes turbulent waters, we will remain dedicated to providing the best GI Bill experience possible for those who fought for us.

S. 681, the Deborah Sampson Act to Improve VA Services for Women Veterans

On March 21, the Ranking Member of the Senate Committee on Veterans Affairs, Senator Jon Tester, introduced S. 681, the Deborah Sampson Act. This comprehensive measure addresses gender disparities and would improve and expand programs and services for women veterans provided by the Department of Veterans Affairs (VA).

The bill would establish a pilot program for peer-to-peer counseling and authorizes group retreat counseling for women veterans recently separated from military service. It would expand the capabilities within the VA

Women Veterans Call Center and extend the number of days, from seven to 14, VA can cover the cost of care for newborns of women veterans and authorize medically-necessary transportation for newborns.

The legislation aims to eliminate barriers to care by ensuring every VA medical facility has at least one full-time or part-time women's health provider, as well as a Women Veterans Program Manager and a Women Veteran Program Ombudsman. Additional resources are authorized for mini-residency training in women's health for clinicians, and retrofitting VA facilities to enhance privacy, safety and improve the overall environment of care for women veterans.

S. 681 would provide support services for women veterans seeking legal assistance and authorizes additional grants for organizations supporting women veterans and their families. Finally, The Deborah Sampson Act would require data collection and reporting on all VA programs serving veterans, by gender and minority status, including a report on the availability of prosthetics for women veterans and would better coordinate outreach by centralizing all information for women veterans in one easily accessible place on VA's website.

DAV's 2014 report, *Women Veterans: The Long Journey Home* identified many of these gaps in VA programs for women and has long advocated for a more comprehensive provision of VA women's health services that appropriately recognizes and honors their service and sacrifice.

AF Suicide Prevention Resources

The U.S. Air Force has a comprehensive approach to suicide prevention through several sources. Comprehensive Airman Fitness (CAF) program includes Airmen being on the lookout for signs of impending suicide. The Behavioral Health Optimization Program embeds behavioral health providers within base primary care clinics to deliver brief, behaviorally-based interventions. Military One Source provides services 24 hours a day by phone at 800-342-9647 and on the [Military One Source website](#). On February 21, 2017, an interim final rule was published in the federal register that extended the period of eligibility for firms in the Veterans First program from two years to three years. Center for Verification &

Evaluation (CVE) believed that due to Executive Order 13771, implementation of the rule would be delayed until March 21. On March 20, we recognized that the Executive Order did not apply and that the rule was effective on the date of publication. In response to this recognition CVE reinstated all VOSB that expired during that time period and extended their period of eligibility in accordance with the interim final rule. CVE notified all firms that they have been reinstated, and is not aware of any firms that were adversely affected by the temporary expiration.

VA Offering Services for MST Victims

The Department of Veterans Affairs (VA) is providing all care for mental and physical health conditions related to military sexual trauma (MST) free of charge, and veterans do not need to have reported their experiences of MST at the time or have other documentation that they occurred in order to receive free MST-related health care. Service connection (VA disability compensation) is also not required, and veterans may be able to receive free MST-related care even if they are not eligible for other VA care. Change to Spouse Federal Hiring Preference Awaits Clarification

Federal hiring officials are working to clarify whether a military spouse hiring preference change included in a 2016 law is retroactive, a question that could change eligibility for thousands of potential applicants. The hiring measure, known as PPP-S, allows military spouse dependents to receive preference when applying for a Defense Department federal job after a permanent change-of-station move. Support Caregiver Expansion

We applaud Senators Patty Murray, Susan Collins, and Representative Jim Langevin for introducing the "Military and Veteran Caregiver Services Improvement Act" on March 9, 2017.

DAV has worked diligently for several years as a part of a larger coalition of veterans organizations that promoted the advent of family caregiver support services for severely injured and ill veterans. Congress finally responded by enacting Public Law 111-163, the Caregivers and Veterans Omnibus Health Services Act of 2010. However, that law limited services and supports to family caregivers of veterans who were injured or became severely ill in military service only on or after September 11, 2001. That omission left thousands of veterans' families without the level of caregiver support and services they have needed because those veterans' health challenges, many from war injuries, occurred before that effective date.

If enacted, the Military and Veteran Caregiver Services Improvement Act would responsibly and finally address these families' needs on the same basis as those of veterans injured after September 11, 2001. Ultimately, when fully implemented, the bill would improve the lives of tens of thousands of veteran families, and will save the federal government a significant amount of resources that otherwise would need to be spent to provide institutional solutions to these veterans' health challenges and health maintenance. This bill is both beneficial to these families and a taxpayer-friendly measure.

Fry Scholarship / Survivors' and Dependents' Educational Assistance (DEA) Update

Colleagues and Fellow Veterans,

Everyone knows VA provides many programs for veterans and their families to assist with life after the military, but did you know that VA has GI Bill programs that offer education assistance to survivors and dependents of veterans? There are many wonderful nonprofit organizations that offer scholarships to the families of our heroes. We honor and encourage all of them, but want everyone to ensure they do not accept them *in lieu of what the VA provides*. Families have earned the programs discussed below – it is not an either or situation.

[The Marine Gunnery Sergeant John David Fry Scholarship \(Fry Scholarship\)](#) is available for children and spouses of Service members who died in the line of duty while serving on active duty on or after September 11, 2001. Children may use benefits until their 33rd birthday; and spouses' eligibility ends at the earlier of 15 years from the date of death or the date of remarriage. See our [fact sheet](#) for more detailed information. Eligible beneficiaries attending school may receive up to 36 months of benefits. This includes full in-state tuition & fees for public schools, and private or foreign school tuition & fees are capped at a statutory maximum amount per academic year. Additionally, students may receive a monthly housing allowance and stipend for books & supplies. We've worked hard to support and implement laws that make programs like this available. On December 16, 2016, a new provision of the law extended the benefit eligibility period to January 1, 2021, for the spouses of Service members that died between September 11, 2001 and December 31, 2005. This provides surviving spouses with additional time to use the Fry Scholarship benefits. Check out our [letter to spouses](#) for more information on what has changed. Federal law also requires schools to charge [in-state tuition and fee](#) amounts to qualifying dependents using the Fry Scholarship at a public institution of higher learning located in the state where they currently live. We're working to ensure that all states come into compliance, and the public can track our progress through the use of a [map](#) available on our website.

[Survivors' and Dependents' Educational Assistance \(DEA\)](#) offers education and training benefits to the spouses and children of veterans who are permanently and totally disabled due to a service-related condition,

veterans who died while on active duty, or who died as a result of a service-related condition. Children must generally use benefits between the ages of 18 and 26; and spouses generally have a 10 year period in which to use benefits, or a 20 year period for spouses of Service members who die on active duty or veterans that receive a permanent and total rating effective within 3 years of release from active duty. Benefits may be used for degree and certificate programs, apprenticeships, and/or on-the-job training. See our [DEA pamphlet](#) for more detailed information.

Sometimes it can seem as though the VA is a giant government organization that only processes claims. However, the majority of our employees here are either veterans or the family member of a veteran. In fact, many of us use or have used these benefits ourselves. We assure you that each day we're working hard to provide the best care and benefit programs and upholding the VA motto, "*to care for him who shall have borne the battle and for his widow, and his orphan.*"

Bills to Increase Payment for Adult Day Health Care in State Homes

Senator Orrin Hatch (UT) and Representative Lee Zeldin [NY-1] introduced legislation (S. 324 and H.R. 1005) designed to increase the availability of adult day health care services for severely disabled veterans. If enacted, the legislation would increase the current reimbursement to state veterans homes for the provision of adult day health care services to severely disabled veterans who are eligible for, but do not receive, full-

time skilled nursing home care paid for by the Department of Veterans Affairs (VA), with no cost to the veteran.

Under current law, veterans who require nursing home care due to a service-connected disability or who have a VA disability rating of 70% or more can receive full-time nursing home care inside a state veterans home at no cost; however, the law does not allow those same severely disabled veterans to benefit from adult day health care, which is a less costly non-institutional alternative many prefer. S. 324 and H.R. 1005 would amend existing law to authorize VA to pay state veterans homes a per diem rate that is 65% of the per diem otherwise payable for full-time skilled nursing home care for these same severely disabled veterans.

Adult day health care, which is currently offered by only three state homes, provides comprehensive medical, nursing and personal care services combined with social activities for physically or cognitively impaired adults. Under this program, veterans are brought to the state home for 6-8 hours where they can receive any necessary medical care -- including physical, occupational or speech therapy -- as well as nutritional and social services. Adult day health care allows severely disabled veterans who might otherwise need skilled nursing services to receive these services several times a week while continuing to live at home.

If enacted, these bills would enable more state veterans homes across the country to offer adult day health care programs for these deserving veterans. The legislation would also provide important relief and support for their family caregivers. DAV Resolution 127 calls for legislation to provide state homes with greater flexibility in providing eligible veterans medically necessary long-term supports and services.

Please contact your elected officials and urge them to support passage of the State Veterans Home Adult Day Health Care Improvement Act of 2017 (S. 324 and H.R. 1005) during the 115th Congress.
