**It's Official: Disabled Vets to See Biggest Raise Since 2012**



Veterans with the highest ratings will see an almost \$100 bump in [disability pay](#) each month starting in 2019, the largest increase since 2012. That 2.8 percent cost-of-living adjustment ([COLA](#)), which kicks in Jan. 1, was made official Monday by the [Department of Veterans Affairs](#). **VA Responsibility for Making  
Student Veterans Whole**

The [VA](#) released a [statement](#) this week regarding the implementation of Forever GI Bill changes that were supposed to have been enacted this past August. VA Secretary Robert Wilkie has now directed the Veterans

Benefits Administration to cease attempting to implement the changes and instead reset the entire effort in order to get the job done correctly. The reset begins this Saturday, with the full implementation date now shifting to December 2019. VFW National Commander B.J. Lawrence said “The VFW was disappointed to learn about the 12-month delay in implementing this amazing benefit, but we recognize why hitting the reset button was necessary in order for the VA to get this right.” The Forever GI Bill changed student housing allowances to reflect the ZIP codes where students attend the majority of their classes. This change was required to go into effect on Aug. 1, 2018, but the VA admits that its antiquated computer system was unable to simultaneously handle individual ZIP code changes and the influx of students registering for the fall semester. “Shifting the implementation deadline a year isn’t a free pass for the VA to arbitrarily pay student veterans less than they are due simply because it was unable to correct internal problems in time,” said Lawrence in a [press release](#). “I appreciated hearing the VBA undersecretary in testimony address the need to make student veterans whole, and I pledge that the VFW will continue to push for the proper implementation of the Forever GI Bill so that all student veterans receive the prompt and full benefits they earned and deserve.”



## **VA Announces GI Bill Processing Changes**

The Department of Veterans Affairs (VA) has announced key changes in the processing of GI Bill benefits payments under the Harry W. Colmery Veterans Educational Assistance Act of 2017 (Forever GI Bill). Because of continued information technology difficulties with implementing sections 107 and 501 of the law, both of which change the way monthly housing allowance payments are calculated, the Veterans Benefits Administration (VBA) will reset its implementation efforts to give the department the time necessary to develop the capability to process Spring 2020 enrollments. If students require assistance with their GI Bill benefit or experience a financial hardship due to a delay in payment, they should contact the Education Call Center at 888-442-4551. ## **MILITARY STAR Card Launches New App**

The military exchange store credit card has rolled out a mobile app, MILITARY STAR Mobile, that will allow shoppers to make payments, sign up for push notifications and view account information, including all transactions and past billing statements. Biometric security features ensure that all account information stays safe. App users can track rewards points and see how close they are to their next \$20 rewards card, which cardholders automatically earn every 2,000 points. **Blue Water Navy Bill - Alive but on Life Support**

Congress is very close to passing H.R. 299, the Blue Water Navy Vietnam Veterans Act of 2018, which would end the injustice of denying Vietnam, Korean DMZ, and Thailand veterans who suffer from life-threatening health conditions the care and benefits they deserve.

Unfortunately, because of the limited time left for Congressional action this year as explained above, this important bill is now in jeopardy. Make sure your Senators support its immediate passage and encourage their colleagues to do the same.

It is especially important for veterans in Utah to contact Senator Mike Lee. His phone number is 202-224-5444. He is apparently the only Senator now holding up passage of the bill in the Senate.

Even if you don't live in Utah call your own senators and urge them to support immediate passage of H.R. 299. The Senate cannot continue to delay passage of this important bill while Blue Water Navy veterans sicken and die from diseases related to exposure to Agent Orange. If it does not pass this year we have to start all over again next year.

**US-Russia Joint Commission on  
POW/MIAs**

Representing the interests of the veterans' community, VFW Washington Office Executive Director Bob Wallace attended the 22nd meeting of the U.S.-Russia Joint Commission on POW/MIAs here in Washington, D.C., this week. It was his second consecutive appearance, having traveled to Moscow to attend last year's conference. The Joint Commission was established in 1992 by Presidents George H.W. Bush and Boris Yeltsin as a forum through which both nations seek to determine the fates of their missing service personnel. Since then, U.S. analysts have had access to many important Russian governmental archives for research on past conflicts ranging from the Korean and Vietnam Wars to the Cold War, as well as World War II losses during lend-lease operations. With international tensions high due to Russia's four-year involvement in the Ukraine, it is hoped that the humanitarian aspect of the Joint Commission will be able to keep some diplomatic doors open between our two countries. **VA Cost-of-Living Adjustment  
(COLA) and 2019 Compensation  
Rates**

VA adjusts monthly compensation amounts based on the yearly change in the cost of living as determined by the Social Security Administration (SSA). These periodic changes made to VA compensation rates allow for VA benefit amounts to increase with the rate of inflation. The SSA bases COLA rates off of the percentage increase in the Consumer Price Index for Urban Wage Earning and Clerical Workers from the third quarter (i.e. July, August, September) of the previous year to the third quarter of the current year. The 2019 COLA is set for a 2.8 percent increase, which will be the largest COLA increase since 2011 when it was 3.6 percent. For 2019, VA compensation rates are scheduled to go into effect on December 1, 2018 and will be reflected in veterans' benefit checks starting December 31, 2018.

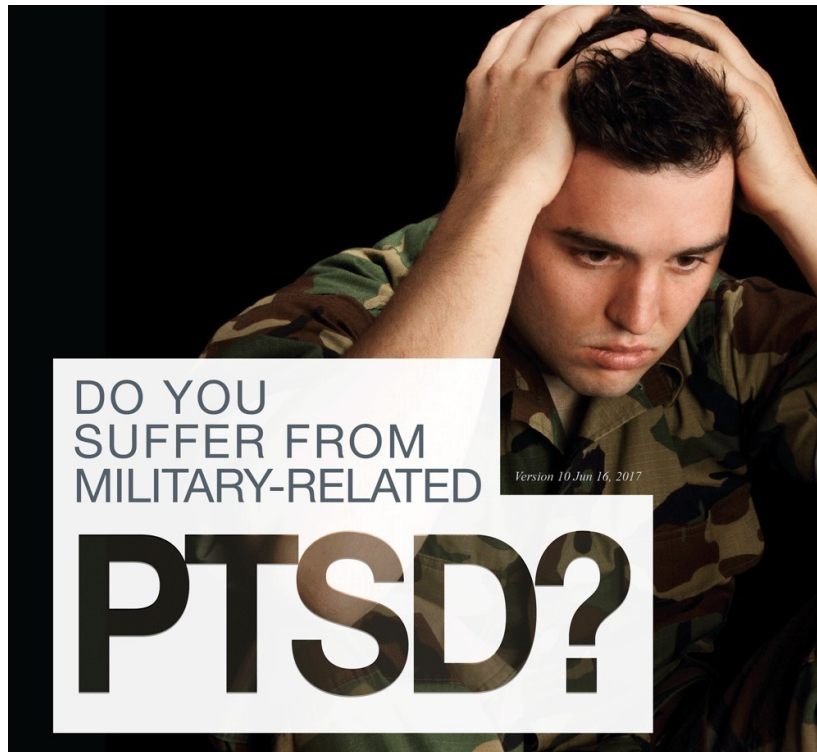


**Blended Retirement Enrollment  
for Sailors Ending**

The U.S. Navy has issued a reminder to Sailors eligible to opt-in to the Blended Retirement System (BRS) that the BRS enrollment period ends Dec. 31. Sailors can enroll in BRS via [MyPay](#). Opt-in eligible Sailors who decide not to enroll in BRS will remain in the current 'legacy' retirement system. Command leaders are responsible for ensuring opt-in eligible service members are prepared to make an informed financial decision prior to the closure of the opt-in window. ## **VA Presumptive AO Diseases Update - Hypertension Recommended**

New research linking veterans' high blood pressure with wartime exposure to chemical defoliants could



dramatically expand federal disability benefits for tens of thousands of Vietnam-era troops. The findings, from the National Academies of Sciences, Engineering and Medicine, conclude that “sufficient evidence” exists linking hypertension and related illnesses in veterans to Agent Orange and other defoliants used in Vietnam, Thailand and South Korea in the 1960s and 1970s. They recommend adding the condition to the list of 14 presumptive diseases associated with Agent Orange exposure, a group that includes Hodgkin’s Disease, prostate cancer and Parkinson’s Disease. That’s an upgrade from past research that showed a possible but not conclusive link between the toxic exposures and high blood pressure problems later in life.

If Veterans Affairs officials follow through with the recommendation, it could open up new or additional disability benefits to thousands of aging veterans who served in those areas and who are now struggling with heart problems. Veterans who struggle with high blood pressure issues are eligible for health care at VA facilities. But the illness is eligible for disability benefits in only select cases. Adding an illness to VA’s presumptive list means that veterans applying for disability benefits need not prove that their sickness is directly connected to their time in service. Instead, they only need show that they served in areas where the defoliant was used and that they now suffer from the

diseases.

That's a significant difference, since proving direct exposure and clear health links can be nearly impossible for ailing veterans searching for decades-old paper records.

A change in the designation of hypertension by VA could also add significant new costs to the department's disability payout expenses. In 2010, when then Veterans Affairs Secretary Eric Shinseki expanded the list of presumptive illnesses for Agent Orange exposure to include ischemic heart disease and Parkinson's, the department estimated additional costs of more than \$42 billion over a decade. It's unclear how many veterans suffer from high blood pressure and would be eligible for disability payments if the change is made. In a statement, VA spokesman Curt Cashour said the department "is in the process of evaluating this report and appreciates the work" of the group.

Regardless the cost, officials from the Veterans of Foreign Wars are already calling for VA officials to move ahead with adding hypertension to the list. "There is no doubt in anyone's mind that Agent Orange made veterans sick, it made their children sick, and it brought pain and suffering and premature death to many," VFW National Commander B.J. Lawrence said

in a statement. “Even though it’s been a half century since they were exposed, the results of that exposure is something they continue to live with daily.” The new study is available at the National Academies Press website.

## **Air Reserve Revises Medical Waiver Process**

The Surgeon General's Office of the Air Force Reserve Command (AFRC) is revitalizing the medical waiver adjudication process from the top down. The office recently tested a new process where wing commanders have the authority to allow members to continue serving, in a full or limited range, while his or her waiver is being adjudicated at headquarters. The commander will review the member's records and make the decision in conjunction with a local medical provider's recommendation. Tests are being completed and evaluated and will be discussed by AFRC leadership as to whether the process should be rolled out command wide or if more information is needed.

## **Generational Health Effects of Serving in the Gulf War**

## **VA Realigns Health Programs**

The Department of Veterans Affairs (VA) plans to realign several programs within its Veterans Health Administration (VHA) into four offices. A requirement of [Executive Order 13781, Comprehensive Plan for Reorganizing the Executive Branch](#), the realignment, which began Nov. 25, is designed to enhance quality care for Veterans by improving coordination of services in the areas of population health; education and training of health care professionals; research, academic affiliations; engineering services; and human resources (HR). Population Health will consolidate six programs into one new office. HR will merge four headquarters-based HR groups with similar functions into one office.

**VA Researchers Named TIME  
Magazine's 50 Most Influential  
People**

Two scientists conducting research with VA, Dr. Ann McKee and Dr. Tony Wyss-Coray, were named to TIME Magazine's list of the [50 most influential people in health care](#). McKee works at the VA Boston Healthcare System as chief of neuropathology and is the director of VA's brain bank. Her research is focused on identifying and understanding chronic traumatic encephalopathy (CTE) — a degenerative condition caused by repeated brain injuries. Wyss-Coray works in Palo Alto, Calif., as a senior research scientist and associate director of the Center for Tissue Regeneration, Repair and Restoration. He is also a professor of neurology and neurological sciences at Stanford University. ## **Coast Guard Needs More Icebreakers**

The VFW was at the National Press Club yesterday to hear Coast Guard Commandant Adm. Karl Schultz say that if the United States wants to protect its national security interests in the Arctic, it needs to fund more ships for the U.S. Coast Guard, especially icebreakers. Schultz said the rise of Russian and Chinese influence in the region is troubling, given the rich natural resources like natural gas, oil, minerals and fish, as well as the two countries' accelerated building of icebreakers. China is estimated to have seven icebreakers in commission or under construction. Russia is estimated to have more than 40 in service or under construction. Canada, which is second only to Russia in landmass inside the Arctic Circle, has 17. A Department of Homeland Security analysis in 2013 concluded that the Coast Guard needs six icebreakers — three heavy and three medium ships. The U.S. Coast Guard today has only two icebreakers — one heavy and one medium. Coast Guard funding is currently in a part of the fiscal 2019 budget that has yet to be finalized. **Agent Orange Case – Gray v. Wilkie Certified to Supreme Court**

On Friday November 2, 2018, the Supreme Court of the United States granted certiorari in the veteran's case Gray v. Wilkie. The justices agreed to address an issue involving whether the U.S. Court of Appeals for the Federal Circuit has jurisdiction to hear pre-enforcement litigation of VA rules set forth in its adjudication manual known as the M21-1. In February of 2016, VA published a Memorandum of Changes, announcing a change to its interpretation of the Agent Orange Act by revising the M21-1 Manual. This revision held that only veterans who set foot on Vietnam soil or served in the country's inland waterways would be presumed to have been exposed to Agent Orange. Mr. Gray sought pre-enforcement review of this matter in the Federal Circuit. However, the Federal Circuit held that it lacked the jurisdiction to review VA interpretive rules if VA published them in its M21-1 Manual. The Supreme Court justices will review the lower court's ruling.

## The Next 'Air Force One' Office Gets New Name

The Air Force office responsible for the acquisition of the VC-25B fleet (more commonly known as the next Air Force One) recently changed its name from the Presidential Airlift Recapitalization Directorate to the Presidential and Executive Airlift Directorate. The new Directorate comprises approximately 300 employees located at Wright-Patterson Air Force Base and Tinker AFB and is responsible for the life cycle management of the VC-25B and the VC-25A (the current Air Force One) as well as the C-12, C-21, C-32, C-37, C-40, and E-4B.0 The directorate is also working to replace the E-4B National Airborne Operations Center, the Navy's E-6B Airborne Command Post, and the C-32A executive aircraft. **Agent Orange Testing and  
Storage Locations: U.S.  
Government Accountability Office  
Releases Report**

The United States Government Accountability Office (GAO) released a report focusing on the actions needed to improve the accuracy and communication of information regarding testing and storage locations of Agent Orange outside of Vietnam. This report examines (1) information the federal government has about the procurement, distribution, use, and disposition of Agent Orange; (2) DoD and VA efforts to make information about where Agent Orange and its components were tested and stored available; and (3) challenges associated with Agent Orange testing. Overall, GAO found that DoD's official list of herbicide testing and storage locations outside of Vietnam lacks clarity in descriptive information; omits both testing and storage locations; and omits additional time periods covered by testing events. At the conclusion of its report, GAO makes six recommendations: four to the Secretary of Defense and two to the Secretary of Veterans Affairs. These recommendations focus on developing a process for updating the list and communicating this information to veterans and the public, and developing criteria for what constitutes a location that should be included on the list.

## **Update on VA's Benefits Delivery at Discharge Program**

The U.S. Department of Veterans Affairs' Benefits Delivery at Discharge (BDD) program has made significant improvements in disability claim processing over the past year, with most service members who submitted claims through the program receiving decisions within 30 days of discharge. BDD allows service members to file a claim for disability between 90 and 180 days prior to discharge from active duty, which provides time for paperwork review and medical exams prior to leaving. By participating in BDD, service members ensure that their disability medical exams become part of their service treatment record and that service connection for their conditions may be established as early as possible. **Army Cpl. DeMaret M. Kirtley** was a member of Battery A, 57th Field Artillery Battalion, 31st Regimental Combat Team, 7th Infantry Division. In late

November 1950, his unit was assembled with South Korean soldiers in the 31st Regimental Combat Team on the east side of the Chosin River, North Korea, when his unit was attacked by Chinese forces. Kirtley was reported missing in action on Dec. 6, 1950, when he could not be accounted for after the withdrawal. Interment services are pending. [Read about Kirtley.](#)

**Marine Corps Sgt. Meredith F. Keirn** was a light machine gun section leader for Company F, 2nd Battalion, 7th Marine Regiment, 1st Marine Division. In late November 1950, he was reported to have been killed while defending a hill overlooking the Toktong Pass, a critical main supply route between the villages of Hagaru-ri and Yudam-ni, North Korea. His remains were reportedly buried at the base of “Fox Hill,” in the Toktong Pass, but they could not be recovered following the war. Interment services are pending. [Read about Keirn.](#)

**Marine Corps Reserve Sgt. Johnson McAfee** was a member of Company F, 2nd Battalion, 7th Marine Regiment, 1st Marine Division, Fleet Marine Force. In late November 1950, his unit was engaged in heavy fighting against units of the Chinese People's Volunteer Forces in North Korea. McAfee was reported to have been killed in action in the vicinity of the Chosin Reservoir. His remains were buried at the base

of “Fox Hill,” in the Toktong Pass, but they could not be recovered following the war. Interment services are pending. [Read about McAfee.](#)

**Army Pvt. Floyd A. Fulmer** was a member of Company A, 1st Battalion, 110th Infantry Regiment, 28th Infantry Division. On Nov. 14, 1944, he was reported as missing in action after fierce combat in the Raffelsbrand sector of the Hürtgen Forest, near the village of Simonskall, in Germany. On Nov. 15, 1945, the War Department declared him deceased. Interment services are pending. [Read about Fulmer.](#)

**Army Pvt. Harry W. Wilder** was a member of Company B, 1st Battalion, 110th Infantry Regiment, 28th Infantry Division. On Nov. 25, 1944, his company was deployed as direct fire support for American infantrymen attacking the town of Grosshau. Two tank destroyers and six tanks, including the M10 tank destroyer Akers was on, were destroyed in the fighting. He was killed during the battle, though his status was initially listed as missing in action. On Dec. 21, 1944, his status was amended to killed in action. Interment services are pending. **Army Cpl. Joseph Akers** was a member of Company C, 803rd Tank Destroyer Battalion, participating in intense fighting in the Hürtgen Forest. On Nov. 14,



1944, he was reported as missing in action after fierce combat in the Raffelsbrand sector of the Hürtgen Forest, near the village of Simonskall, in Germany. On Nov. 15, 1945, the War Department declared him deceased. Interment services are pending. [Read about Akers.](#)

**Army Air Forces Capt. Lawrence E. Dickson** was a pilot with the 100th Fighter Squadron, 332nd Fighter Group, in the European Theater. On Dec. 23, 1944, Dickson departed Ramitelli Air Base, Italy on an aerial reconnaissance mission and sustained an engine failure during his return flight. According to witnesses, Dickson's plane had rolled over with the canopy jettisoned. He was not observed ejecting from the plane.
