Over the past few months we've received numerous E-Mails from Veterans on the issue of travel pay reimbursement.

This topic has been a hot one for several years now, and if memory serves me right without having to do a ton of back newsletter research pay was reduce at one point, then it was changed again but members of Congress get a reimbursement at a higher value than Veterans do, and this too is not acceptable.

We have a team of very knowledgeable Veterans working on a letter which once done, all edits completed we will distribute both via the Newsletter, all our groups on MEWE, and several other outlets where we can reach as many Veterans as possible.

Then you will be able to copy and paste into a letter or E-Mail and send off to your Reps in DC. In addition we will upload a PDF version to our website so others can download and do the same thing, and again you don't have to be a Veteran to help and participate.

Due to limitation of space in the Newsletter, we can't go into a lot of detail, but the proposed change in the use of the VA ID card will help make the process a lot easier, simpler and faster. No forms to fill out, no VA Staffer to deal with, just scan your VA ID card as you do now in the Kiosk, and boom all done.

This will also greatly reduce the chances of fraud which we've all seen in the past dozen or so years.

Down in various locations in this newsletter there are several calls to **TAKE ACTION** on several pieces of legislation and we sincerely encourage

everyone, please send out these prewritten letters to your Reps in DC.

It only takes a couple of minutes of your time, and again even civilians can do this as well to help all our Veterans.

Two of sincere need to be brought to the floor, voted on and passed is HR 303 Retired Pay Restoration Act and the second is HR 553 Military Surviving Spouses Equity Act.

These two bills would reverse a long time practice of the Government actually STEALING benefits from our Veterans and Widows alike amount to thousands annually for each.

And I'd also like to ask you to refer back to prior newsletters for the last two months, and call your Reps in DC on those bills too!

In future newsletters we will try and keep a running list of active bills needing desperate attention so you can remind your Reps about those needing to be brought to the House floor, passed, sent to the Senate floor, passed and then signed by President Trump!

With your help, we can make change, but in order for this to happen, we need thousands upon thousands of Veterans and civilians alike to hound our Reps constantly, as they say the squeaky wheel gets the grease, so lets make one hell of a lot of noise!

In following up on the trained medical care staff shortage of 49,000 within the VA, it doesn't seem like Secretary Wilkie is taking much action there, and no foreseeable signs of any action to be taken to correct this deficit.

They'd rather waste twice as much money sending you to private doctors and clinics, only for Veterans to find out their spinning their wheels and not getting any where.

Purple Heart Recipients Will Move to Front of Line for VA Claims

Purple Heart recipients will soon take priority in the queue for Department of Veterans Affairs claims adjudication, VA Secretary Robert Wilkie announced Feb. 26. The change is in "recognition of wounds taken in battle," he said. Starting April 1, veterans who have earned the Purple Heart and are submitting initial disability compensation claims will be added to the existing list of categories that receive priority processing within the Veterans Benefits Administration. The change is among the many improvements the department is making as part of the claims and appeals modernization effort. H.R. 303, the Retired Pay Restoration Act

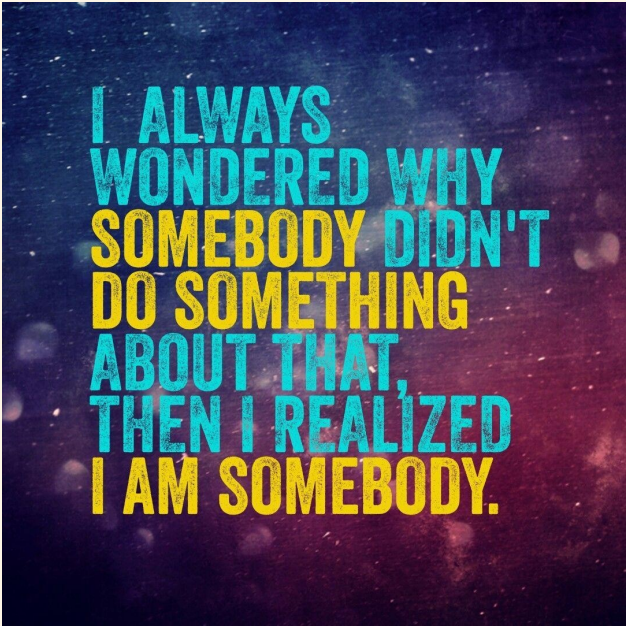
On January 8, 2019, Representative Gus Bilirakis (FL) introduced H.R. 303, the Retired Pay Restoration Act.

This bill would extend concurrent receipt authority to longevity retirees with service-connected disabilities rated less than 50 percent disabling. Under current law disabled veterans with longevity retirement from active military service who are also in receipt of a Department of Veterans Affairs (VA) disability determination of 50 percent or higher may retain both military retirement pay and their compensation.

DAV strongly supports H.R. 303 as it would end the unfair policy of forcing many military longevity retirees to forfeit some of their retired pay in order to receive equal amounts of disability compensation from the VA. This legislation is in accord with DAV Resolution No. 104 and would eliminate concurrent receipt for all longevity retirees.

**Judge Rules Men-Only Military Draft
Unconstitutional**

A federal judge has ruled that a men-only draft is unconstitutional, but he stopped short of ordering the Selective Service System to register women for military service. The Houston judge sided with a San Diego men's advocacy group that challenged the government's practice of having only men sign up for the draft, citing sex discrimination in violation of the Fifth Amendment's equal protection clause. The ruling does not order the federal government to change its policy on who must register, nor does it make any recommendation to Congress, which would have to change the laws governing the Selective Service System to require women to sign up. DoD/VA EHR Update

Still Working Out How to Create Single HER: The Departments of Defense and Veterans Affairs are still trying to figure out how to best align their agencies' respective plans to create a common Cerner electronic health record system. Speaking on 13 FEB at the HIMSS19 conference in Orlando, DoD and VA program officials said coordinating their activities to ensure interoperable EHR systems is a work in progress, emphasizing that the agencies continue to discuss an optimal organizational design that will facilitate coordinated decision-making and oversight when it comes to governance.

Toward that end, the DoD and VA Interagency Program Office is working to establish joint EHR modernization governance bodies to foster coordination and improve communication between the departments. “We can’t talk enough about the work that the Interagency Program Office has done to ensure that the DoD and VA are aligning around commercial standards and to also be able to provide a consolidated input between basically the two largest federal healthcare providers,” Stacy Cummings, program executive officer for Defense Healthcare Management Systems, told a HIMSS audience.

Cummings noted that late last year Defense Secretary James Mattis and VA Secretary Robert Wilkie signed a joint statement committing to the implementation of a single, seamlessly integrated EHR that “maximizes commercial health record interoperability” by sharing data between the two agencies as well as community healthcare providers. The purpose of the document signed by Mattis and Wilkie was to “demonstrate the commitment of both the DoD and the VA to the success of this electronic health record deployment,” according to Cummings. To make decisions and execute them jointly, she added that

the agencies have put together a working group to create synergies and efficiencies. “We’re making great progress—we’re looking at risk and technical and programmatic functions,” she said. “Having greater synergy will reduce the risk to both of our programs.”

While DoD and VA have “spent a lot of time” sharing information and lessons learned, Cummings acknowledged that the two agencies “can benefit from being even closer than we are today.” Last year, the VA awarded Cerner a \$10 billion EHR modernization contract—one of the largest IT contracts in the federal government—to replace the agency’s decades-old Veterans Health Information Systems and Technology Architecture. In 2015, DoD awarded a \$4.3 billion contract to prime contractor Leidos to modernize the military’s EHR system with Cerner’s Millennium platform. According to Cummings, the two agencies will share a data center hosted at Cerner’s Kansas City headquarters in a “single instance” enclave, with the VA taking advantage of investments DoD has already made in that commercial data center.

DoD’s Cerner system—called MHS GENESIS—has so far been deployed at four military sites in the Pacific Northwest . The VA’s planned acquisition

calls for aligning, as much as possible, the deployment and implementation of its EHR system with ongoing DoD rollout activities in order to achieve efficiencies. “In our deployment schedules, we’re looking to be as coordinated as possible where it makes sense,” said Cummings. “But, at the same time, I don’t think either one of us is interested in slowing down our plans to deploy on our timelines.” In December, DoD authorized MHS GENESIS to proceed with six “waves” of deployment, starting in the fall of 2019. Wave 1 sites include Naval Air Station Lemoore, Travis Air Force Base, Mountain Home Air Force Base and the U.S. Army Health Clinic Presidio—all of which are the first military facilities to field the standard baseline of MHS GENESIS.

Cummings observed that one of the biggest lessons learned from DoD’s deployment of MHS GENESIS to initial operational capability sites was that “this is not an IT implementation—this is a change management program.” “DoD has already gone live at facilities—we are still educating our clinicians, and that’s a tough chore,” said John Windom, executive director of the VA’s Office of EHR Modernization, at the HIMSS19 conference. “We want to make sure we’re judicious in the way

we move forward such that our change management strategies that we're both employing will take hold as appropriate. This is about the end user—the person that's required to use Cerner Millennium.”

“It's a hard sell because people are used to what they're used to, regardless of how arduous it may be to use or how cumbersome,” added Windom, referring the VA's legacy VistA system which is popular with the agency's clinicians. At the same time, Windom pointed out that DoD and VA have “two different patient populations” that the agencies are trying to both serve using a single, seamlessly integrated EHR. “That's a tremendous challenge that we don't take lightly,” he concluded.

H.R 445, Help Hire Our Heroes Act

On January 10, 2019, Representative Julia Brownley introduced H.R. 445, the Help Hire Our Heroes Act. This bill would amend the VOW to Hire Heroes Act of 2011 to make permanent the Veterans Retraining Assistance Program (VRAP).

The VRAP was started in 2012 to provide training assistance to unemployed veterans between the ages of 35 and 60 who are no longer eligible for the

GI Bill. It provided up to 12 months of training benefits at community colleges and technical schools in occupations that the Department of Labor has identified as "high demand." Since funding for this program expired in March 2014, the VA has not been able to enroll new veterans in VRAP. This program gap means that thousands of older, qualified veterans have been unable to access the resources which could help them find work.

This bill would strike the end dates of the Veterans Retraining Assistance Program and would replace it with year to year authorizations. This bill is in accord with DAV Resolution No. 190 which seeks adequate funding and permanency for veterans' employment and training programs.

Commissary Curbside Delivery Adds Location, Service Fee

The commissary's curbside grocery pickup program started its expansion to new locations Friday, while also announcing the closure of the three current locations — and adding a service fee. The program, known as Click2Go, has been available for free through a pilot program at three commissaries — at [Fort Lee](#), Virginia; [Offutt Air Force Base](#), Nebraska; and [Travis Air Force Base](#), California — since 2013. Now, the system has added its first new location: [Fort Eustis](#), Virginia. But at the same time, officials announced that the Fort Lee, Offutt and Travis locations will be shuttering June 1. And although the service at Eustis will be free for a promotional period through the end of March, shoppers there will pay a \$4.95 service fee per order starting April 1, officials said in a release. 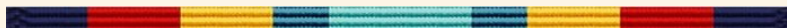

**Gulf War Memorial Moves Forward with
Site Dedication**

The dedication of a first-of-its-kind national memorial to veterans of the first Gulf War on Feb. 26 in Washington, D.C., drew dignitaries including former Vice President Dick Cheney, who oversaw Operations Desert Storm and Desert Shield in his role as defense secretary. The Pentagon lists 383 U.S. troops as having been killed in action in Desert Shield/Desert Storm. The site is on the National Mall, off Constitution Avenue and by the Vietnam Veterans Memorial. VA Asks for Comment on Proposed Access Rules

The VA's proposed new access standards were published in the Federal Register late last month. The period for public comment continues until March 25. With the proposed rules, the wait-times standards would be 20 days for primary and mental health care, and 28 days for specialty care, from the date of request. The new rules would also be based on drive times rather than mileage. Veterans would be eligible for private care if they faced a 30-minute drive to the nearest VA facility. The drive times go up to 60 minutes, and the wait times to 28 days, for certain types of specialty care. [Veterans can comment by visiting the Federal Register website](#). 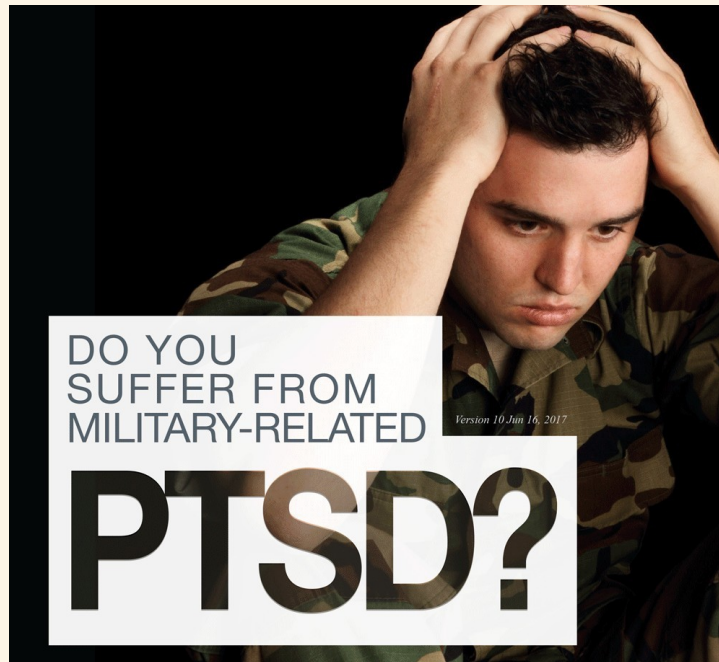

How to Get a Historic M1 Rifle and Other Military Surplus Weapons

The Civilian Marksmanship Program is sold out of surplus 1911 .45 caliber pistols for this year, but the nonprofit still has M1 rifles to sell. The U.S. Army allowed [8,000 1911s to be transferred to the CMP for sale and distribution](#) as part of the Fiscal 2018 National Defense Authorization Act, or NDAA. Look what happened overnight at the VA....

While you were sleeping last week, the VA did this:

NOTE: As of February 14, 2019,* , both VA Form 21-526, Veterans Application for Compensation and/or Pension, and VA Form 21-526b, Veteran's Supplemental Claim for Compensation, will be discontinued from use. These forms will be removed from VA forms websites and will no longer be accepted by our intake centers. If these forms

are received after February 14, 2019, send a VA Form 21-526EZ, Application for Disability Compensation and Related Compensation Benefits, to the claimant to be filled out accordingly and returned.

It's all part of the changeover from the old Legacy VA Appeals process to the new "Modernized" Appeal Process.

H.R. 444, Reduce Unemployment for Veterans of All Ages Act of 2019

On January 10, 2019, Representative Julia Brown (CA) introduced H.R. 444, the Reduce Unemployment for Veterans of All Ages Act of 2019.

Currently, veterans with service-connected disabilities or other employment handicaps are able to receive career development services through VA's Vocational Rehabilitation and Employment

program up to 12 years after they separate from military service. H.R. 444 would remove the limiting 12-year-period for eligibility.

In agreement with DAV Resolution No. 310, we support this legislation to eliminate the 12-year-period of eligibility. By removing the limited eligibility period, H.R. 444 will provide veterans the flexibility to receive the support they have earned and deserve throughout their lifetime and thus help reduce unemployment for service-connected veterans.

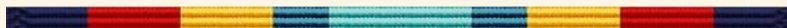

National Guard Tests Threat Response System

Troops with the Maryland and Delaware National Guard are testing a new system for threat response that can be dispatched to potential contamination sites, according to an Army release. The Analytical Laboratory System Increment 1 A1 is designed to be moved via C-5 or C-17 cargo transport aircraft, and from ships to the shore by a landing craft air cushion vessel, or LCAC. The system is supposed to detect and identify a number of toxins; current testing is intended to determine whether its technologies are "effective, suitable and survivable on the modern battlefield." The five-day test will allow soldiers to take various chemical and biological samples and run them through the system's analyses. The samples will then be processed off-site, with analysis and mitigation information provided to the incident commander. Read more at [Army.mil](https://www.army.mil).

Health Initiative Targets Guard Members


A new National Guard Bureau initiative is intended to better provide behavioral health care to members of the Guard living in remote locations. The Veteran Center Outreach Initiative will create opportunities for counseling to those who live far from military medical facilities, according to a release. Mobile vet center staff members belonging to the Department of Veterans Affairs' Readjustment Counseling Service will visit full-time and part-time Guard members during training as part of the effort to offer services at convenient times. The counselors coordinate with Guard behavioral health representatives at state and unit levels to offer services. Tuskegee Airman Posthumously Honored after Decades MIA

One of the famous Tuskegee Airmen who has been missing in action since December 1944 will finally get a burial in Arlington National Cemetery after his remains were identified months ago. Capt. Lawrence E. Dickson's plane crashed in Europe during service in World War II, according to a recent release. His remains were identified using DNA tests; officials said he was the first identified out of more than two dozen Tuskegee Airmen MIA during the war. Dickson, a P-51D pilot with 100th Fighter Squadron, 332nd Fighter Group, had departed Ramitelli Air Base, Italy, for a reconnaissance mission over Prague when his aircraft suffered engine failure and went down. His remains were recovered when a crash site excavation was conducted more than seven decades later. He is set to be buried at Arlington on March 22. H.R. 553, Military Surviving Spouses Equity Act

On January 15, 2019, Congressman Joe Wilson introduced H.R. 553, the Military Surviving Spouses Equity Act. This bill would eliminate an unfair offset placed on many surviving spouses of service members who pass away during active duty or spouses of retirees who die of a service-connected disability.

Currently, purchased Survivor Benefit Plan (SBP) annuities are offset by the amount of any benefit payable under the VA Dependency and Indemnity Compensation (DIC) program. SBP is not a government gratuity benefit; rather, it is a type of insurance purchased out-of-pocket by military retirees for their survivors while DIC is a VA benefit intended to provide spouses of veterans who died from a service-connected condition some semblance of financial security. Thousands of survivors of military retirees are adversely affected by this unfair offset between SBP and DIC benefits.

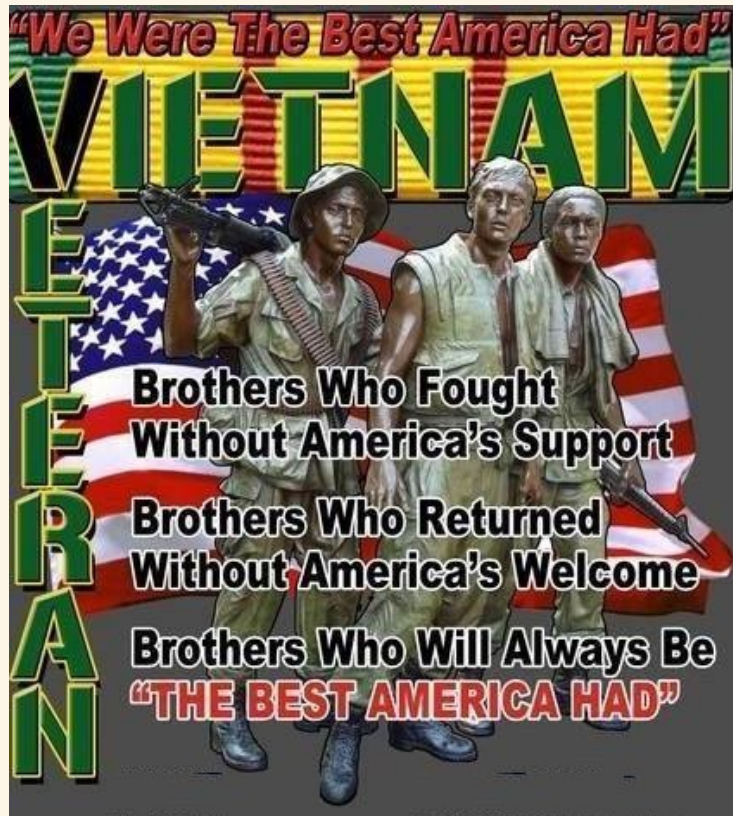
Upon the retiree's death, the SBP annuity is paid monthly to eligible beneficiaries; however, if a surviving spouse is also entitled to DIC, the SBP benefit is reduced by the amount of the DIC benefit (currently \$1,283.11 per month). In general, when DIC benefits are payable but the monthly rate is equal to, or greater than, the monthly SBP payment amount, beneficiaries lose the entire SBP payment.

This bill would eliminate the offset and allow surviving spouses to receive both the purchased SBP annuities and their earned DIC benefits. This bill is in accordance with DAV Resolution No. 014, which calls for Congress to repeal the offset between SBP annuity payments and DIC payments.

National Roadmap to Empower Veterans and End Veteran Suicide

On Tuesday, VFW National Commander B.J. Lawrence joined President Donald J. Trump at the White House for the signing of an executive order that commissions an inter-agency Veteran Wellness, Empowerment, and Suicide Prevention Task Force. The task force will develop a

“Roadmap to Empower Veterans and End a National Tragedy of Suicide” that enables cooperation between nation, state, and local services to integrate services for veterans. “Suicide is a serious issue,” said VFW National Commander B.J. Lawrence. “We must do everything possible to save the 20 veterans who take their own lives every day, as well as encourage the 14 of every 20 who are not enrolled in the VA to get enrolled. The VFW agrees that addressing this issue takes a collaborative effort among federal agencies and applauds the creation of a taskforce for that purpose,” he said. “The answer to the veterans suicide crisis is not in Washington, but through increased federal funding and community partnerships everyone can have an impact. Through the VFW Mental Wellness Campaign, VFW Posts throughout the world have been helping to destigmatize mental health by educating veterans and their families on the signs of emotional distress and informing veterans of resources in their local communities. The VFW stands prepared to assist in every way possible.”

DOD 'Tenant Bill of Rights'

On Thursday, the three service secretaries and the Joint Chiefs testified before the Senate Committee on Armed Services. The hearing focused on accountability to provide safe military housing and other building infrastructure to service members and their families. To ensure service members and their families have safe and adequate living conditions and proper legal protections, the service secretaries have created a Tenant Bill of Rights. It would provide a major overhaul of the military's two-decade old housing privatization program. Key provisions include: requiring the military to renegotiate contracts with the real estate companies and bondholders who back the deals; will impose new controls on the landlords operating on military bases; allow military base tenants to withhold rent payments from landlords if housing troubles persist; and guarantee tenants' access to housing advocates when they dispute landlords, or allow them to move, at no cost, to "suitable lodging" if repairs aren't made. Navy Reserve Seaman 2nd Class Deward W. Duncan was assigned to Aviation, Construction, Ordnance, Repair, Navy Fourteen, Standard Landing Craft Unit 4, when a Japanese air raid on Betio Island, Tarawa Atoll, Gilbert Islands, dropped a bomb near his tent. Duncan was killed Jan. 12, 1944, and was reportedly buried the same day in Cemetery #33. Interment services are pending. [Read about Duncan.](#)

Marine Corps. Cpl. Claire E. Goldtrap was assigned to Company A, 2nd Amphibian Tractor Battalion, 2nd Marine Division, Fleet Marine Force, which landed against stiff Japanese resistance on the small island of Betio in the Tarawa Atoll of the Gilbert Islands. Over several days of intense fighting at Tarawa, approximately 1,000 Marines and sailors were killed and more than 2,000 were

wounded. Goldtrap died on the first day of the battle, Nov. 20, 1943, during the first wave of the assault. Interment services are pending. [Read about Goldtrap.](#)

Navy Reserve Aviation Machinist's Mate 1st Class John O. Morris was a member of Carrier Aircraft Service Unit (CASU) 17. In November 1943, American units landed against stiff Japanese resistance on the small island of Betio in the Tarawa Atoll of the Gilbert Islands, in an attempt to secure the island. On Dec. 16, 1943, Morris was killed during the test-firing of a machine gun. The weapon accidentally discharged, killing Morris. He was buried on the island, in Cemetery #33. Interment services are pending. [Read about Morris.](#)

Army Sgt. Cread E. Shuey was a member of Battery G, 60th Coast Artillery Regiment, serving in the Philippines, when Japanese forces invaded the Philippine Islands. Shuey was among those reported captured, and one of the thousands who were eventually moved to the Cabanatuan POW camp. More than 2,500 POWs perished in this camp during the remaining years of the war. Interment services are pending. [Read about Shuey.](#)

Navy Fireman 1st Class Angelo M. Gabriele was

stationed aboard the USS West Virginia, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft on Dec. 7, 1941. The ship sustained multiple torpedo hits, which caused it to quickly sink, but not capsize. The attack on the ship resulted in the deaths of 106 crewmen, including Gabriele.
