## **This-N-That**

I'd like to wish everyone a belated Happy New Year with hope and expectation of more and better benefits to come and more claims and appeals will progress and be approved more quickly.

I've spent roughly 90+ hours to do some intense research on benefits by state nationwide. I feel that if there are benefits out there that you might qualify for, then why not apply for them.

I've changed the category "Benefits" in both web links and documents library so that there is one major category called Benefits, then inside each of those are two more categories, one labeled "VA" and one labeled "State" in the hopes it will make it easier and not forcing you to dig to find what you want.

Under the "State" sub-category you will find each state listed and the benefits those states offer. And although it's not completed yet there has been a good start on them.

There are still a little more than 950 more links that need to be added, and roughly between 50-100 documents to be added by state.

So please stop by the website, check the web links and the documents library under the benefits category, look for your state and see what you might be able to qualify for! Why not reach out and grab all you can, our country does owe you and not everything you might qualify for comes from the VA.

In doing my homework on this area the one thing I

found which almost all states offer is a reduction in property taxes for homeowner Veterans, and this is one huge benefit. You could receive a deduction of up to \$3,000.00 on your annual property taxes. Another is reduced or free DMV fees on both vehicle registrations and drivers licenses and many states offer Veteran Preference noted on your drivers license card. Than in turn can also bring you discounts in many places you shop.

So please give it a shot, and follow up again next week and the following week as more will be being added.

On another note, Homeless Mini Home Villages seems to be an issue with some.

One issue seems to be the amount of "control" by those who run these Mini Home villages. Some Veterans aren't interested in control. Well the control is designed to be able to offer you a place to live, but yes, there are restrictions, all meant to help get you back on your feet, become more independent and self sufficient.

It's not meant to be nor were they designed to be a permanent "gift". You do need to keep certain requirements such as attending group mental health meetings, that you must remain clean and sober of any drugs and alcohol, some have job retraining programs which you must attend one of your choosing, that you must be available for random drug and alcohol screening.

In my humble opinion, these "requirements" are not a lot to be asking in order to provide you a place to live and to learn to become self sufficient and independent again. And many of these programs go from six months to two years, all dependent on your personal level of need for help.

And once you've moved on, that opens up a slot for the next Veteran in need. And most of these Mini Home Villages are being supported by civilian donors, not the Veterans Affairs, however, the VA could take a serious lesson from these private groups.

West Los Angeles VA is a prime example, and has been for well over the past eleven years.

They've leased out Veteran Land to private parties, they have 12 historic buildings that could be easily renovate and cleaned up from asbestos and house no less than 24 Vets per building, plus there is a huge amount of land available to construct more buildings with mini apartments, or even build mini homes.

In my opinion mini homes are the best route to take as there are many companies out there who are constructing these mini homes for about \$5,000 each, and this also means they come with furniture.

I've been following the homeless Veteran crisis for years, fought on many levels on this issue and no matter what the VA says their continual touting of false information such as there are only 40,000 homeless Vets needs to stop especially when the total still hovers right around 1.5 million.

So as much as I hate to say it, if you're a homeless Veteran, and you refuse to be "controlled" by their rules, please don't complain. Nothing in this life is free, especially when it's meant to help you and they're being provided by

every day taxpayers making donations to ensure you're taken care of.

## **VA Grants Herbicide Benefits for Some (But Not All) Vietnam Veterans**

After a two-decade battle in Congress and in the

courts, the Department of Veterans Affairs has finally begun to adjudicate benefits for some - but not all - veterans who served in waters offshore Vietnam. In a new change to their adjudication manual, the VA will now grant benefits to those veterans who serve in the bays, harbors and territorial sea of Vietnam.

"This may be a good start," said Col. Rob Maness (USAF, Ret.), Executive Director of the Louisiana-based Military-Veterans Advocacy (MVA), "but the battle continues. The new policy specifically exempts those veterans who flew close air support missions and those who served outside of the territorial sea."

MVA led the fight for benefits for these veterans, known as "Blue Water Navy," sailors. In January 2019, MVA won a landmark court case in the Court of Appeals for the Federal Circuit, *Procopio v. Wilkie*, which interpreted the Agent Orange Act of 1991 to include the territorial sea. Congress acted soon after by passing the Blue Water Navy Vietnam Veterans Act of 2019. The law allowed for a stay of benefits, which the VA imposed. MVA went back to court to force an end to the

stay effective Jan. 1, 2020.

"The VA has chosen to interpret the Blue Water Navy Vietnam Veterans Act too narrowly," said Commander John B Wells, (USN, Ret), MVA's chairman of the board and director of litigation.

"The Congressional action was poorly worded and provided ambiguities seized on by the VA to limit coverage. Although the Act did not replace the original law and did not supersede Procopio, the VA's constricted reading effectively does so."

Wells also noted that the legislative history of the Act eliminated coverage for those who flew over Vietnamese territorial sea, but that the VA policy restricts those who flew low-level missions in South Vietnam.

"Often these Air Force and Navy pilots flew through clouds of Agent Orange to perform their mission," Maness noted. "They should be covered."

The policy changes also addressed bases in Thailand where Agent Orange was used on the perimeter. Under the new provision, veterans who



had duties on the perimeter were covered but others were not.

"This policy is way too narrow," said Bill Rhodes, a retired Marine Staff Sergeant and Thailand veteran who joined MVA as Director of Thailand Veterans. "Many of the barracks backed up to the perimeter and personnel who did not have duties on the perimeter slept there. Yet they are not covered. Additionally, vehicles and personnel would track the herbicide into the base interior, increasing the exposure."

Rhodes also noted that the Army Field Manual governing herbicide exposure required a buffer area of 500 meters from spraying. Personnel serving in that buffer area are not covered by the new policy.

Although the policy addressed Johnston Island, it virtually excluded military personnel stationed there. "Although contractors handled the storage," said Brian Moyer, MVA Director of Central Pacific Islands, "military personnel were in the area covered. Johnston Island is a small atoll and the leakage from the steel barrels, stored in the open

salt air, resulted in the exposure of military personnel in the area."

Not covered in the policy change was the island of Guam, where testing has shown the presence of herbicides as late as 1980. MVA currently has a Rulemaking request for Guam pending at the VA.

"We are reviewing our options," said Wells, "and may seek judicial review of this policy."



## **VA to Reach Out to New Veterans**

The Department of Veterans Affairs (VA) is launching a new program called the Solid Start Program. It will inform new veterans about benefits and support services at the VA in an effort to ease transition issues. The VA believes this will help with suicide prevention. These veterans will get three phone calls from the VA. The first call, expected within 90 days of separation from the military, will include an in-depth conversation with veterans about their goals and challenges, to better target what VA services may be of use to them. This program is expected to reach out to more than 200,000 veterans. Subsequent phone calls will check on the veteran's transition progress and answer any questions they may have about available VA benefits and services. Among the programs the callers will discuss, are the free VA mental health resources available for all separating service members during their first year of post-military life—regardless of discharge status or service history.



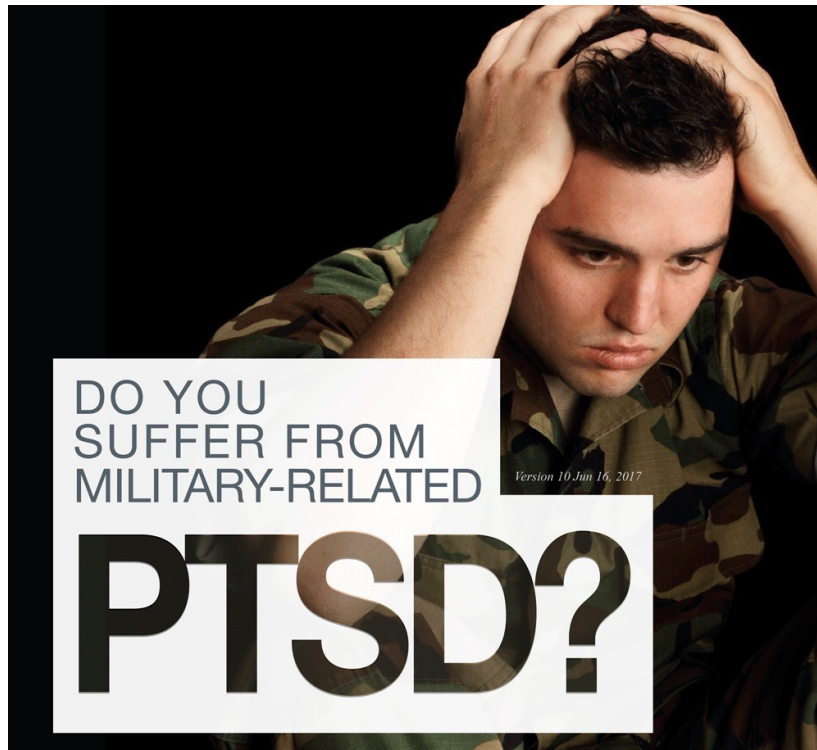

## **DoD Announces BAH Rates for 2020**

The Department of Defense has released the 2020 Rates for Basic Allowance for Housing (BAH), Basic Allowance for Subsistence and Basic Pay. These rates took effect Jan. 1, 2020. BAH rates will increase an average of 2.8 percent. An estimated \$22 billion in BAH payments will be provided to approximately one million service members. The fiscal 2016 National Defense Authorization Act decreased payment to cover

only 95 percent in 2019. The FRA opposed these cuts to BAH payments and is working to restore BAH to 100 percent of housing costs. The FRA also wants to reform enlisted housing standards by allowing E-7s and above to reside in separate homes, track BAH to ensure it is commensurate with actual housing costs, ensure adequate housing inventory and that housing privatization programs are beneficial to service members and their families. BAH rates vary by grade and dependency status.

Housing cost data are collected annually for more than 300 military housing areas in the United States, including Alaska and Hawaii. Basic Allowance for Housing rates are then calculated for each pay grade, both with and without dependents. **Here's the VA's Dependency  
Indemnity Compensation Rates  
Increase for 2020**

The Dependency and Indemnity Compensation (DIC) benefit paid by the Department of Veterans Affairs to survivors of certain deceased veterans will be increasing by 1.6% for 2020. DIC is a monthly benefit paid to eligible survivors of certain deceased veterans. There are two main types, one for surviving spouses and one for surviving parents. The surviving spouse DIC is a congressionally mandated monthly benefit which is adjusted annually based on the Cost-of-Living. Parent DIC is based on the parent's income. Typically, only those parents whose income is below a certain level are eligible. Read more [here](#).



## **Pentagon Ordered to Add Blast Exposure to Troops' Medical Histories**

Congress has directed the Pentagon to document troops' blast exposures in combat and training and include the information in their medical histories to help determine whether they are eligible for treatment and service-connected benefits.

According to language in the \$738 billion defense bill signed into law recently by President Donald Trump, the histories will also "inform future blast exposure risk mitigation efforts of the Department of Defense." Numerous reports and studies by the DoD, the Department of Veterans Affairs, the Centers for Disease Control and Prevention, and others have pointed to links between blast exposure and traumatic brain injury and post-traumatic stress. 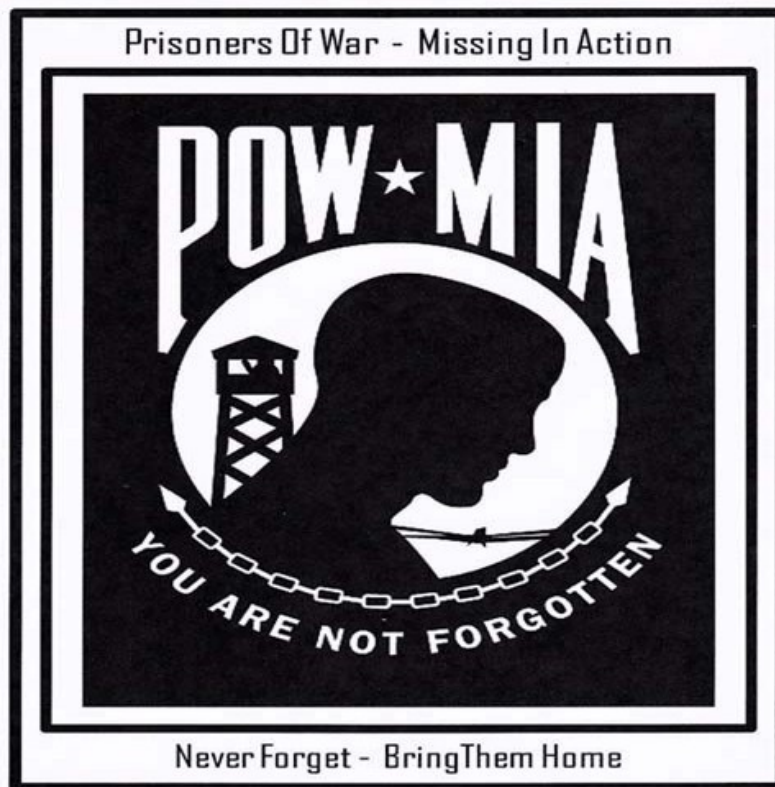
