# This-N-That

Congressman Jeff miller (R-FL) submitted the VA Accountability Act which passed the house with a vote of 256 to 170 even with widespread opposition from federal employee advocates.

This bill would make it easier to fire employees at the Veterans Affairs Department which is long over due. The bill would expand to the VA workforce the authority of the 2014. The employee could file an appeal to the Merit Systems Protection Board within seven days of his or her removal.

Rep. Dan Benishek (R-MI) included an amendment in the bill which would hold VA Managers responsible for implementing recommendations from the IG for improving department operations, and would withhold performance awards (ie: Bonuses) from those who fail to do so.

However, the White House says President Obama will veto legislation that would let the Department of Veterans Affairs fire corrupt or negligent officials, in part because that change would make the VA a less pleasant place to work for federal employees.

The White House said in a <u>statement released late Tuesday</u> that Miller's bill would be unfair to the VA, since it would create a "disparity" between VA workers and officials at other government agencies.

Well in my opinion this is long over due, and if the staff at the various VAMC's can't perform their jobs well, can't provide the best medical care available, then it's time for replacements.

Dr. Gorton is a mental and behavior health physician at the Philadelphia VA Medical Center told a Veteran in response to a post on Face Book regarding gun control "Off yourself, please."

And the VA's response was "we're sorry!"

"Our mission is to provide the highest level of medical and mental health care, which is not reflected in the Facebook post," a VA spokesman told The Washington Times. "The post was totally inappropriate and does not convey our commitment to veterans. We are taking steps immediately to address the situation."

This would be a prime example why an immediate termination would be called for and no red tape. Had this been a civilian situation, termination would have been swift and immediate, no documentation, no judge, no hearing and no appeal!

## 34,000 Vets Lost Healthcare Eligibility

Scott Davis, a program specialist at the VA enrollment center in Atlanta, says 34,000 veterans returning from Iraq and Afghanistan lost their eligibility for healthcare after the VA sat on their applications until they expired. The applications were designated as pending because they lacked income information. However, combat veterans are not required to verify their income when applying for VA benefits. ## VA to Outsource Care

The Department of Veterans Affairs (VA) is moving to outsource care nationwide for up to 180,000 veterans who have hepatitis C. VA has spent weeks developing a dramatic and controversial transition as patient loads have surged and funding has run out. Those efforts were not disclosed until records were released this week to *The Arizona Republic*. Hepatitis C is a serious blood and liver condition that is treated with expensive new drugs that are costing the government billions of dollars. ## VA Chief Counterpunches Over Costs

The Veterans Choice, Access and Accountability Act of 2014, which Congress rushed to pass last summer to address a patient wait-time scandal at dozens of VA hospitals and clinics, spurred VA to broaden access to care. The result was seven million new health care appointments for veterans the past year, but also a flood of new enrollees into VA care, an accounting nightmare for health care administrators and a surprising budget shortfall, which VA officials concede they failed to forecast and which angry lawmakers realize they must repair before going on August recess. If not, VA leaders warn, VA medical facilities will shut their doors.

# New Rule to Protect Vets from Predatory Lenders

The Obama administration and U.S. Department of Defense have issued a new rule to protect veterans from predatory lenders. Included in the amendment to the Military Lending Act is a new rule that says creditors may not charge an annual percentage rate of more than 36% on all consumer credit. The Mount Soledad cross in La Jolla, Calif., is part of a larger memorial, which includes more than 3,700 plaques honoring veterans of various wars. ## Proposed Rulemaking for Selection Process for Private Architectural and Engineering Firms

Sacramento – Notice is hereby given that the California Department of Veterans Affairs (CalVet) proposes to adopt California Code of Regulations Title 12, Division 2, Chapter 7, Subchapter 4, amended Sections 801.1, 803, 804, and 808 concerning the terms, definitions and selection process for private architectural and engineering firms.

CalVet has not scheduled a public hearing on this proposed action. However, CalVet will hold a hearing if it receives a written request for a public hearing from any interested person, or his or her authorized representative, no later than 15 days before the close of the written comment period.

Any interested person, or his or her authorized representative, may submit written comments relevant to the proposed regulatory action to CalVet. The written comment period is now open, and it closes at 5:00 p.m. on September 18, 2015. CalVet will only consider comments received at CalVet offices by that time.

Be sure to pack your medication in your carry-on luggage. While traveling, TRICARE's Nurse Advice Line (NAL) at 1-800-TRICARE (874-2273) can help you decide what type of care you need. A registered nurse can answer your urgent care questions and schedule next-day appointments at military hospitals and clinics if necessary. #### House Passes VA Accountability Act

The House on Wednesday passed a bill that would make it easier to fire employees at the Veterans Affairs Department.

Despite a veto threat from the White House and widespread opposition from federal employee advocates, lawmakers approved in a 256-170 vote the <u>2015 VA Accountability Act</u>, which would give the VA secretary much more flexibility to demote and fire corrupt or poor-performing employees, not just top officials.

The bill essentially would expand to the entire VA workforce the authority of the 2014 Veterans Access, Choice and Accountability Act, which made it easier to get rid of senior executives engaged in wrongdoing at the department.

Under H.R. 1994, the employee could file an appeal to the Merit Systems Protection Board within seven days of his or her removal. MSPB would have to rule within 45 days of the appeal filing. The legislation also would limit the amount of time an employee can be on paid administrative leave to 14 days in a one-year period.

Due process for most of the federal workforce now requires that agencies notify employees within 30 days of an adverse action (including removal), and provide them with seven days to respond and an opportunity to defend themselves.

The bill also would extend the probationary period for new VA employees from one year to 18 months, and allow the secretary to extend that even further.

An amendment included in the bill offered by Rep. Dan Benishek (R-MI) would hold VA managers individually responsible for implementing recommendations from the inspector general on improving department operations, and would withhold performance awards from those who fail to do so.
