We're talking about people who turned in applications and VA said, 'No, go into a backlog because you didn't give us financial information.'"

VA spokeswoman Walinda West confirmed that combat Vets aren't required to provide financial information to be enrolled in health care.

"VA is actively taking action to enroll and further reach out to these Veterans (by telephone and letters) due to the length of time some of these applications have been pending," West said.

But what we believe is this was no human or computer error, but a blatant attack on Veterans to avoid providing benefits or care!

And now that it's in mainstream media, we wonder how long it will take to correct this, if ever!

VA Can Help Veteran Struggling Homeowners

Colleagues and Fellow Veterans,

Thought you'd like to know ... help for struggling homeowners is often closer and more attainable than they think.

Some Veterans experiencing financial hardship may be unaware of the programs and services available to help them avoid foreclosure, even for home loans not guaranteed by VA. It's easy to become discouraged after falling behind and receiving daily collections phone calls. Remember that a mortgage servicer's goal is not to take anyone's home from them. Servicers would much rather see hardships resolved and borrowers resume making payments or otherwise avoid foreclosure. There are many VA resources to help Veterans do those things.

Did you know that the inability to afford your mortgage does not mean that foreclosure is inevitable? Modifying your loan to a more affordable interest rate, being placed on a forbearance plan to obtain additional time if your financial situation is expected to improve down the road, or even deeding the property back to the mortgage servicer are all potential options to avoid foreclosure.

Are you concerned that your property value is so upside-down that you will never get out from under it? A Compromise Sale, or short sale, may be a great option, potentially allowing you to sell the home for less than you owe.

These are only a few of the many options available. If you are more than two payments past due and have a VA home loan, a VA Loan Technician has already been assigned to assist you. If not, or if you do not have a VA loan, knowledgeable VA staff can offer financial counseling to determine how VA can help and what loss mitigation options might work best. If you have a VA loan, VA staff can even speak directly with your mortgage servicer on your behalf.

Possible Repeal of "Cost-Plus-5%" Pricing

Defense officials appear ready to ask Congress to repeal a law that commissaries must sell products at cost plus five percent, a formula that for decades has ensured commissary shoppers everywhere pay the same prices. Officials have drafted a replacement formula that would allow prices to vary from store to store to meet a new twin goal: reducing taxpayer support for commissaries while maintaining still attractive savings for patrons. Variable pricing would seek to keep savings consistent across the commissary system by pegging local commissary prices for a market basket of goods at some target percentage level below prices of "lowest-price" competitors nearby such as Wal-Mart stores.

VA Hospital Dumps Patient Records

An employee at the Hot Springs campus of the VA Black Hills Health Care System in South Dakota (<http://www.blackhills.va.gov>) has thrown into a trash bin the records of more than 1,100 patients that contain Social Security numbers and other personal information. The VA Black Hills Health Care System blamed the breach on an employee who mistakenly tossed the patient files into a dumpster on May 15 during a regular office move. The records were found two days later by another employee who fished them out of the trash and notified hospital security guards. The Department of Veterans Affairs (VA) has alerted the 1,100 military veterans of the breach by letter. The letter informed recipients they could request a free credit report to ensure their personal data was not being misused.

Minnesota Organization Helps Vets

The Pain Free Patriots organization offers free treatments for pain such as muscle and nerve therapy and spinal balancing. Since it was started five years ago, more than 450 veterans have been through the program. The mobile units of Pain Free Patriots come equipped with over \$250,000 in technology. Potential clients must show evidence of military service, either their discharge papers or a military identification, and fill out a one-page questionnaire about their ailments. The veterans are provided grants that average about \$5,000 for their treatments. Tuition Benefits in Connecticut

Veterans who use their service-related tuition benefits to attend the University of Connecticut (UConn) or send their dependents will no longer face a three-year deadline to enroll under the in-state rate, thanks to a new policy. Now, any qualified veterans and dependents whose legal residency is outside of Connecticut and who use veterans' educational benefits can receive the in-state rate at any time after discharge — even many years later. Senior Veterans Showcase Benefits of Sports During National Veterans Golden Age Games

More than 800 Veterans ages 55 and older are expected to compete in the 29th National Veterans Golden Age Games, Aug. 8-12 in Omaha, Neb. The official kick-off starts at 6:30 p.m., August 8 at the CenturyLink Center Arena.

Participants will compete in 14 events including swimming, cycling, horseshoes, bowling, field events and air rifles. Veterans also will participate in four exhibition events, including racquetball, 3-on-3 basketball, bocchia and blind disc golf.

"When it comes to sports, age is just a number," said Department of Veterans Affairs' (VA) Secretary Robert A. McDonald. "VA research and clinical experience shows that physical activity plays an integral role in maintaining good health, speeding recovery and improving overall quality of life. These games also serve as a way for participants to continue in local senior events in their home communities."

The National Veterans Golden Age Games is sponsored by the Department of Veterans Affairs and hosted by the VA Nebraska-Western Iowa Health Care System. The health care system provides care for more than 55,000 Veterans from 101 counties in Nebraska, western Iowa and portions of Missouri and Kansas. The event is open to all U.S. military Veterans ages 55 or older who are currently enrolled for any VA care.

Change to Where Some TRICARE Beneficiaries Obtain Prescriptions

Beginning on Oct. 1, TRICARE beneficiaries will have to obtain refills for certain drug prescriptions through the mail, or at military treatment facilities, according to a [new interim final rule](#) from the Defense Department.

The new policy affects refills of non-generic prescription "maintenance medications," or drugs that people take on a regular basis for chronic conditions, such as high cholesterol or blood pressure. The change does not apply to medications for sudden infections or illnesses. The head of the Defense Health Agency will maintain and update a list of covered medications, available online or by telephone, and agency will contact eligible beneficiaries about the change, stated the rule, published on Aug. 6 in the *Federal Register*.

The change, mandated by the 2015 National Defense Authorization Act, aims to save money for the department and TRICARE enrollees by avoiding the higher drug co-payments associated with many prescriptions medications in retail pharmacies. The department estimated that the change would save the government roughly \$88 million annually, while TRICARE beneficiaries will save about \$16.5 million per year because of cheaper co-payments.

VA Says System Did Not Improperly Deny Health Care

The VA is denying that a computer glitch caused some 35,000 combat veterans to be denied VA Health Care saying that the problem rests with incomplete applications.

"The computer system is operating as it was designed and according to VA policy," spokeswoman Walinda West said.

What is happening is that some veterans did not answer questions on income eligibility or, alternatively, agree to cover applicable co-pays for non-combat related care. "If a combat veteran declines to provide income information, there are two questions that must be answered related to paying copays for non-combat related care," she said. "If these last two questions are not answered during the intake process, the application is placed into a pending status."

Scott Davis, a program specialist at the VA's Health Eligibility Center in Atlanta Georgia [told The Huffington Post in a story](#) published Wednesday that a computer system error has kept more than 35,000 combat vets from getting care. The Health Eligibility Center verifies eligibility for department health care benefits.

Davis, who testified as a VA whistleblower before Congress in 2014, provided the Huffington Post with an agency analysis of the number of veterans listed as pending for health care enrollment because they didn't complete the financial questions. About 16,000 veterans have been on the pending list for more than five years and about 19,000 have anywhere from a month up to five years, according to the report.

Davis called the questions "an illegal, artificial barrier" to combat veterans accessing care.

West said the financial questions are partly intended to ensure that veterans with less means get additional benefits, including travel for beneficiaries and exemptions for co-pays for care not related to military service.

They are not required to fill out the income questions, she said, but if they decline to do so they are asked to agree to cover any non-military service related care co-pays. If they do not complete the last part after declining to provide income information, she said, the applications goes into pending status.

She said the VA makes "multiple attempts" to reach veterans and get the information if their applicators end up in pending status, but did not say how frequently. She said VA is currently trying to reach combat veterans on the pending list "by phone and mail."

She also acknowledged that the department has identified a problem with "frontline employees" communicating directly with veterans, and that it is developing teaching aids to help them improve.
