## ***This-N-That***

What is accountability? According to Webster's dictionary accountability is the state of being accountable, liable, or answerable.

But where is this in the Veterans Affairs, let alone government? It's non-existent as far as I can see.

Two years ago a VA Nurses aid, Fredrick Kevin Harris was charged with the beating of a 70 year old Veteran whose care was in the hands of the Veterans Affairs which resulted in the death of the Veteran two weeks later.

The coroners report clearly stated the Veteran's death was caused by blunt force trauma, however, Fredrick Kevin Harris was put on a weeks paid leave so he could "recover" from the incident, and was later absolved of all wrong doing and allowed to return to work!

The issue is similar to a recent shoving incident at Tomah VA between a mentally handicapped patient who was not defending himself and VA employee working as a nursing assistant. That VA employee was charged with disorderly conduct. Tomah VA is still looking into the matter in its internal investigation.

Then Sloan Gibson has the nerve to stand before Congress and lecture them on accountability when the VA themselves can't even hold their own accountable.

And prior to this two other VA employees were found guilty of fraud against the VA and these two not only were allowed to keep their jobs, but all the funds they obtained fraudulently.

Prior to this a bill was passed by both the House and Senate and sent to Obama for signature to allow the VA easier terms on which they could terminate employees of the VA and Obama vetoed the bill saying it was "unfair!"

So far to date, I've not seen one press release, not one article and absolutely no word from any of the Nationally Chartered Veteran Service Organizations demanding justice let alone immediate action to correct these issues.

Why is that?

And according to many news articles, Obama has taken \$2 BILLION dollars from the VA to help pay to bring all his Syrian Refugee's to the United States, again, absolutely no word from any of the Nationally Chartered Veteran Service Organizations demanding the funds be returned.

Why is that?

Where is the accountability when it comes to Veterans Claims too?

Most if not all of the Nationally Chartered Veteran Service Organizations hire only Veterans to be trained as Service Officers. I know this first hand as back in 2006 I asked to be sent to school to be trained, offered to not only work for free, but to also pay for my own training and was refused.

Most of these organizations only pay for 10-40 hours worth of training when the actual training program is a two year program through the Veterans Affairs. But most of these organizations either won't or can't pay for housing, transportation, food, and training but they allow most who get the minimal training to process claims unchecked.

And this is a huge part of why claims are denied, maybe not the largest reason of all why claims are denied, but it sure does add to the problem.

And while I will admit there are a lot of Service Officers who truly do care, get through the program, and continue to educate themselves and put forth a huge amount of effort to make sure the claims they process are completed to the best of their abilities.

But many others will do the bare minimum if that, earn their points and bonuses, and some even get promoted.

And what I will never understand is why those who process the claims with minimal work can live with themselves doing what they do against their fellow Veteran.

Then to add to that I want to know how these very same organizations can allow this to happen and certainly don't put much effort forward to strive for better work quality and more claims approvals.

### ***New TRICARE Reimbursement Rates***

Many TRICARE beneficiaries diagnosed with Autism Spectrum Disorder (ASD) receive Applied Behavior Analysis (ABA) care under the Autism Care Demonstration. Beginning spring 2016, TRICARE reimbursement rates for ABA providers under the Demonstration will change to become more consistent with national prevailing rates. The current ABA reimbursement rates will be replaced with rates for each geographic location, similar to how all other TRICARE rates are established. TRICARE also recently changed ABA cost shares to be consistent with other cost shares under TRICARE Prime and Standard. These changes resulted in a significant benefit improvement by applying the beneficiary's cost-share for ABA services towards the annual TRICARE catastrophic cap. ### ***VA to Revamp Private Care***

The Department of Veterans Affairs (VA) recently unveiled a wide-reaching plan to Congress to merge and expand its unwieldy networks of private doctors. The goal of the New Veterans Choice Program, which would combine seven of the agency's existing private health-care arrangements into a single system, is to eliminate gaps in care. The plan would overhaul the system that allows veterans to use private doctors at government expense if they live too far from a VA hospital or need a specialist. VA officials provided details of their strategy at a recent hearing before the House Veterans Affairs Committee. ### ***TRICARE and Maintenance Drugs***

This December, TRICARE beneficiaries can take action to avoid paying more for some prescription drugs. If you fill a prescription for a [select brand name maintenance drug](#) at a retail pharmacy, you may need to move your prescription to either a military pharmacy or TRICARE Pharmacy Home Delivery. If not, you may have to pay full cost of your

prescription. Beneficiaries can move their prescriptions by contacting the TRICARE pharmacy contactor, Express Scripts (ESI) at 1-877-363-1303 or by using ESI's [secure online portal](#). If you are taking an affected drug, you should have received several notifications from ESI. You can also check by calling ESI at 1-877-363-1303. ## **Veteran Unemployment Hits 7-Year Low**

For years, it's been no secret that veteran unemployment rates were usually higher than the civilian population. But now, they've officially crossed the threshold to the other side. Reported by [CNBC](#), according to the Bureau of Labor Statistics, the unemployment rate is down to 3.9 percent since October. Not only is that the lowest point in seven years, it's better than the nations average of 5 percent. Veterans have been going stronger than the civilian population for 23 uninterrupted weeks.

## **New Bill: PROMISE Act on Vet Pain Meds**

Legislation has been introduced in Congress recently that would change how the VA manages veterans in pain, with particular focus on prescription opioids. Introduced by Representative Gus Bilirakis (R-FL), H.R. 4063, the Promoting Responsible Opioid Management and Incorporating Scientific Expertise Act (PROMISE Act) is intended to help Veterans by promoting safety, patient advocacy, and better access to quality care. The PROMISE Act has companion legislation in the U.S. Senate, where both bills are currently in committee. The legislation has gained support from a variety of veterans groups. ## *State of Emergency in Washington State due to Flooding*

The governor of Washington has declared a State of Emergency due to flooding.

Emergency prescription refill procedures are in place from December 10, 2015 through January 9, 2016.

### *Emergency Refills*

To get an emergency refill, take your prescription bottle to any TRICARE retail network pharmacy. To find a network pharmacy:

- Call Express Scripts at 1-877-363-1303
- Search the [network pharmacy locator](#)

If possible, visit the pharmacy where the prescription was filled.

- If you use a retail chain, you can fill your prescription at another store in that chain.
- If your provider is available, he or she may call in a new prescription to any network pharmacy.
- You can request assistance at another pharmacy, but it's at that pharmacy's discretion to help you.

Emergency prescription refill procedures are in place from December 10, 2015 through January 9, 2016.

### ***DeCA Reminds You to Watch the Orange Tags***

Commissary patrons are finding they can save money when they locate the orange tags denoting Value Brands. The Commissary Value Brands program provides savings on national name brand items comparable to low-cost store brand or private label items in commercial stores. On average, Commissary Value Brands save patrons about 20 percent when compared to the commercial retail stores' brand and private label items and about 38 percent against national brands. ### ***Women Veterans Suicide Crisis Prompts Legislation***

Representative Julia Brownley introduced H.R. 2915, the Female Veteran Suicide Prevention Act. If enacted, this bill would identify mental health and suicide prevention programs that are the most effective with the best outcomes among women veterans at risk. The bill would require VA to report the results of this analysis to the Congressional Veterans' Committees.

Recent data reveals the suicide rate of women veterans is nearly six times higher than women in general; for women ages 18-29, the risk is even higher, at nearly 12 times the rate of women in general. These findings have prompted clinicians and policy makers at VA to develop a number of outreach initiatives and clinical approaches to enable VA to better deal with this health care crisis.

VA experts are examining the many reasons suicide rates among women veterans are higher. According to VA's suicide prevention office, a history of military sexual assault may be a major contributing factor.

Enactment of Mrs. Brownley's bill would improve VA's evaluative efforts in this challenging area.


### ***TRICARE Webinar on Pharmacy Benefits***

### ***VA Expands Choice, Seeks Dollars for Outside Care***

An additional 160,000 veterans became eligible Dec. 1 to receive VA-paid medical care from civilian health care providers, the result of changes to the Choice Act of 2014 voted several months ago as Congress seeks to ease the flood of complaints still swirling around that poorly-designed law. Meanwhile, VA officials have unveiled a costly, complex and phased plan to consolidate the Choice program with a "patchwork" of other purchased care initiatives enacted over the years, even as VA hospitals continue their own referral agreements with local community providers.

## ***Military Holiday Mailing Deadlines***

Time is running out to send holiday packages to deployed Soldiers. Dec. 10 is the deadline for sending packages to most areas by Priority Mail and also for sending letters or cards by First Class Mail. After that, the only way to get it there in time for the holidays is by the premium Priority Mail Express Military Service (PMEMS). The deadline for PMEMS is Dec. 17 for most overseas locations. The deadlines are simply "to make sure people get it before Christmas." Another way to ensure timely delivery is by completing the online customs form before taking packages to the post office. ## ***Military Sexual Assault Victims Empowerment Act***

The American Legion recently presented written and oral testimony during a congressional hearing. LaRhanda Holt, assistant director for women and minority veteran outreach, testified before the House Committee on Veteran Affairs Subcommittee on Health regarding the Military Sexual Assault Victims Empowerment Act. Intended to amend the Veterans Access, Choice and Accountability Act of 2014, the bill aims to improve the private treatment of veterans who are MST survivors. Through this piece of legislation, MST victims could potentially be eligible for non-VA health care under the Veterans Choice Program. ### ***Vet Bus Pass Program in Tallahassee***

Tallahassee City Commissioners recently approved a permanent program to allow low-income veterans to ride StarMetro buses for free. The Veterans Bus Pass Program started as a pilot program in October 2014. The program is for low-income veterans, including those who are homeless. To receive a bus pass, qualified veterans should complete an application that will be processed through the Leon County Veterans Center. ### ***Tuskegee Airman Dies***

Milton Pitts Crenshaw, one of the last remaining instructors for the Tuskegee Airmen, passed away recently near Atlanta. He was 96. Crenshaw was one of the original flight instructors for the program established by President Franklin D. Roosevelt to train black pilots in a segregated unit. He was the first Arkansan to be successfully trained by the federal government as a civilian licensed pilot. Based on your specific eligibility status, you will be assigned a Priority Group which range from 1 to 8, with 1 being the highest priority for enrollment.
