Tips for Filing VA Appeals

Once a VA office issues its decision on your claim, you have one year from that date to file an appeal. Read the decision letter closely: it will tell you why VA made the decision it did. If you disagree with VA's decision for any reason, you should file a Notice of Disagreement (NOD). If VA included VA Form 21-0958, Notice of Disagreement, with its decision, you must use that form to file your NOD-- it is mandatory. The NOD is the start of your appeal. File your appeal right away. When you file your NOD, submit any new evidence you have. Also, when you file your NOD, state if you want a Decision Review Officer (DRO) review or a traditional review.

SBP Annuities Available for Disabled Children

The National Defense Authorization Act for fiscal 2015 now gives retirees the option of having Survivor Benefit Plan (SBP) annuity payments go directly into a special-needs trust for a disabled child. This irrevocable decision may be made during the life of the retiree through a written statement that designates future SBP payments go into the special-needs trust. There must be a written statement requesting the annuity be paid to the trust along with an attorney certification letter verifying that the trust is a special-needs trust created for the benefit of the disabled dependent child. Four Changes Eyed for 'Blended' Retirement Plan

As many as 1.8 million active duty and reserve component members, roughly 75 percent of the Total Force, will be invited in 2018 to switch to the new "blended" military retirement plan that Congress approved last year. To prepare for that "open season" year, to strengthen force retention and to bolster retirement savings, Defense officials are asking Congress to make four significant changes to the new retirement plan.

Survivor Benefit

QUESTION: I have been divorced from my first wife for seven years and have since remarried. My first wife will get part of my retirement as part of our divorce decree. If she remarries before she turns age 55, would she lose her share of my retirement?

ANSWER: The loss of benefits upon remarriage prior to age 55 is usually associated with eligibility for survivor benefits. A court order awarding your former spouse with a portion of your monthly federal annuity, unless otherwise specified in the order itself, is payable until your death or the death of your former spouse.

Navy Implements New Postal System

The U.S. Navy is assisting mail facilities with the installation and implementation of a new system to process transferring Sailors' mail quickly. The Navy Postal Directory System will be on line for all ships as of March 1 and all shore based facilities and mail rooms by March 31. NPDS is a Microsoft Access program that automates the mail processing and record keeping for a command. It stores individual personal address data for current personnel assigned to a command and also stores new data for personnel when they transfer so that mail received by the command may be readdressed and forwarded. NPDS also prepares and prints address labels for readdressing mail and automatically purges files for transferred personnel. The new system will simplify mail redirect services for all Navy commands, which can be a significant manpower savings in time taken to process redirect mail.

DoD and VA Announce Effort to Ease Transition from DoD to VA Health Care

The Departments of Defense (DoD) and Veterans Affairs (VA) announced an ongoing effort to ease the transition for service members who require complex care management as they transition from the DoD system of health care to VA or within each system.

The effort is designed to ease the burden for service members and veterans, who have suffered illnesses or injuries so severe as to require the expertise provided by multiple care specialties throughout both Departments.

"More than a decade of combat has placed enormous demands on a generation of service members and veterans – particularly those who have suffered wounds, injuries, or illnesses which require a complex plan of care," said Dr. Karen Guice, principal deputy assistant secretary of defense for health affairs, and co-chair of the DoD-VA Interagency Care Coordination Committee (IC3). "These individuals require the complex coordination of medical and rehabilitative care, benefits, and other services to successfully transition from active duty to veteran status, and to optimally recover from their illnesses or injuries."

The hallmark of the effort is the implementation of the role of Lead Coordinator. The Lead Coordinator will be a designated member of a service member's care management team who will serve as the primary coordinator for that individual. The Lead Coordinator will offer personal guidance and assist the service member and their families in understanding the benefits and services to which they are entitled. Service members, veterans, and their families, working with their Lead Coordinator, will have someone to whom they can turn when they have a question or issue as they actively participate in their care. The first phase of Lead Coordinator Training was completed in November. It is expected that a total of 1,500 DoD staff and 1,200 VA staff will serve as Lead Coordinators.

This effort comes as a result of the work of the DoD-VA IC3, established in 2012 to implement a joint, standard model of collaboration for the most complex cases of care that will require a warm handoff from the DoD to the VA system of care, as well as within the Departments, and is based on many of the best practices of collaboration that have been created

over the last decade. This effort was enacted as policy by both departments in 2015, aligning more than 250 sub-policies to one, overarching policy that will govern the coordination of complex care cases that transition between the two departments.

Coordination efforts are synchronized through the IC3 Community of Practice (CoP), a group representing more than 50 DoD and VA programs that provide specialty care, including rehabilitation services for the visually impaired and polytrauma centers. It will be the job of the Lead Coordinator to guide service members through the system, ensuring that they receive the care, benefits, and services they both require and to which they are entitled.

VA Takes Action on Allegations of Wrongdoing in Cincinnati

Network Director Proposed for Removal, and Acting Chief of Staff Reassigned Pending Further Action

WASHINGTON -- The Department of Veterans Affairs (VA) announced today actions against two senior leaders in Cincinnati, Ohio.

Based on preliminary results of a joint VA Office of Medical Inspector (OMI) and Office of Accountability (OAR) review conducted February 9-11, 2016 at the Cincinnati VA Medical Center, Deputy Secretary of Veterans Affairs, Sloan D. Gibson, has proposed the removal of Jack Hetrick, the Veterans Integrated Service Network (VISN 10) director, from Federal Service. Today, Mr. Hetrick submitted his retirement.

Additionally, VA's Undersecretary for Health, Dr. David J. Shulkin, has detailed the Cincinnati VA Medical Center Acting Chief of Staff, Dr. Barbara Temeck, out of her current duties pending appropriate administrative action.

Hetrick received a notice of pending removal today. As of today, Shulkin has summarily suspended Temeck's privileges and detailed her to non-patient-care duties while he considers appropriate additional actions.

"We are committed to sustainable accountability," said Gibson. "We will continue to use VA's statutory authority to hold employees accountable where warranted by the evidence. That is simply the right thing to do for Veterans and taxpayers."

The VA joint team conducted the site visit to investigate allegations of professional misconduct on the part of Temeck along with allegations that she directed the referral of Veterans for care in the community as a cost-shifting mechanism, resulting in poor quality of care.

The team did not substantiate any impropriety with respect to community care referrals or quality of care for Veterans. However, the team did substantiate misconduct by both Hetrick and Temeck related to Temeck's provision of prescriptions and other medical care to members of Hetrick's family. VA OIG has accepted VA's referral of the substantiated allegations for potential criminal investigation.



It is one of only three VA facilities nationwide that directly sponsor its own Graduate Medical Education.

“This award proves that VA is an important national contributor to medical education,” said Dr. David Shulkin, VA’s Under Secretary for Health. “The VA healthcare system is a unique national asset for physician workforce development. I am extremely proud of the VA Caribbean Health Care Center for earning this prestigious award.”
