Brain Injury Awareness Month

March is National Brain Injury Awareness Month, a time to recognize and support the more than 5.3 million Americans who are living with traumatic brain injury-related (TBI) disabilities. Those suffering from traumatic brain injury can display a wide variety of symptoms based on the severity of the injury. Common signs and symptoms include headache or neck pain; memory loss; slowness in thinking, speaking, acting, or reading; getting lost or easily confused; fatigue and mood changes; blurred vision; and ear ringing. Signs and symptoms of TBI may be subtle and might not appear until days or weeks following the injury, while some symptoms can be missed altogether. VA Deputy Secretary Sloan Gibson on Tuesday identified the three as Associate Director Lance Robinson, Chief of Health Administration Service Brad Curry, and hospital Chief of Staff Dr. Darren Deering. The Phoenix VA became **ground central to the wait-times scandal** that eventually revealed that officials across the VA system were hiding their inability to meet appointment standards by keeping secret lists of veterans seeking care.

VA to Commemorate 50th Anniversary of the Vietnam War

Exemplifies a MyVA priority to Improve the Veteran Experience While Thanking Vietnam Veterans and Their Families

WASHINGTON – The Department of Veterans Affairs (VA) today announced it will conduct hundreds of events in VA facilities across the nation on Mar. 29 to recognize, honor and thank U.S. Vietnam Veterans and their families for their service and sacrifices as part of the national Vietnam War Commemoration.

VA Secretary Robert McDonald will host a wreath-laying ceremony at the Vietnam Veterans Memorial – "The Wall" to initiate VA's contribution to the Commemoration. He will be joined by Defense Secretary Ashton Carter. "We are proud to partner with the Department of Defense in this endeavor. Secretary Carter's Vietnam War Commemoration staff has greatly assisted us in planning this humble tribute to our Vietnam Veterans and their families."

VA, along with more than 9,000 organizations across the country, has joined with the Department of Defense as a Commemorative Partner to help Americans honor our nation's Vietnam Veterans.

Authorized by Congress, established under the Secretary of Defense, and launched by the President in May 2012, the Vietnam War Commemoration recognizes all men and women who served on active duty in the U.S. Armed Forces from November 1, 1955 to May 15, 1975. Nine million Americans, approximately 7 million living today, served during that period, and the Commemoration makes no distinction between Veterans who served in-country, in-theater, or were stationed elsewhere during those 20 years. All answered the call of duty.

"This Commemoration has special significance for those of us at VA because of our honored mission to serve those who have "borne the battle," said McDonald. "It's also an opportunity to remember our VA colleagues who served in this generation of Veterans, to extend our heartfelt appreciation to them and to their families who shared the burden of their loved one's service."

More than 329 VA medical centers, regional benefit offices and national cemeteries will host events, many in partnership with local Veteran service organizations and volunteers.

By presidential proclamation issued on May 25, 2012, the Commemoration extends from its inaugural event on Memorial Day 2012 through Veterans Day 2025.

Commemorative Partners – local, state and national organizations, businesses, corporations and governmental agencies – have committed to publicly thank and honor Vietnam Veterans and their families on behalf of the nation and have pledged to host a minimum of two events annually.

VA Expands Hep-C Treatment

The Department of Veterans Affairs (VA) has announced that it is now able to fund care for all veterans with hepatitis C for Fiscal Year 2016 regardless of the stage of the patient's liver disease. The move follows increased funding from Congress along with reduced drug prices. Treatment priority is established for the sickest patients. Also, if veterans are currently waiting on an appointment for community care through the Choice Program, they can now turn to their local VA facility for this treatment or can elect to continue to receive treatment through the Choice Program. VA Identifies Additional Beneficiaries in Need of Fiduciary Assistance

New Technologies Aid VA in Identifying 14,000 Beneficiaries Delayed for Fiduciary Appointments

Due to Claims Processing Errors

WASHINGTON – The Department of Veterans Affairs (VA) announced today that an information technology system that it deployed in 2014 and enhanced in 2015, the Beneficiary Fiduciary Field System, allowed it to identify claim processing errors affecting approximately 14,000 Veterans and survivors. These Veterans' and survivors' claims were initially filed over many years, with some going back as far as 2000. The errors concern cases in which VA had proposed that due to disability or age the beneficiary was unable to manage his or her VA benefits without assistance, but did not complete the action by transferring it within VA for appointment of a fiduciary. These cases represent approximately four percent of such proposals since 2000.

VA's Veterans Benefits Administration (VBA) became aware of a potential problem when it received inquiries about delayed fiduciary appointments from affected beneficiaries or their families. A system-wide review by VBA using the new technology found claim processing errors that had occurred at each of its regional offices and pension management centers across the country. In these cases, one or more of the procedures for controlling and transferring the workload were not followed, resulting in the fiduciary appointment delays.

"We sincerely apologize to these Veterans and their survivors for this regrettable delay," said VA Deputy Secretary Sloan D. Gibson. "We are taking immediate action to complete these cases, initiate the fiduciary appointment process, and ensure that these errors do not happen again. We must also continue to transform the claim process for beneficiaries needing fiduciary assistance and properly resource our fiduciary program to ensure that beneficiaries have the help they need to effectively use the benefits they earned."

VBA has set up a dedicated team to immediately review the cases, notify beneficiaries, complete the claim processing steps, and appoint a fiduciary as quickly as possible. Because the law requires VA to check the qualifications of the fiduciaries it appoints, including conducting a face-to-face interview, VA anticipates that it may take as much as six months or more to complete the fiduciary appointment process for these beneficiaries. However, the beneficiaries will continue to receive their monthly benefits as VA works to appoint a fiduciary to assist them.

Additionally, VBA has already modified its systems to better track this workload and plans to remove manual transfer processes that are prone to error through enhancements to its automated claims processing system, the Veterans Benefits Management System.

WWII Museum Restoration Nears Completion

The National World War II Museum in New Orleans, Louisiana has launched a Kickstarter Campaign to raise \$100,000 to complete its restoration of the PT-305 boat. The museum hopes to have the boat sailing Louisiana's Lake Pontchartrain by early next year. The battle-hardened WWII boat conducted more than 77 offensive patrols and operations, fought in 11 separate actions and sank three German ships during its 14-month deployment. Michigan Veterans Home Dinged in Audit

A recent audit report by the Office of the Auditor General for the State of Michigan of the Grand Rapids Veterans Home has revealed quality-of-care issues like not administering pharmaceuticals correctly and abuse and neglect cases not being taken seriously. The report also revealed the home was understaffed 81 percent of the time. Two state Senate committees will hold hearings on the audit. Additional Disciplinary Actions by VA

The VA has announced actions against four leaders at the Veterans Benefits Administration (VBA) and close-out of an Administrative Investigation Board (AIB) review of the Denver Hospital Replacement project.

Based on results of investigations VA proposed three actions and issued one action. These actions include:

Danny Pummill, acting undersecretary for benefits, received a proposed 15-day suspension. This action is based on his alleged lack of oversight regarding Ms. Rubens' and Ms. Graves' actions in connection with their relocations.

Diana Rubens, director, Philadelphia Regional Office, received a reprimand and a proposed 10-percent salary reduction. This action is based on her failure to exercise sound judgment by creating the appearance of impropriety in connection with her relocation.

Kimberly Graves, director, Minneapolis/St. Paul Regional Office, received a reprimand and a proposed 10-percent salary reduction. This action is based on her failure to exercise sound judgment by creating the appearance of impropriety in connection with her relocation.

Additionally, Beth McCoy, director, Field Operations, received a reprimand, based on her failure to exercise sound judgment by creating the appearance of impropriety in connection with her involvement in vacating the position to which she was then permanently assigned.

Mr. Pummill's action, if sustained, is appealable to a third party. Ms. Rubens' and Ms. Graves' pay reductions, if sustained, may be reviewed by the VA Secretary but may not be appealed to outside third parties.

TRICARE Pharmacy Changes Coming October 1

Starting October 1, 2015, a new law requires all TRICARE beneficiaries, except active duty service members, to get select brand name maintenance drugs through either TRICARE Pharmacy Home Delivery or from a military pharmacy.

Beneficiaries who keep using a retail pharmacy for these drugs will have to pay the full cost. Maintenance drugs are those you take regularly for a long time, such as drugs to control blood pressure or cholesterol. The law does not apply to drugs you take for a short time, like antibiotics, or generic drugs. Beneficiaries living overseas, or with other prescription drug coverage, are not affected.
