#### TRICARE: State of Emergency in Texas, Louisiana

A State of Emergency has been declared in all of Louisiana and several counties in Texas due to severe flooding. Emergency prescription refill procedures are in place. To get an emergency refill, take your prescription bottle to any TRICARE retail network pharmacy. To find a network pharmacy: call Express Scripts at 1-877-363-1303 or search the <u>network pharmacy locator</u>. If possible, visit the pharmacy where the prescription was filled. If you use a retail chain, you can fill your prescription at another store in that chain. If your provider is available, he or she may call in a new prescription to any network pharmacy. You can request assistance at another pharmacy, but it is at that pharmacy's discretion to help you.

#### VA Compensation for Gulf War Syndrome

Many veterans who served in the 1991 Gulf War continue to suffer from chronic symptoms of 'gulf war syndrome' including fatigue, headaches, joint pain, indigestion, insomnia, dizziness, respiratory and memory problems. These veterans may be eligible for disability compensation from the Department of Veterans Affairs (VA). Benefits may include free, comprehensive medical examinations, including laboratory testing, a Gulf War Registry health exam, the Airborne Hazards and Open Burn Pit Registry, and health care for the disease or diseases they suffer from that are related to military service. #### **Veterans Treatment Courts**

Veterans Treatment Courts allow jurisdictions to serve a large segment of the justice-involved Veteran population. Because a Veterans court judge handles numerous Veterans' cases and is supported by a strong, interdisciplinary team, the judge is in a much better position to exercise discretion and effectively respond than someone who only occasionally hears a case involving a Veteran defendant. VA regularly works with Veterans Treatments Courts across the country through its <u>Veterans Justice Outreach initiative</u>. While VA cannot provide legal services for Veterans, there are a number of resources available. If you need legal assistance, contact your local <u>Veterans Justice Outreach</u> <u>specialist</u> who may know of community resources for legal assistance. ## Enhanced VA Enrollment for Combat Vets

When veterans choose to enroll, the Department of Veterans Affairs (VA) offers an enhancement to their enrollment experience through "Welcome to VA" (W2VA). Veterans enrolled since July 1, 2015 have received a personal introduction to VA health care services, programs and resources to help them become more familiar with VA's services. In addition, VA sends each new enrollee an introductory letter and personalized handbook in the mail. W2VA enhances communication by reaching out to newly enrolled veterans through personal phone calls upon enrollment, providing assistance with health care inquiries and assisting with their initial appointment at their preferred VA healthcare facility. #### **Civil Relief Act Aids Servicemembers**

The Servicemembers Civil Relief Act (SCRA) provides protection to servicemembers who have difficulty meeting their financial and legal obligations because of their military service. The SCRA allows servicemembers required to PCS or deploy with military orders to terminate automotive or residential leases early. The SCRA affords servicemembers this right regardless of what the lease says. Your deployment must be for at least 90 days for you to terminate a residential lease. Your deployment must be for at least 180 days in order for you to terminate an automotive lease. To terminate either lease, you must provide written notice along with your orders or a letter from your commander. For more information, contact your base legal office. Learn more about SCRA.

#### Tips and Tricks to Accessing VA Health Care

Here are several tips one veteran uses to have a good experience with the Department of Veterans Affairs (VA): (1) schedule your appointments first thing in the morning or right after lunch so you will be seen on time; (2) have a referral to

a specialty clinic? Call that clinic yourself to schedule an appointment; (3) ask for an appointment tomorrow and see if it works; (4) use My HealtheVet secure messenger to talk with your physician; (5) choose a different VA if necessary; (6) if you need to be seen sooner than your appointment, use the VA medical center emergency room; (7) use the kiosks, and avoid the lines; and (8 prepare and double-check your list of needs with your physician.

#### Families, Therapists Brace for Autism Care Cuts

Under an expansive demonstration program, TRICARE, the military's health insurance program, now covers ABA therapy for more than 10,500 service families and retirees with autistic children. Another 16,000 are eligible for such care. Yet this is a nervous time for these families, and for ABA therapy providers. On April 1, TRICARE will cut ABA reimbursement rates as much as 15 percent, with a second rate cut planned in some locales next year.

The U.S. Department of Homeland Security (DHS) is recruiting veterans and promoting on-the-spot job offers to qualified veterans looking for jobs in law enforcement, mission support, program and budget analysis, contracting and chemical security. The State of Florida has launched an initiative to attract veterans from other states, especially young ones. According to the state-formed website VeteransFlorida.org, here are several reasons why veterans will like Florida; (1) there are "no taxes on personal income, military pensions, inheritance, gifts, or intangible property" for vets; (2) every Florida resident receives \$25,000 homestead property tax exemption with additional breaks for disabled veterans; (3) thanks to Florida's GI Bill, the state gives in-state tuition rates to all veterans, spouses and dependents of veterans; (4) free tuition is also an option for those who have received the Purple Heart or several other combat decorations. #### VA Has no Plans to Punish Those Responsible for Denver Medical Center Overruns

The VA has no plans to punish any other employees over massive cost overruns at a VA medical center under construction outside Denver, the agency said Tuesday.

The executives who made the decisions that caused the price to swell to \$1.7 billion have already left department, the VA said in announcing the long-awaited results of an internal review. The VA said last year that three other executives were transferred or demoted.

A separate investigation by the VA's inspector general is still underway.

The decision angered members of Congress who have demanded for months that the executives responsible be fired.

"There's going to be a billion dollars wasted on this hospital that could have gone to veterans' health care," said Rep. Mike Coffman (R-CO) whose district includes the site.

The facility's final cost will be many times the amount estimated in 2014. It's expected to be finished in January 2018.

When Congress reluctantly approved additional spending in September to complete the hospital, it stripped the VA of the authority to manage large construction projects in the future and turned it over to the Army Corps of Engineers.

VA officials have repeatedly said federal personnel rules controlled what action they could take against executives. They also said they had no legal authority to stop employees from retiring amid the internal review.

Coffman said the department should have at least tried.

"I think they use that system, the personnel system, to hide behind when it's convenient to do so," he said.

Colorado Sens. Michael Bennet, a Democrat, and Cory Gardner, a Republican, also condemned the decision.

Bennet called it an abdication of responsibility.

"It's incomprehensible that the VA concluded no further personnel action was necessary to hold these individuals accountable," he said.

Gardner said the VA's decision makes it appear that "federal employment comes with a get-out-of-jail-free card."

## **TBI? Get Your Eyes Checked**

The Defense Health Agency reports that concussion can cause changes to vision that are sometimes overlooked during an initial medical evaluation.

Vision experts stress that eye exams should be part of the diagnosis and treatment of mild traumatic brain injury (TBI), according to Felix Barker, associate director of research for the <u>Vision Center of Excellence</u> in Bethesda, Maryland.

Because a patient's vision may not be affected at first, and issues such as bumping into objects or having double vision may seem subtle, providers and patients may not realize vision is a problem.

"Undiagnosed, such 'invisible' eye problems can interfere with near tasks such as reading, which, in turn, can be confused with TBI issues, such as cognitive dysfunction," Barker said.

To help eye care providers diagnose and treat eye problems associated with a concussion, the Vision Center of Excellence created a <u>clinical recommendation and support tools</u> for eye problems following a TBI. This clinical tool offers a practical approach to help identify patients with mild TBI who may benefit from further assessment and care. There is also <u>an educational brochure for patients</u>.

Patients with moderate or severe TBI may have more serious vision injuries and may TBI may experience central vision loss or loss of half of their visual field due to direct brain trauma.

In these cases, treatment may not restore vision back to what it was before the TBI. However, rehabilitation can help patients return to daily activities. Rehab specialists should work with eye care providers to support these individuals.

The <u>Vision Center of Excellence website</u> has information for service members, families and health care providers to help recovery after an eye injury.

## DoD Pondering Options for Medical Personnel to Maintain Medical Proficiency

Military Health System (MHS) leaders are evaluating a wide-ranging set of options so that medical personnel can practice their skills to maintain what is known as clinical currency.

"Recapturing care" from the civilian sector – convincing beneficiaries who are located within driving distance of a military treatment facility (MTF) to seek care there first – is first among those solutions.

"Recapturing care into MTFs is a strategic priority," said Navy Vice Adm. Raquel Bono, director of the Defense Health Agency. Bono explained that the recapture efforts help provide military surgeons with an active clinical practice to sustain skills, offers superb care to patients, and lowers costs for the entire system by more efficiently using military hospitals and clinics.

Bono said that in addition to recapture, she and other MHS leaders are looking at a variety of options to help ensure surgeons have access to clinically complex care. Options include greater sharing of patients between Department of Defense and Department of Veterans Affairs' facilities, as well as increased partnerships between military and civilian hospitals.

Bono also discussed the MHS journey toward a high reliability organization, emphasizing the need for greater internal and external transparency – where patients and providers can more easily access information already available – to drive improvement system-wide. She added that transparency is also a critical piece of ongoing efforts to modernize TRICARE.

"Transparency isn't just a nice buzzword," she said. "The Secretary of Defense demanded it, our patients expect it, and there's a reason why leading high reliability organizations embody it. It fosters a culture of continuous improvement."
