VA Recommends Dropping Blue Water Navy Legal Battle

VA Secretary Robert Wilkie said during congressional testimony Tuesday that he would recommend that the Justice Department not contest a recent federal court ruling that will pave the way for the return of earned disability benefits for some 90,000 so-called Blue Water Navy veterans. In [Procopio v. Wilkie](#), the VA secretary was sued by Navy veteran Alfred Procopio Jr., a Life member of VFW Post 6587 in Spring Lake Park, Minn., who was denied service connection for prostate cancer and diabetes mellitus — both illnesses are among the [14 presumptive diseases](#) associated with Agent Orange exposure — because he was

assigned aboard an aircraft carrier inside Vietnam's 12-mile territorial waters but never on dry land or within Vietnam's inland waterways. The U.S. Court of Appeals for the Federal Circuit focused on the intent of the 1991 Agent Orange Act, which was to grant a presumption of service connection for certain diseases to veterans who "served in the Republic of Vietnam." At issue was whether service within territorial waters constituted service "in the Republic of Vietnam." By a 9-2 decision, the court ruled it did. "The VFW salutes Secretary Wilkie for his support to move forward and take care of this group of forgotten Vietnam veterans," said VFW National Commander B.J. Lawrence. "We also support his recommendation that some type of historical research division be created within the Department of the Navy to ensure that all such ships are fully accounted-for in the [VA's list of exposed ships](#). After a half-century, we need to get this done to reinforce to tens of thousands of Vietnam veterans that our nation is willing to provide them the care and benefits they have earned and deserve, and we urge Congress to pass H.R. 299, the Blue Water Veterans Act of 2019, to ensure the VA can never again arbitrarily strip veterans of their earned benefits." H.R. 1527, the Long-Term Care Veterans Choice Act

Representative Clay Higgins introduced H.R. 1527, the Long-Term Care Veterans Choice Act. This bill would provide veterans who are no longer capable of living independently an alternative to nursing home care, in which the veteran would continue to receive the care that they need in an intimate home-like environment through VA's Home-Based Primary Care program, and

the Medical Foster Home (MFH) attendant program.

Started in 2000, VA Medical Foster Homes provide veterans who need nursing home level of care an alternative to being placed in a nursing home. VA Medical Foster Homes merge traditional adult foster care with comprehensive longitudinal care provided in the home by a VA interdisciplinary team that includes a physician, nurse, social worker, rehabilitation therapist, mental health provider, dietitian, and pharmacist. Since its inception, over 4,000 veterans have resided in Medical Foster Homes.

However, many service-connected veterans who wish to reside in a VA Medical Foster Home are unable to do so because of substantial out-of-pocket costs of approximately \$1,500 to \$3,000 per month. Because VA does not have the authority to cover these costs, veterans are placed in nursing homes which VA pays for but cost more than twice as much.

As the veteran population continues to age, the need for long-term care services will continue to grow. Home-based community programs like MFHs will enable VA to meet the needs of aging veterans in a manner closer to independent living than institutionalized care. With the passage of this bill, veterans would have the option of care that more closely aligns with their independence while

maintaining their quality of life.

This bill is in accordance with DAV Resolution No. 085, which calls for legislation to improve the comprehensive program of long-term services and supports for service-connected disabled veterans regardless of their disability ratings.


**H.R. 303, the Retired Pay Restoration
Act**

On January 8, 2019, Representative Gus Bilirakis (FL) introduced H.R. 303, the Retired Pay Restoration Act. This bill would extend concurrent receipt authority to longevity retirees with service-connected disabilities rated less than 50 percent disabling. Under current law disabled veterans with longevity retirement from active military service who are also in receipt of a Department of Veterans Affairs (VA) disability determination of 50 percent or higher may retain both military retirement pay and their compensation.

DAV strongly supports H.R. 303 as it would end the unfair policy of forcing many military longevity retirees to forfeit some of their retired pay in order to receive equal amounts of disability compensation from the VA. This legislation is in accord with DAV Resolution No. 104 and would eliminate concurrent receipt for all longevity retirees.



VA to Offer New Ketamine-Based Nasal Spray for Depression

The newest FDA-approved medication to treat severe depression, a nasal spray based on the anesthetic (and misused hallucinogenic party drug) ketamine, will soon be available to veterans treated within the [Department of Veterans Affairs](#). In a move that may help thousands of former service members with depression that has not improved with other treatments, VA officials announced March 19 that the department's doctors are now authorized to prescribe Spravato, the brand name for esketamine, a molecular variation of ketamine. The treatment will be available to veterans based on a physician's assessment and will be administered only to patients who have tried at least two antidepressant medications and continue to have symptoms of major depressive disorder. 

Fiscal Year 2020 Budget for Veterans' Programs

On Tuesday, Secretary of Veterans Affairs Robert Wilkie testified before a Senate Committee on Veterans' Affairs hearing regarding the president's Fiscal Year (FY) 2020 budget request for VA. Secretary Wilkie supported the president's 7.5 percent increase of VA's budget and discussed how it enables VA to improve customer service and implement the numerous recently enacted and VFW-supported laws such as the [VA MISSION Act](#), the [Forever GI Bill](#), and the [Appeals Modernization Act](#). Secretary Wilkie also announced that VA has recommended the president drop the [Blue Water Navy legal battle](#) and start providing long-overdue benefits to veterans exposed to

Agent Orange while serving off the coast of Vietnam. Committee members expressed concerns with VA's reduction in funds for construction despite having a \$60 billion construction backlog and VA's plans to rely more heavily on private sector doctors. VA also indicated it would make a decision within the next three months on benefits for bladder cancer, hypertension, Parkinson's-like symptoms, and hypothyroidism related to Agent Orange exposure. The VFW and its Independent Budget (IB) coauthors submitted testimony opposing VA's proposal to round-down cost-of-living adjustments for compensation benefits and encouraging Congress to properly fund veterans' care and benefits. H.R 445, Help Hire Our Heroes Act

On January 10, 2019, Representative Julia Brownley introduced H.R. 445, the Help Hire Our Heroes Act. This bill would amend the VOW to Hire Heroes Act of 2011 to make permanent the Veterans Retraining Assistance Program (VRAP).

The VRAP was started in 2012 to provide training assistance to unemployed veterans between the ages of 35 and 60 who are no longer eligible for the GI Bill. It provided up to 12 months of training benefits at community colleges and technical schools in occupations that the Department of Labor has identified as "high demand." Since funding for this program expired in March 2014, the VA has not been able to enroll new veterans in VRAP. This program gap means that thousands of older, qualified veterans have been unable to access the resources which could help them find work.

This bill would strike the end dates of the Veterans Retraining Assistance Program and would replace it

with year to year authorizations. This bill is in accord with DAV Resolution No. 190 which seeks adequate funding and permanency for veterans' employment and training programs.

VA Receives \$25 Million Donation to Provide Genetic Testing for Veterans

A billionaire philanthropist has donated \$25 million to the Department of Veterans Affairs to provide genetic tests for veterans to help tailor their medical treatments and medications. The VA and Denny Sanford, a South Dakota banker and Air Force Reserve veteran, announced the gift March 12. The money is expected to help up to 250,000 veterans through 2022, starting with those who have received a cancer diagnosis. According to Sanford Health, the hospital system named for Sanford after he donated \$400 million in 2007, the gift will fund the testing program, called Pharmacogenomics Action for Cancer Survivorship, or PHASeR. It aims to use a veteran's DNA to determine personalized treatment and reduce costly adverse drug reactions. Dr. Deepak Voora, with the Duke University School of Medicine's Center for Applied Genomics and Precision Medicine, will oversee the program; a pilot is expected to launch at the Durham, N.C., VA Health System later this year. 

**DOD Fiscal Year 2020 National Defense
Authorization Budget request**

On Tuesday, Acting Secretary of Defense Patrick M. Shanahan and the Chairman of the Joint Chiefs of Staff General Joseph F. Dunford testified before the House Committee on Armed Services. The hearing focused on the Department of Defense (DOD) Fiscal Year (FY) 2020 Budget request for the FY2020 National Defense Authorization Act. The president's budget request for overall defense is \$750 billion for the FY2020, a \$34 billion increase from FY2019. The request focuses on military modernization, which the military has been unable to achieve for the past three decades. Acting Secretary Shanahan stated that both China and Russia are aggressively modernizing their militaries, especially in the space and cyber domains, to erode U.S. global hegemony, a "central problem" for DOD. In light of this, the budget will invest heavily in prioritizing innovation and modernization to strengthen competitiveness across all domains —air, sea, land, space, and cyber. \$57.7 billion will go to procurement and modernization for U.S. fighters, \$14.1 billion to space, \$9.6 billion to offensive and defensive cyberspace operations, \$2.6 billion to improving and expanding cyber operations training, \$14.6 billion to fund roughly 6,400 combat and tactical vehicles, and \$14 billion to nuclear capabilities. 

Bill Introduced to Stop Veterans from Being Punished for VA's Miscalculations




Bill Would Require DoD to Pay for Combat Troops to Freeze Sperm, Eggs


A new bill would give troops with infertility related to their military service greater access to advanced reproductive treatments, including up to three completed cycles of in vitro fertilization, or IVF, and cryopreservation of eggs and sperm for those heading to a combat zone. It would require the Defense Department to provide treatments, such as IVF and access to egg and sperm donation services, as well as use of surrogates to wounded, ill or injured service members whose infertility is related to military service. If approved, the legislation would revive an initiative announced in 2016 by former Defense Secretary Ash Carter, who included cryopreservation of gametes in a series of personnel initiatives known as the "Force of the Future." Armed Forces Retirement Home Accepting Applicants

The Armed Forces Retirement Home is accepting applications for residents at its two locations in Gulfport, Mississippi, and Washington, D.C. Applications are being accepted from veterans with at least half of their service as an enlisted member, warrant officer or limited-duty officer, and those who meet one of the following criteria: at least 60 years of age or older with an honorable discharge; retirees with 20 years of service or more; service-connected disability; served in a war zone or received hostile-fire pay and have injuries, disease or a disability. The 2019 rate for independent living is 46.7 percent of the resident's gross monthly income or \$1,990, whichever is less. Learn more [here](#).

**S. 179/H.R. 712, Legislation Calling for
Clinical Trials to Evaluate the
Effectiveness of Medical Cannabis for
Chronic Pain and PTSD**

These companion bills, S. 179 and H.R. 712, would direct the Secretary of Veterans Affairs (VA) to carry out a clinical trial of the effects of cannabis on health outcomes of adults with chronic pain and post-traumatic stress disorder (PTSD).

These measures would require the VA Secretary to conduct clinical trials that look into whether cannabis is able to reduce symptoms associated with chronic pain such as inflammation, sleep disorders, spasticity, and agitation and effects on the use or dosage of opioids, benzodiazepines or alcohol for veterans with PTSD.

Research is necessary to determine the safety and efficacy of any drug. At this time there are few definitive answers about risks and benefits associated with the use of cannabis on various medical conditions and illnesses. Research is necessary to help clinicians better understand the safety and efficacy of cannabis use for certain conditions common in the veteran population such as chronic pain and posttraumatic stress.

These bills are in line with DAV Resolution No. 023 which calls for comprehensive and scientifically rigorous research by the VA into the therapeutic benefits and risks of cannabis, cannabis-derived products as a possible treatment for service-connected

disabled veterans.

Tricare Adds Coverage for Human Breast Milk

For the first time ever, [Tricare](#) is covering the purchase of human breast milk from an accredited milk bank, according to a policy update released March 18. The new coverage, which is retroactive to Jan. 1, could save mothers of premature or sick infants thousands of dollars if their baby requires breast milk but they are unable to provide it. Since the maximum Tricare will pay a bank per ounce for milk is \$4.50, according to the policy, that means no beneficiary will pay more than about \$1.12 per ounce, while many will pay nothing, depending on their cost share. Coast Guard Eyes Changes to Physical Standards, Tattoo Policy to Retain Troops

A week before releasing results of a study on retaining women in the [Coast Guard](#), the service's top leaders said they will institute a policy to better support families during parental leave and are considering changing weight standards they say disproportionately affect women. Officials also said the service plans to study minority retention in order to grow — and keep — diversity in the ranks. It also is examining its tattoo restrictions, policies that prevent single parents from enlisting and physical standards based on body mass index that limit recruitment and retention. H.R. 444, Reduce Unemployment for Veterans of All Ages Act of 2019

On January 10, 2019, Representative Julia Brown (CA) introduced H.R. 444, the Reduce Unemployment for Veterans of All Ages Act of 2019.

Currently, veterans with service-connected disabilities or other employment handicaps are able to receive career development services through VA's Vocational Rehabilitation and Employment program up to 12 years after they separate from military service. H.R. 444 would remove the limiting 12-year-period for eligibility.

In agreement with DAV Resolution No. 310, we support this legislation to eliminate the 12-year-period of eligibility. By removing the limited eligibility period, H.R. 444 will provide veterans the flexibility to receive the support they have earned and deserve throughout their lifetime and thus help reduce unemployment for service-connected veterans.



McConville Picked to Lead Army

The president this week nominated Army Gen. James McConville to become the service's next chief of staff. Once confirmed by the Senate, he will replace Army Gen. Mark Milley, who President Trump announced was his choice to become the next chairman of the Joint Chiefs of Staff when Marine Gen. Joseph Dunford retires sometime this year. McConville has served as the Army vice chief of staff since June 2017. The 59-year-old from Quincy, Mass., is a 1981 graduate of West Point, who spent much of his career in Army aviation flying the AH-64 Apache, OH-58 Kiowa Warrior and the AH-1 Cobra. The general has commanded troops in both Iraq and Afghanistan, to include the 101st Airborne Division in Afghanistan, and earlier, the 4th Brigade, 1st Cavalry Division, in Iraq. Soldiers Re-Enact Bataan Death March

Soldiers and civilians at White Sands Missile Range, New Mexico, marked the anniversary of World War II's 1942 Bataan Death March with a desert walk involving nearly 9,000 participants. To start the memorial trek, troops heard from three survivors of the historic march: Valdemar De Herrera, Paul Kerchum and Ben Skardon. Then, they sounded a symbolic roll call, according to a recent release. The marchers traveled from all 50 states and 12 countries. The event honored the 750,000 U.S. and Filipino troops who were marched brutally for days through Philippine jungles to prison camps after the U.S. surrendered the Bataan Peninsula to the Japanese during the war. Currently, purchased Survivor Benefit Plan (SBP) annuities are offset by the amount of any benefit payable under the VA Dependency and Indemnity Compensation (DIC) program. SBP is not a government gratuity benefit; rather, it is a type of insurance purchased out-of-pocket by military retirees for their survivors while DIC is a VA benefit intended to provide spouses of veterans who died from a service-connected condition some semblance of financial security. Thousands of survivors of military retirees are adversely affected by this unfair offset between SBP and DIC benefits.


Upon the retiree's death, the SBP annuity is paid monthly to eligible beneficiaries; however, if a surviving spouse is also entitled to DIC, the SBP benefit is reduced by the amount of the DIC benefit (currently \$1,283.11 per month). In general, when DIC benefits are payable but the monthly rate is equal to, or greater than, the monthly SBP payment amount, beneficiaries lose the entire SBP payment.

This bill would eliminate the offset and allow surviving spouses to receive both the purchased SBP annuities and their earned DIC benefits. This bill is in accordance with DAV Resolution No. 014, which calls

for Congress to repeal the offset between SBP annuity payments and DIC payments.




Berger Picked to Lead Marine Corps

The president this week also nominated Lt. Gen. David Berger to be the next commandant of the Marine Corps, as well as promotion to the rank of general. If confirmed, he will replace Gen. Robert Neller, who is set to retire after leading the Corps since 2015. Berger, 59, of Woodbine, Md., was commissioned in 1981 as an infantry officer after graduating from Tulane University in New Orleans. He was a battalion operations officer with 2nd Reconnaissance Battalion during Operation Desert Storm, commanded Regimental Combat Team 8 during Operation Iraqi Freedom, and was the commanding general of 1st Marine Division during Operation Enduring Freedom. Berger has been the commanding general of Marine Corps Combat Development Command and the Deputy Commandant for Combat Development and Integration since August. **Support SBP/DIC Offset Repeal (S.
622/H.R. 553)!**

Sen. Doug Jones (AL) has introduced legislation (S. 622) that repeals the SBP/DIC offset for survivors, sometimes referred to as the "military widows tax." Earlier, Rep. Joe Wilson (SC) introduced similar legislation in the House, the "Military Surviving Spouses Equity Act" (H.R. 553).

SBP and DIC payments are paid for different reasons. The Survivor Benefit Plan (SBP) is purchased by the retiree and is intended to provide a portion of retired pay to the survivor. Dependency and Indemnity Compensation (DIC) is a special indemnity compensation paid to the survivor when a member's service causes his or her premature death. In such cases, the VA DIC should be added to the SBP the retiree paid for, not substituted for it. It should be noted as a matter of equity that surviving spouses of federal civilian retirees who are disabled veterans and die of military-service-connected causes can receive DIC without losing any of their federal civilian SBP benefits.

TRICARE Fee Increases in 2019?


The FRA is thankful that the Administration's proposed FY2020 budget recently submitted to Congress does not include any TRICARE fee increases.

Unfortunately, the Congressional Budget Office (CBO) submitted a report to Congress in December recommending various TRICARE fee increases and other benefit cuts for military retirees and active duty military. Concern in Congress about the growing annual spending deficit for the current and upcoming fiscal years is increasing and legislators may consider these drastic cuts to reduce the deficit. Some of the

many recommendations in the report include:


- A new TRICARE-For-Life (TFL) annual enrollment fee of \$485 for individual coverage and \$970 for family coverage, and increased cost-shares
- Increasing TRICARE Prime and Select enrollment fees beyond the current annual CPI increase
- Reduce active duty BAH to 80 percent of actual cost
- Limit active duty annual pay increases
- Eliminate VA's Individual Unemployability payments to disabled veterans at the full retirement age for Social Security





H.R. 1200, the Veterans' Compensation Cost-of-Living Adjustment Act of 2019

On February 13, 2019, Representative Elaine Luria (VA), Chairman of the House Veterans' Affairs Subcommittee on Disability Assistance and Memorial Affairs and Ranking Member Michael Bost (IL),

introduced H.R. 1200, the Veterans' Compensation Cost-of-Living Adjustment Act of 2019.

This bill, if enacted, would authorize a cost-of-living adjustment (COLA) for veterans in receipt of compensation and pension, and for survivors of veterans who died from service-incurred disabilities and are in receipt of Dependency and Indemnity Compensation (DIC). It would provide a COLA increase by the same percentage as Social Security and would be effective December 1, 2019.

Receipt of annual COLA increments aids injured and ill veterans, their families, and their survivors to help maintain the value of their VA benefits against inflation. Without COLAs, these individuals, who sacrificed their own health and their family life for the good of our nation, may not be able to maintain a quality of life in their elder years. DAV strongly supports H.R. 1200 as it is in accord with DAV Resolution No. 031.

MIA Update

This week the Defense POW/MIA Accounting Agency (DPAA) announced the identification of five U.S. personnel, previously unaccounted for from our nation's past wars and conflicts. Returning home with full military honors are:

Navy Reserve Journalist 3rd Class Raul A. Guerra was a passenger on board an E-1B Tracer when radar contact with the aircraft was lost just outside of Da Nang. Several days later, wreckage was spotted in the area where contact was lost, but because of the location and very steep terrain, a ground recovery could not be conducted. Guerra and the four other service members on board were declared killed in action. Interment services are pending. [Read about Guerra.](#)

Army Pfc. Herschel M. Riggs was an infantryman with Headquarters Company, 19th Infantry Regiment, 24th Infantry Division. In July 1950, his unit was involved in combat actions against North Korean forces near Taejon, South Korea. Riggs was declared missing in action on July 16, 1950, when he could not be accounted for by his unit. Interment services are pending. [Read about Riggs.](#)

Army Cpl. Benjamin W. Scott was a member of

Company M, 3rd Battalion, 21st Infantry Regiment, 24th Infantry Division. In July 1950, his unit was engaged in combat actions against the North Korean forces in the vicinity of Choch'iwon, South Korea, when he was declared missing in action. Interment services are pending. [Read about Scott.](#)

Seaman 2nd Class Calvin H. Palmer and **Seaman 2nd Class Wilferd D. Palmer** were stationed aboard the USS Oklahoma, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft on Dec. 7, 1941. The battleship sustained multiple torpedo hits, which caused it to quickly capsize. The attack on the ship resulted in the deaths of 429 crewmembers, including Calvin and Wilferd Palmer. Interment services are pending. [Read about the Palmer brothers.](#)


