# ADVOCACY GROUP CLAIMS STRATEGIC VICTORY AGAINST THE SECRETARY OF VETERANS AFFAIRS

Louisiana based Military-Veterans Advocacy (MVA) hauled the Secretary of Veterans Affairs before the Court of Appeals for the Federal Circuit on Friday in an attempt to lift a stay the Secretary placed on benefits claims for 90,000 Blue Water Navy veterans.

MVA won a landmark case in the same court in January, Procopio v. Wilkie, which extended benefits to veterans who served in the bays, harbors and territorial sea of South Vietnam. The Secretary's stay, issued on July 1, was in response to Congressional action which was touted as a legislative support for the Procopio decision. Instead, the law used ambiguous language and authorized a stay of proceedings. MVA opposed the legislation because of the stay provisions and the confusing and inconsistent language. The major Veterans Service Organizations supported the bill.

MVA argued that the legislation, sponsored by

Mark Takano (D-CA), opened a second pathway to benefits before the VA but that it did not restrict the pathway opened up by Procopio. Members of Congress agreed and contacted the Secretary to explain that they never intended the stay to apply to Procopio claims. MVA filed those letters with the Court.

MVA Director of Litigation Commander John B. Wells (USN, ret) represented the group and the Blue Water Navy Vietnam Veterans Association before the court. He noted that at least 12 veterans had died during the stay and more deaths were expected. He also asserted the MVA position that the Secretary should not be allowed to initiate subsequent stays. The current stay expires on Jan. 1, 2020.

Under questioning by the court, the Department of Justice representative conceded that the Secretary would have no authority to extend or reissue the stay. Judge Kimberly Moore, who also authored the Procopio opinion, noted that the Department of Justice had bound the government to lift the stay.

The Department also argued that Alfred Procopio, who was a lead plaintiff on this case, was not affected by the stay. Wells, who also serves as Procopio's attorney, disagreed. Subsequent to the argument, the government submitted an admission that the stay against Procopio himself had not been lifted until Nov. 6 - two days before the oral argument.

"It is really fascinating that the VA magically discovered that Procopio was mistakenly stayed two days prior to the oral argument," Wells noted. "Of course, they did not bother to notify Mr. Procopio or myself that he was no longer impacted by the stay."

Wells claimed a strategic victory over the VA.


"One of our goals was to ensure that the stay was not reissued or extended," Wells said. "We achieved that. Now we have to wait for the court to decide whether the stay was illegal or not."

If the stay is not lifted by Jan. 1, 2020, MVA will file a Motion to hold the Secretary in contempt.

"The Secretary has claimed that the VA will be only federal office working on Jan. 1, and will be processing Blue Water Navy claims on that date," Wells said. "Accordingly, I have asked our scheduler to set up a meeting with him at 9 a.m. on Jan. 1, at his office. It will certainly make a good photo op if he is there."



How Will Veterans Get on Base for Their New Commissary Access? No One Can Say Just how the Defense Department will allow an estimated 3.5 million veterans and their caregivers on bases early next year to use commissaries, exchanges and some recreation resources is still largely unanswered, despite a looming deadline and potentially complicated access issues. Beginning Jan. 1, 2020, all service-connected disabled veterans, caregivers enrolled in the Department of Veterans Affairs' Comprehensive Assistance for Family Caregivers program, and former prisoners of war will be able to shop at onbase grocery stores and exchanges. ### VA Taking Note of 'Alarming' Burn Pit Trends in WWP Survey

A disturbing trend related to exposure to burn pits while deployed, recently detailed in a Wounded Warrior Project survey, has been noted by the Department of Veterans Affairs. But more research is needed before any changes to presumptive illnesses and benefits can be considered, according to a top VA official. The VA currently lacks the scientific evidence to establish a causal relationship between exposure to burn pits and a variety of illnesses, but the WWP survey released last week will be taken into account, said Dr. Carolyn Clancy, the VA's deputy under secretary for Discovery, Education and Affiliate Networks. On Wednesday, the VFW-supported H.R. 3224, Deborah Sampson Act, which would expand the availability of women's health services at VA to include expanding and improving counseling and treatment services for women who have experienced sexual trauma and providing training on women veterans health care providers, was passed in the House. 
Join Nov. 21 TRICARE Webinar on Open Season

**House Passes Multiple Veteran Bills** 

This week, the House overwhelmingly passed more than a dozen veteran-centric bills. "It was good to see the House come back after Veterans Day and immediately pick back up working for veterans," said VFW National Legislative Service Deputy Director Pat Murray. The bills passed improve education benefits, address VA overpayment issues, and address gaps for rural and underserved veterans. ### The FRA Speaks at Suicide Prevention at Capitol Hill Meeting

NED Chris Slawinski recently was one of four featured speakers at the Veteran and Servicemember Suicide Prevention roundtable discussion on Capitol Hill that was sponsored by the American Foundation for Suicide Prevention. It was noted at the meeting that suicide is the second leading cause of death for ages 15 to 34. Suicide is tenth leading cause of death in the United States and on average, 129 Americans die by suicide each day. Veterans are 1.5 times more likely to die by suicide than civilians.

Speaking before a room of mostly Capitol Hill staffers, Slawinski spoke from a personal perspective as a Veteran Service Officer. He shared a particular story of being on the telephone with the wife of a Vietnam veteran who suffers from PTSD. The veteran was considering suicide and it was the intervention of his spouse along with Slawinski that helped the veteran get assistance.

One of the speakers was Psych Hub Chief Clinical Officer Dr. Keita Franklin, who acknowledged

suicide is a "very complex issue" and some causes that trigger feelings of suicide often include failed relationship, substance abuse and legal troubles. Franklin stressed that one of the most productive steps that can be taken is to reduce the stigma that surrounds suicide. This "mental health literacy" is important in bringing the issue of suicide out into the open. Chief Advocacy Officer of the Independence Fund Bob Carey spoke of current legislation that intends to help those seeking help, are able to receive it. Director of Psychological Health, District of Columbia National Guard Torrie Osterholm encouraged everyone to take a moment and ask, "how can I help?"

**POW/MIA Flag at Federal Buildings** 

President Donald Trump recently signed into law the National POW/MIA Flag Act (S.693), sponsored by Sen. Elizabeth Warren (Mass.). The act would require prominent federal buildings and national war memorials to fly the POW/MIA flag alongside the American flag throughout the year. The flag is designed to help highlight the continued suffering of military families with service members who are unaccounted for overseas (82,000). The FRA wants to ensure that the Defense Department makes every effort for a complete accounting of all Prisoners Of War and Missing in Action service members for past and current conflicts.

House Holds Hearing on Disinformation on Social Media

This week, the House Committee on Veterans' Affairs held a hearing to discuss the effect of social media disinformation on veterans. Due to the influence they have within their communities, veterans are targeted for scams and propaganda at high rates. While disinformation and other malicious online behavior is on the rise, policing conduct on social media remains incredibly difficult and more work is needed to guarantee that veterans and their families remain secure. At the hearing, Ranking Member Phil Roe (R-Tenn.) stated, "We want to shed light on the issues impacting veterans, help them understand the risks associated with using social media and direct them to resources to empower them to protect themselves and their families online." ### Key Legislators Work to Avoid Government Shutdown


In September, the House and Senate passed a Continuing Resolution (CR-H.R.4378) based on an agreement between the White House, Senate and House of Representatives. The CR kept the federal government open at the current spending levels from October 1 to Nov. 21, 2019, which is the beginning of a new fiscal year. With the November 21 deadline looming over the horizon, the Senate Appropriations Committee Chair Sen. Richard Shelby (Ala.) and House Appropriations Committee Chair Rep. Nita Lowey (N.Y.) have tentatively agreed on a second Continuing Resolution to keep government open until Dec. 20, 2019. This new CR must pass the House and Senate and be signed by the president before Nov. 21, 2019. According to press reports, the White House has not yet signed off on the deal.

The Pentagon has informed Congress that another CR after November 21 will disrupt various programs. The Navy disruptions would include operation and maintenance fund shortfalls that would curtail the availability of 14 ships, cancel deployed ship training and shutdown nondeployed carrier air wing and expeditionary squadrons. Further, the Navy could also see delayed delivery of one Virginia-class fast attack submarine, one fleet ocean tug and two Landing Craft Utility vessels.



Some Veterans Will Not Have Access to Military Installations by Jan. 1, 2020

The Purple Heart and Disabled Veterans Equal Access Act of 2018 expanded eligibility for commissary, military exchanges, and morale, welfare and recreation (MWR) services to include Purple Heart recipients, former prisoners of war, and veterans with VA documented serviceconnected disability ratings of 0-90 percent. Veterans who are 100 percent service-connected already had access to commissary and MWR services. Eligible persons will need to have a Veteran Health Identification Card (VHID) from VA in order to gain entry to Department of Defense and/or Coast Guard installations. Those who are covered under this act and do not have a VHID will not be allowed access to the installations on Jan. 1, 2020, but will have access to online exchanges and American Forces Travel. Caregiver eligibility will be limited to caregivers who are designated as the primary family caregiver of an eligible veteran under the Program of Comprehensive Assistance for Family Caregivers and will need to show an acceptable credential, along with their eligibility letter. **Eligibility Criteria for Burial** 

Acting Secretary of the Army Ryan D. McCarthy has proposed changes to eligibility criteria for burial at Arlington National Cemetery (ANC) that will include military retirees, without combat experience, for above-ground inurnment.

The FY 2019 National Defense Authorization Act directed the Secretary of the Army to revise eligibility criteria to keep the cemetery functioning as an active burial ground "well into the future" – defined as 150 years. The Army will now begin the federal government's public rule making process, which includes soliciting public feedback to the proposed changes. The FRA would like to know your thoughts on providing retirees aboveground inurnment at ANC.

#### **MIA Update**

The Defense POW/MIA Accounting Agency announced one new identification and six burial updates for service members who have been missing and unaccounted-for from WWII and the Korean War. Returning home for burial with full military honors are:

U.S. Army Cpl. Jackey D. Blosser, 21, was a member of Dog Company, 1st Battalion, 32nd Infantry Regiment, 7th Infantry Division. He was reported missing in action Dec. 2, 1950, in the vicinity of the Chosin Reservoir, North Korea, when his unit was attacked by enemy forces. Following the battle, his remains could not be

recovered. Interment services are pending. Read about Blosser.

Army Cpl. Kenneth E. Ford, 18, of Albia, Iowa, was a member of Company C, 1st Battalion, 32nd Infantry Regiment. He was reported missing in action on Dec. 2, 1950, in the vicinity of the Chosin Reservoir, North Korea, when his unit was attacked by enemy forces. Interment services are pending. Read about Ford.

Army Air Forces Tech. Sgt. Max. W. Lower, 23, of Lewiston, Utah, was assigned to the 345th Bombardment Squadron, 98th Bombardment Group (Heavy), 9th Air Force. On Aug. 1, 1943, the B-24 aircraft on which Lower was the radio operator crashed as a result of enemy anti-aircraft fire during Operation Tidal Wave, the largest bombing mission against the oil fields and refineries at Ploiesti, north of Bucharest, Romania. Lower will be buried Nov. 23, 2019, in his hometown. Read about Lower.

**Army Cpl. Joe T. Avant**, 20, of Greenwood, Mississippi, was a member of Heavy Mortar Company, 31st Infantry Regiment, 7th Infantry

Division, 31st Regimental Combat Team, engaged in intense fighting near the Chosin Reservoir in North Korea. He was reported missing and unaccounted for on Nov. 30, 1950. Avant will be buried Dec. 13, 2019, in his hometown. Read about Avant.

Army Pfc. Karl L. Dye, 17, of Marion, Ohio, was a member of Battery B, 52nd Field Artillery Battalion, 24th Infantry Division, engaged in combat operations against North Korean forces, near Taejon, South Korea. In July 1950, he was seriously wounded by an enemy mortar shell and placed in an ambulance. The ambulance allegedly encountered an enemy roadblock. Dye was reported missing in action on July 16, 1950. Dye will be buried at Arlington National Cemetery in Arlington, Va. The date has not been set. Read about Dye.

Army Cpl. Leon E. Clevenger, 21, of Durham, North Carolina, was an infantryman with Company K, 3rd Battalion, 21st Infantry Regiment, 24th Infantry Division. He was reported missing in action on July 11, 1950, while involved in combat operations against the North Korean People's

Army in the vicinity of Chonui and Choch'iwon, South Korea. The Army amended his status to deceased in December 1953 when there was no updated information regarding his status. Clevenger will be buried in Mims, Florida. The date has not been set. Read about Clevenger.

Marine Corps Pfc. Jack B. Van Zandt, 22, of Danville, Illinois, was a member of Company A, 1st Battalion, 6th Marine Regiment, 2nd Marine Division, Fleet Marine Force. Van Zandt landed on the island of Betio in the Tarawa Atoll of the Gilbert Islands. Over several days of intense fighting at Tarawa, approximately 1,000 Marines and sailors were killed, including Van Zandt on the third day of the battle, Nov. 22, 1943. Van Zandt will be buried in Danville, Illinois. The date has not been set. Read about Van Zandt.
