### Advocacy Group Sues VA Secretary over Blue Water Navy, Thailand Veterans

Louisiana based Military-Veterans Advocacy (MVA) today filed suit in the Court of Appeals for the Federal Circuit. The suit seeks judicial review of a change to the Veterans Administration adjudication manual issued on Dec. 31, 2019. That regulation will guide the benefit claims for tens of thousands of military veterans. MVA took issue with the failure of the VA to include veterans who flew into South Vietnam and its territorial sea, despite the fact that some close air support missions were less than a thousand feet. They also charged that the VA ignored the provisions of its own regulation by excluding veterans who served in "waters offshore," an area that extended past the territorial sea but was included in the area of combat.

"We need to finish the job for the Blue Water Navy veterans," said MVA Executive Director Col. Rob Maness (USAF, Ret.). "There are thousands of veterans who served on aircraft carriers and other ships and were exposed but did not actually enter the territorial sea or the area designated by Congress."

Last year MVA won a landmark decision, Procopio v. Wilkie, that extended benefits to those who served in Vietnam=s territorial sea.

"We covered about two-thirds of the Blue Water Navy," said former Petty Officer Mike Yates, of Las Vegas, Section Chief for the Blue Water Navy. "Now we have to cover the rest of them."

The suit also argues that actions by the VA to limit veterans serving at Royal Thai Army and Air Force bases to those who had duties on the perimeter. MVA Veterans of Southeast Asia Section Chief Bill Rhodes, of Mena, Arkansas, a former Marine who served in Thailand, dismissed the limitation as "woefully inadequate."

"Official government documents indicate herbicides were used within the confines of the bases, not just on the perimeter," Rhodes said. "Many of the barracks abutted the perimeter. Military personnel who had duties elsewhere but slept on or near the perimeter are not covered by this rule."

Rhodes also noted that to account for wind drift, the Army Field Manual required a 500-meter buffer area when herbicide was sprayed at ground level.

MVA Director of Litigation Cmdr. John B. Wells, (U.S. Navy, Ret.), who brought the suit, also complained that the rule was not published in the Federal Register to allow for notice and comment.

"Historically, the VA has used the adjudication manual to publish their rules," Wells said. "This allows them to avoid public comment from veterans and stakeholders. They have also dodged judicial review by claiming that their adjudication manual was exempt. This is a flagrant violation of the Administrative Procedures Act, and this suit will hopefully put an end to that practice."

MVA is a non-profit organization that uses litigation

and legislative advocacy to protect members of the armed forces and military veterans. The all-volunteer group also provides seminars on benefits and trains attorneys in VA law.



NOTICE is hereby given that the Department of Veterans Affairs of the State of California (the "Department") will hold a public hearing at 9:00 a.m. on March 2, 2020, as required by Section 147(f) of the Internal Revenue Code of 1986, as amended:

The purpose of the hearing is to solicit public comments on the Department's proposed bond issuance of State of California veterans general obligation bonds and/or homeowner mortgage revenue bonds in the combined maximum aggregate principal amount not to exceed \$900,000,000 (collectively, the "Bonds").

The Bonds, in one or more series pursuant to a common plan of finance, will be issued to (i) provide monies for the Farm and Home Purchase Program of the Department (the "Program") and (ii) refund and redeem bonds previously issued by the Department or the State, the proceeds of which were used to provide monies for the Program. Under the Program, the Department acquires residential property to be sold to veterans throughout the State of California. In connection with the issuance of the Bonds, monies will be available for the acquisition of residential property to be sold to veterans in the State of California, to fund a reserve for the mortgage revenue bonds, and to pay costs associated with the issuance of the Bonds.

It is important to note that the faith, credit, and taxing powers of the State of California are in no way pledged or encumbered by the mortgage revenue bonds.

Those wishing to comment on the proposed financing may either appear in person at the public hearing or submit written comments, which must be received prior to the hearing. To allow all interested individuals a reasonable opportunity to express their views, the Department will impose the following requirements on persons who wish to present oral comments at the hearing: (1) persons desiring to speak at the hearing must file with the Department a request in writing at least 24 hours prior to the hearing, and (2) each person is to limit his or her oral remarks to a period no longer than 10 minutes. Accommodations for any person with special needs, who desires to attend the hearing, will be made upon timely written request.

The meeting location is accessible to the physically disabled. A person who needs disability-related

accommodations or modifications in order to participate in the meeting shall make request no later than five (5) business days before the meeting.

### The DoD Announces Plan to Downsize Nearly 50 Hospitals and Clinics

As noted in last week's NewsBytes, the Pentagon released a plan that, if fully implemented, would significantly restructure the military health system's responsibilities in the continental U.S. over the next several years. The list includes 50 existing Military Treatment Facilities whose services would change in some way. In the FY2021 Defense Health Program budget proposal, the Pentagon estimated a \$36 million savings during the first transition year by moving some patients (retirees and families) from MTFs to private providers in the DoD's TRICARE system. The focus of these changes is to improve readiness. The DoD wants to remove care that doesn't contribute to the readiness mission and move it into the TRICARE civilian network. The Defense Health Agency estimates that 84,000 active duty family members and 110,000 military retiree beneficiaries will be impacted by military treatment facility downsizing proposed.

Many TRICARE beneficiaries are worried about the impact these changes will have on their pocketbook. Retirees and their family members who are switched from MTFs to the TRICARE network care would face out-of-pocket cost increases because they would have a co-pay fee for most of their covered services.

## HVAC Subcommittee Discuss Privacy Concerns at VA

The House Veterans' Affairs Subcommittee on Technology Modernization held a hearing on data privacy for veterans who are using the Department of Veterans Affairs' vendors. The VA explained during the hearing that they have a process for vetting third party vendors who are part of the Community Care Network. Committee members expressed concern that privacy data should be protected by these third-party vendors. The committee focused on the security of the integrated electronic health record, record sharing and data collection and permissions from apps the VA offers for smartphones. The VA health care information from veterans falls under the jurisdiction of the Health Insurance Portability and Accountability Act (HIPAA) and their personal information falls under the Privacy ACT. A third party vendor must follow VA procedures when gaining access to veteran information. The VA often performs compliance audits to ensure their agreements and polices are upheld. The VA claims that they have policies in place to immediately rectify an incident during a data breach.

# CCN Payment Delays Discussed at HVAC Joint Subcommittee Meeting

Assistant Director, Legislative Programs Theo Lawson recently attended a joint oversight hearing of the House Veterans' Affairs Subcommittees on Health and Oversight and Investigations. The hearing was about the status of the Community Care Network program provider networks. Attention was paid to the backlog of claims-2.5 million claims out of 3.8 million are older than 30 days. The Department of Veterans Affairs testified that this will be remedied by the end of the fiscal year this September.

The VA is making changes to streamline the payment and referrals process. This includes reforming the purchase and authorization systems and improving effective communication with service providers using technology as opposed to telephone calls. The Community Care Network is responsible for monitoring feedback from the service providers. Currently, 30 percent of veterans obtain health care through the CCN.



### New Research on Challenges Faced by Minority Veterans

On Thursday, VFW National Legislative Service Director Carlos Fuentes participated in a panel discussion with VA officials and other advocates to discuss the findings of a recent Center for a New American Security report entitled "New York State Minority Veteran Needs Assessment," which evaluates challenges faced by women, LGBT, and racial and ethnic minority veterans across life domains. The report includes recommendations on how veterans service organizations — like the VFW — VA, and researchers can address health, housing stability, financial stability, and social functioning differences between minority veterans and their non-minority peers. ### Some Military Treatment Facilities to Stop Serving Retirees and Military Families

On Wednesday, the Pentagon released a list of military treatment facilities and clinics that will no longer provide care to military retirees and active-duty families as part of a shift in focus to supporting active-duty readiness. The report lays out the process through which officials selected the locations slated for changes that could impact 200,000 retirees and activeduty family members. Of those, about 80,000 are active-duty family members, while the remaining 120,000 are retirees and their families. Read the report.



## Legislation Introduced to Study Cancer Among Fighter Pilots

Last Wednesday, Representative Elaine Luria (D-Va.) and Representative Adam Kinzinger (R-III.) introduced H.R. 5858, the Military Pilots Cancer Incidence Study Act. This important legislation would require DOD to enter into an agreement with the National Academies of Sciences, Engineering, and Medicine to study and report on the incidence of cancer diagnosis and mortality among military pilots compared with other service members. In a press release, Representative Luria stated, "I am introducing the Military Pilot Cancer Incidence Study Act, so DOD and the VA understand the scope of the problem, identify service-connected illnesses, and address them appropriately. We owe it to these brave service members to know what health risks they assume and ensure we screen and treat early, so they live longer and healthier lives." The VFW thanks Rep. Luria and Rep. Kinzinger for introducing this legislation and for their efforts to expand health care and disability benefits for veterans. Read more.



### New Research Project Honors the History and Legacy of Black Soldiers in WWII

Ten years ago, in the Netherlands, a research effort was started that compiled the oral histories of Dutch people who survived World War II. Through this project, researchers learned about the hundreds of black American soldiers who were tasked with burying nearly 20,000 soldiers killed in action in the middle of winter. These soldiers labored in 12-hour shifts for months, burying their fellow yet segregated soldiers in makeshift, wartime cemeteries, and conducting makeshift services. These wartime cemeteries would become the Netherlands American Cemetery at Margraten. From this research The Black Liberators Project was born. Read more.



The Defense POW/MIA Accounting Agency announced two new identifications, and two burial updates for service members who have been missing and unaccounted-for from WWII and the Korean War. Returning home for burial with full military honors are:

### U.S. Navy Steward's Mate 2nd Class Jesus F.

**Garcia**, 21, was assigned to the battleship USS Oklahoma, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft on Dec. 7, 1941. The USS Oklahoma sustained multiple torpedo hits, which caused it to quickly capsize. The attack on the ship resulted in the deaths of 429 crewmen, including Garcia. Interment services are pending. Read about Garcia.

**U.S. Army Air Forces 1st Lt. Ernest L. Roth**, 20, was assigned as a pilot with the 359th Bombardment Squadron, 303rd Bombardment Group, 8th Air Force in Europe. On May 19, 1944, he was piloting a B-17G

bomber while on a bombing run over Berlin when the plane was hit by flak and crashed. Six of the 10 crewmembers, including Roth, were killed in the crash. They were recovered by German forces and reportedly buried in the Döberitz cemetery. Interment services are pending. Read about Roth.

**U.S. Navy Seaman 1st Class Lyal J. Savage**, 19, of Dexter, New York, was assigned to the battleship USS Oklahoma, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft, on Dec. 7, 1941. The USS Oklahoma sustained multiple torpedo hits, which caused it to quickly capsize. The attack on the ship resulted in the deaths of 429 crewmen, including Savage. He will be buried June 27, 2020, in his hometown. Read about Savage.

### U.S. Navy Fire Controlman 1st Class Robert L.

**Corn**, 24, of Baker City, Oregon, was assigned to the battleship USS Oklahoma, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft, on Dec. 7, 1941. The USS Oklahoma sustained multiple torpedo hits, which caused it to quickly capsize. The attack on the ship resulted in the deaths of 429 crewmen, including Corn. He will be buried May 1, 2020, in Honolulu, Hawaii. Read about Corn.
