Postal Delays May Impact Medication

Shipments

VA explained last week that approximately 90 percent of Consolidated Mail Outpatient Pharmacy (CMOP) packages are shipped to veterans by the USPS. CMOP has detected hot spots with delivery delays (Detroit, parts of New York and New Jersey) and proactively converted from USPS to United Parcel Service (UPS) 2nd Day Air for those areas until service levels can be returned to normal. The VFW is working with our supporters in the House and Senate to monitor this situation in order to ensure the health and well-being of our veterans remains paramount, especially during the COVID-19 pandemic.



Post office officials backtrack on service changes that delayed veterans' prescriptions

The U.S. Postal Service announced it will halt planned service reductions and other cost-cutting initiatives in response to public outcry - including strong opposition from veterans advocates - over the timing and impact of the moves.

"There are some long-standing operational initiatives ... that have been raised as areas of concern as the nation prepares to hold an election in the midst of a

devastating pandemic," Postmaster General Louis DeJoy said in a statement released Tuesday.

"To avoid even the appearance of any impact on election mail, I am suspending these initiatives until after the election is concluded. Retail hours at post offices will not change. Mail processing equipment and blue collection boxes will remain where they are. No mail processing facilities will be closed. And we reassert that overtime has, and will continue to be, approved as needed."



Information on Potential Start Date for VA's Caregiver Program Expansion

We wanted to update you with new information from VA about when newly eligible veterans will be able to apply for caregiver benefits. As previously reported, VA recently published new regulations to expand the Program of Comprehensive Assistance for Family Caregivers (PCAFC) to pre-9/11 veterans, beginning with those from World War II, the Korean and Vietnam war eras whose injuries or illnesses occurred on or before May 7, 1975. The second expansion phase will cover veterans whose injuries or illnesses occurred between May 8, 1975 and September 10, 2001.

According to VA, this expansion will not occur and become official until the Secretary certifies a new

caregiver IT system and it is fully implemented. VA also notes that it will not approve any new applications for caregiver benefits based on this expanded eligibility prior to that date, which is expected to be October 1st (the same day the new regulations take effect). Only new applications received by VA on or after the IT certification date (also expected to be October 1st) will be considered or approved based on the new expanded eligibility for World War II, Korean War and Vietnam veterans in phase one.

It is important to remember that having a service-connected injury or illness—regardless of the level of disability compensation—does not automatically qualify a veteran for PCAFC benefits. VA must first make a clinical assessment of each individual's caregiving needs and approve both the veteran and their designated caregiver into the program before VA will begin to provide benefits.

According to VA's new regulation, a phase one veteran's effective date for caregiver benefits, including stipends, would be:

“...the latest of the following dates:

(1) The date the joint application that resulted in approval and designation of the Family Caregiver is received by VA.

(2) The date the eligible veteran begins receiving care at home.

(3) The date the Family Caregiver begins providing personal care services to the eligible veteran at home.”

Therefore, if you are a World War II, Korean War or Vietnam era veteran who currently has a family caregiver providing you with caregiving services in your home, you may become eligible on the date your application is received by VA as long as it is on or after the IT certification date, (expected to be October 1st) and VA has determined that both you and your caregiver meet the clinical criteria for the program.

To reiterate—if your application for benefits is approved, and your designated caregiver is approved into the program, your benefits may be payable back to the date the application was received (on or after October 1st) if your caregiver was already providing personal care services at your home. If you do not currently have a caregiver but you are found to be eligible for the program, and your application is approved and clinical need is determined, the effective date would be the date the designated caregiver begins providing personal care services to the eligible veteran.

VA is expected to provide further information later this month about the IT certification date and will make an

official announcement when applications will be accepted. We will keep you updated once we receive this information. You can also find VA's latest announcements about the program and the expansion to pre-9/11 veterans [here](#).



Trump rejects reported \$2.2 billion in cuts to military health care that Pentagon proposed

WASHINGTON - President Donald Trump said he would not allow a major cut to the Pentagon's health care system under consideration by defense officials as part of an annual process to reprogram funds to warfighting priorities such as weapons and training.

Trump tweeted late Monday his displeasure with the reported \$2.2 billion cut over five years, which defense officials were planning to propose soon to Defense Secretary Mark Esper as part of his second annual effort to cut costs from noncombat defense functions. Esper, too, issued a tweet announcing his opposition to the proposal and rejected the initial reporting Sunday about the cuts by Politico as "inaccurate."

FRA Participates in Virtual Press Conference

Rep. Josh Harder (Calif.) along with the FRA, several other organizations, and local Vietnam War veterans who are battling bladder cancer participated in a virtual press conference to announce the launch of a final effort to expand coverage for veterans exposed to Agent Orange but who are unable to access support from the Department of Veterans Affairs (VA). Rep. Harder is kicking off an effort to support the inclusion of these benefits in the final National Defense Authorization Act (NDAA).

Earlier this year, Rep. Harder introduced the FRA-supported Fair Care for Vietnam Veterans Act (H.R.5610), which would ensure Vietnam Veterans with bladder cancer, certain thyroid problems, and Parkinson's like symptoms get access to the program through the VA. Veterans have been unable to get automatic access to benefits for those related illnesses through the VA, despite comprehensive scientific evidence linking the illnesses to exposure. The provisions of the bill were approved in the Senate as an amendment to the Senate version of the annual must-pass NDAA. To become law, the amendment must now be included in the final version of the legislation that will be negotiated and passed before

FRA Supports Veterans Re-Training Legislation

The FRA has signed onto a letter to Senate Majority Leader Mitch McConnell (Ky.), Speaker of the House Nancy Pelosi (Calif.), Senate Minority Leader Chuck Schumer (N.Y.), and House Minority Leader Kevin McCarthy (Calif.) to give serious consideration to incorporating the language of the Veteran Economic Recovery Act (H.R.7111) and (S.3899) in the next stimulus package.

Prior to the pandemic, the economy was strong and veteran unemployment numbers were at their lowest rates in almost two decades. Now, the number of unemployed veterans has tripled, and more than 776,000 veterans are currently out of work. Fourteen

percent of veterans are currently working in the top five industries most impacted by COVID-19, and it is estimated that up to 42 percent of jobs lost to COVID-19 will not return.

This FRA supported legislation would help reopen the American economy and ensure unemployed veterans have access to programs to help them get meaningful careers in the new economy. Provisions in these bills would help 35,000 veterans between the ages of 25 and 60 who are not eligible for the GI Bill get rapid retraining for in-demand occupations by authorizing a COVID-19 veteran retraining program. This legislation also includes additional funds for the VET Tec pilot program, which helps veterans and transitioning service members train for jobs in high tech and coding careers.

Whether one believes in a Deity or not, it is reasonably easy to concede there is some higher power, something greater than self. Whatever one's



President Signs Disabled Veterans Housing Bill into Law

President Donald Trump recently signed into law the FRA-supported Ryan Kules and Paul Benne Specialty Adaptive Housing Improvement Act (H.R.3504), sponsored by Rep. Gus Bilirakis (Fla.). The act will provide improvements to the Department of Veterans Affairs (VA) Specially Adapted Housing (SAH) program by expanding the number of grants awarded from 30 to 150 per year, increasing the dollar amount by 15 percent of the individual grants, and expanding the number of times disabled veterans can use a housing grant. These changes will help certain severely disabled veterans purchase adaptive homes

or upgrade existing homes to meet their specific needs for daily living activities.

The IRS has extended its deadline to September 30, 2020, for people to provide information to the IRS using its Non-Filer Tool at www.irs.gov/coronavirus/non-filers-enter-payment-info-here. People should do this if they:

- receive Social Security retirement, survivors, or disability benefits, or Supplemental Security Income (SSI) payments;
- did not file a 2019 or 2018 tax return;
- have a qualifying child under age 17; and
- did not already enter information in the IRS' Non-Filer Tool for themselves and at least one child.

The Crisis of COVID-19 for Military Caregivers

Former Sen. Elizabeth Dole is founder and chair of the Elizabeth Dole Foundation. Linda Hope is chair and CEO of the Bob & Dolores Hope Foundation.

Mary Hahn Ward, a veteran caregiver, recently shared her story about life during the COVID-19 pandemic. Mary cares for her husband Tom, a Marine Corps veteran who suffers from service-connected Amyotrophic Lateral Sclerosis, more commonly known as ALS or Lou Gehrig's disease.

Mary revealed one of her greatest concerns: "What happens to my husband if I or my daughter Kate contract the virus and need to be quarantined?" Tom

relies on Mary and Kate for his most basic activities of daily living, and their worries are real and alarming.

Even before this pandemic, most of America's 5.5 million military and veteran caregivers -- the spouses, mothers, dads and other loved ones caring for our wounded warriors at home -- lacked a meaningful support network. They are homebound by their around-the-clock caregiving responsibilities and rarely have backup support to care for their loved one. Feelings of extreme loneliness contribute to elevated rates of anxiety, depression and physical ailments. Their limited ability to leave the house also interferes with employment, complicates seemingly simple tasks like buying groceries and medications, and strains their social relationships.

This is the life of these hidden heroes in the best of times. Now, the novel coronavirus pandemic has struck our country hard and turned their already chaotic worlds upside down.

During this crisis, the limited in-person assistance that some caregivers depend upon is gone. Supplementing that support with paid health care professionals comes at a significant financial cost, not to mention the terrifying risk of bringing the virus into the home. As a result, performing at-home medical procedures, moving immobile veterans to avoid bed sores, managing IV

lines, and coaching loved ones through episodes of post-traumatic stress are left to the caregivers -- untrained, unpaid family members and friends.

Caring for someone has never been this hard, and it has never been this important. Even as states begin the first phases of reopening, the vulnerable health of many veterans will force their caregivers to continue to follow strict social distancing guidelines. That is why it is still vital that every American take action to help our hidden heroes pull through. This pandemic will be affecting their lives for months to come.

One of the simplest, yet most important ways to help is to keep in touch with caregivers. In an Elizabeth Dole Foundation COVID-19 survey, caregivers reported that social support and a sense of community were among their greatest concerns during the pandemic.


We cannot let our caregivers lose their sense of connection. If you know a caregiver, please find time each day to reach out -- text, call, or email. Drop off a home cooked meal or groceries. Deliver a small gift that lets them know that you are thinking about them. When you reach out, ask how they are doing and what they need. Caregivers are often asked about their veteran's health, but rarely about their own.

Every American can also help protect caregivers and

their veterans by following the social distancing guidance from the Centers for Disease Control and Prevention and local authorities. Many veterans have compromised immune systems and elevated chances of contracting infections due to amputations, wounds and service-connected illnesses. Factors like Agent Orange and burn pits have left veterans with weakened respiratory systems. As of today, nearly 17,500 patients in the VA health system have been positively diagnosed with COVID-19, and the number continues to rise. Caregivers are the last line of defense between the virus and our nation's veterans. We all have a responsibility to keep this vital community safe, well and strong.

Perhaps one of the quickest ways to support caregivers at this time is to share the Elizabeth Dole Foundation's COVID-19 response website, which provides free information, resources and support to caregivers. The foundation also continues to team with generous partners, like the Bob & Dolores Hope Foundation, to fund work that directly responds to the most urgent needs of caregivers. As Bob Hope demonstrated for nearly 70 years, Americans should always do what is necessary, no matter the cost, to stay connected to those who serve our nation and assure them that we are in this together.

Military and veteran caregivers are among the brave heroes putting themselves in harm's way on behalf of others during this pandemic. They should not have to face this risk alone. We invite all Americans to join us in recognizing and supporting those who stand between this pandemic and the men and women who sacrificed so much for our nation.




Army Air Forces Staff Sgt. Charles G. McMackin, 26, was assigned to the 68th Bombardment Squadron (Heavy), 44th Bombardment Group (Heavy), 8th Air Force. On Aug. 1, 1943, the B-24 Liberator aircraft on

which McMackin was serving as a bombardier crashed as a result of enemy anti-aircraft fire during Operation TIDAL WAVE, the largest bombing mission against the oil fields and refineries at Ploiesti, north of Bucharest, Romania. Interment services are pending. [Read about McMackin.](#)

Army Sgt. John E. Hurlburt, 26, was a member of the 105th Infantry Regiment, 27th Infantry Division. He was killed July 7, 1944, during a massive Japanese attack against the 105th on the island of Saipan. Interment services are pending. [Read about Hurlburt.](#)
